### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## **Aperia Solutions, Inc. 401(k) Plan Notes to Financial Statements**

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of the Aperia Solutions, Inc. 401(k) Plan (the “Plan”) provides only general information. Refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan was adopted effective January 1, 2001, and the Plan name was changed from Data Delivery Services, Inc. 401(k) Plan to Aperia Solutions, Inc. 401(k) Plan effective January 5, 2011. The Plan is sponsored by Aperia Solutions, Inc. (the “Plan Sponsor”). Ingenium Professional Services, LLC and Aperia Compliance, LLC are affiliated companies which have adopted this Plan as participating employers. The Plan is a defined contribution plan covering all employees of Aperia Solutions, Inc., Aperia Compliance, LLC and Ingenium Professional Services, LLC (collectively the “Company” or “Employer”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s Investment Committee (Investment Committee) determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Reliance Trust Company (“Reliance” or “Custodian”), the qualified institution, which invests contributions and Plan earnings, makes investment transactions as directed by the Investment Committee. Automatic Data Processing, Inc (“ADP”). processes certain transactions for the Plan and provides certain recordkeeping services to the Plan. Pentegra is the third-party administrator. The third-party administrator performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Under the terms of the Plan, substantially all employees are eligible to make salary deferral contributions. Effective January 1, 2022, upon completing 90 days of service and attaining age 18, employees may enroll in the Plan. Participants become eligible to receive Company contributions when they attain the age of 21 and have completed 90 days of service.

#### ***Contributions***

Participants may contribute up to 90% of their annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes matching contributions equal to the participants’ elective deferrals up to a maximum of 4% of eligible compensation. Additionally, the Company may make discretionary profit-sharing contributions. For the year ended December 31, 2024, no discretionary profit-sharing contributions were made. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## Aperia Solutions, Inc. 401(k) Plan Notes to Financial Statements

### Note 1: DESCRIPTION OF THE PLAN (Continued)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of the Company's profit-sharing contributions and investment earnings. Participant accounts are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

The vesting percentage is as follows:

Years of Service	Percentage of Vested Interest
One year	33%
Two years	66%
Three years	100%

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through semi-month payroll deductions or by check.

#### **Benefit Payments**

On termination of service due to death, disability, retirement, or other reasons, a participant or their beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### **Forfeitures**

At December 31, 2024 and 2023, the forfeitures account totaled \$21 and \$11, respectively. Forfeitures are first used to reduce expenses related to the administration of the Plan and then to reduce Company contributions. During the year ended December 31, 2024, forfeitures in the amount of \$37,380 were used to reduce expenses and Company contributions.

## Aperia Solutions, Inc. 401(k) Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN (Continued)**

#### ***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### ***Payment of Benefits***

Benefits to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### ***Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 8, 2025. See Note 9 for relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### **Note 3: INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified to be complete and accurate by Reliance Trust Company, the qualified institution:

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1* - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2* - Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Note 4: FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: TAX STATUS

The Plan adopted ADP's Non-Standardized Pre-Approved Profit Sharing/Money purchase/CODA Plan. ADP received an opinion letter from the IRS, dated October 6, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, the Plan is qualified, and the related trust is tax-exempt.

### **Note 5: TAX STATUS (Continued)**

Accounting principles in generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan holds notes receivable from participants. As a result, these assets and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan incurs expenses related to general administration, recordkeeping services and investment advisory services. Fees paid by the Plan for these services totaled \$81,761 for the year ended December 31, 2024.

### **Note 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 8: NON-EXEMPT TRANSACTIONS**

During 2021, the Company experienced unintentional delays in the remittance of withheld participant contributions to the Plan which was not considered timely in accordance with the plan asset provisions of the Department of Labor (DOL) Regulation 2510.3-102, resulting in prohibited (or a non-exempt) transactions. The aggregate amount of participant contributions in these late remittances was \$115,306. The accompanying Schedule of Delinquent Participant Contributions discloses this non-exempt transaction in accordance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company intends to correct these non-exempt transactions pursuant to the DOL's Voluntary Fiduciary Correction Program by funding the impacted Plan participants' accounts for earnings that would have been credited to the participants' accounts if the late remittance had been made on a timely basis and also crediting participants' accounts for the amount of excise taxes the Company would have otherwise paid to the IRS for the a late remittance. The lost earnings are not recorded in the accompanying financial statements as they are immaterial.

### **Note 9: SUBSEQUENT EVENTS**

A partial plan termination occurred effective March 31, 2025, due to members of the Company selling their interest in Aperia Compliance, LLC, in November 2024. All employees of Aperia Compliance, LLC, were terminated on March 31, 2025 and became fully vested in all contributions as a result of the partial plan termination.
