### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed audits of the financial statements of R and A Alexander Investments 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTE 1 – DESCRIPTION OF PLAN

The following description of R and A Alexander Investments 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

Effective February 1, 2017, R and A Alexander Investments (the Company) restated the 401(k) Plan. The Plan is a defined contribution plan covering all full-time employees of the Company and Alexander Buick GMC of Simi Valley who have one year of service, with no less than 1,000 hours, and are age 21 or older. The effective date of participation for an eligible employee is the first day of the quarter following the date the employee successfully met the participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Each year, participants may contribute up to a dollar amount set by law of pretax annual eligible compensation, as defined by the Plan. The Plan includes an automatic enrollment feature that automatically withholds 3% of participant compensation, unless the participant elects an alternative deferral amount or elects not to defer to the Plan. Participants may also make Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Employer contributions are not permitted effective May 1, 2024. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions, and Plan earnings less expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Administrative fees, except loan fees and certain investment fees, are absorbed by the plan sponsor.

#### **Investment Options**

Investments are held by ADP Retirement Trust Services, LLC (ADPRTS). Upon enrollment in the Plan, a participant may direct employee contributions to any of the available mutual funds and collective trust fund managed by ADPRTS. Participants may change their investment options at any time.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 47.5% of their vested account balances. Terms shall not exceed 4.5 years except for the purchase of a primary residence. The maximum number of loans that a participant may have outstanding at any one time is two. The loans are secured by the balances in the participants' accounts and bear interest at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant, or the beneficiary, may elect to receive either a lump-sum, partial payment, or recurring installment payments up to the amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are not allowed as defined in the Plan agreement. Additionally, the Plan allows for in-service distributions at age 59 ½ if fully vested without being required to terminate employment.

#### **Forfeited Accounts**

Effective May 1, 2024, all balances are fully vested.

#### **Administrative Expenses**

The Plan permits the payment of the Plan expenses to be made from the Plan assets. If the Company does not pay these expenses, then the expenses paid using the Plan assets will be allocated among the participant accounts. Expenses relative to loan fees and certain fees were allocated to participants accordingly and totaled \$16,794 for the year ended December 31, 2024.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets must be used for the exclusive benefit of participants. In the event of Plan termination, participants will become 100% vested in their accounts.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared using the accrual method of accounting, based on accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standard Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date.

#### **Notes Receivable from Participants**

Notes receivable from participants are recorded at amortized cost plus accrued, but unpaid, interest.

Management considers all receivables to be fully collectible. Accordingly, no allowance for credit losses has been established.

#### **Payment of Benefits**

Benefits are recorded when paid.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

**Level 1** – consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.

**Level 2** – consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

**Level 3** – consists of significant unobservable inputs for the asset or liability and has the lowest priority.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: The Plan has an investment in a collective trust fund. Units held in collective trust funds are valued using the net asset value (NAV) practical expedient of the fund as reported by the fund manager. The NAV practical expedient is based on the fair value of underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Paychex Retirement Services is the recordkeeper and third-party administrator and certain Plan investments are shares of mutual funds managed by ADP Retirement Trust Services, LLC, the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rule under ERISA. Fees paid by the Plan for the investment management services are netted against appreciation in fair value of investments. The Company provides certain administrative services at no cost to the Plan.

**NOTE 6 – TAX STATUS**

The Plan has adopted a non-standardized profit sharing form of a prototype plan sponsored by PayChex, Inc. The non-standardized profit-sharing plan obtained its latest determination letter on August 31, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

**NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS**

Net assets available for benefits held in accounts of participants that are no longer employees of the plan sponsor totaled \$119,263 as of December 31, 2024. Of those balances, no amounts had been requested to be paid to the participants but were not paid until subsequent to the Plan's year end.

**NOTE 8 – SUBSEQUENT EVENTS**

The plan administrator evaluated events and transactions subsequent to December 31, 2024, through October 13, 2025, the date the financial statements were available to be issued, for potential recognition or disclosure in the financial statements. Management has not identified any items that require disclosure.
