Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spectrum Health and Human Services Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Spectrum Health and Human Services Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan funded by employer and participant contributions and covers substantially all employees of Mental Health Services of Erie County South East Corporation V DBA Spectrum Health and Human Services (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. UBS Financial Services, Inc. (UBS) serves as the Plan's ERISA 3(38) investment manager.

Eligibility:

Except for certain limited classifications, employees of the Company who have attained the age of twenty-one and have completed thirty days of service are automatically enrolled in the Plan. Participants are eligible to receive employer contributions once they have completed one year of service, as defined.

Contributions:

Each year, participants may contribute up to 100% of their eligible compensation, as defined, on a pre-tax basis or Roth basis. Plan participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a target-date fund until changed by the participant. The Plan also includes an annual auto-escalation feature where, for each subsequent year, the participants' deferral rate increases annually by 1% until a maximum of 10% is reached. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

For eligible participants, the Company makes safe harbor non-elective contributions equal to 3% of a participant's eligible compensation. The Company also may provide discretionary matching contributions to eligible participants. For 2024 and 2023, the Company provided discretionary matching contributions equal to 1.5% of the participant's eligible compensation for participants contributing at least 1% of their eligible compensation. The Board of Directors of the Company may also approve discretionary profit sharing contributions to the Plan benefiting participants actively employed on the last day of the Plan year. There were no discretionary profit sharing contributions for the years ended 2024 and 2023.

Contributions are subject to certain limitations of the Internal Revenue Code (the Code). Participants direct the investment of their contributions into various investment options offered by the Plan.

Note 1. Plan Description (Continued)

Participant accounts:

Each participant's account is credited with the participant's contributions, the Company's contributions, an allocation of Plan earnings, reduced for benefits paid, and is charged for loan origination, benefit processing and recordkeeping fees, if applicable, and an allocation of other administrative expenses. Allocations of Plan earnings are based on the investments held by the participant. Allocations of other administrative expenses are based on participant account balances, as defined in the Plan document. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account. The Plan permits participants to convert all or a portion of the employee's pre-tax portion of their account to an after-tax basis, subject to the participant paying the related income taxes as prescribed by the Code.

Vesting:

Participants are immediately vested in their voluntary contributions and Company safe harbor non-elective contributions, plus earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of service, as defined. A participant is 100% vested after three years of service, as defined. Prior to completing the third year of service, the vesting percentage is zero. A participant also becomes 100% vested if the Plan is terminated, the participant reaches age sixty-five while employed, or the participant retires, dies, or becomes disabled.

Forfeitures:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,679 and \$134,161, respectively. Forfeitures of nonvested Company contributions are reallocated back to participants. Forfeitures of \$135,377 and \$-0- were reallocated to participants in 2024 and 2023, respectively.

Notes receivable from participants:

Participants may borrow up to one-half of their vested account balance with a minimum borrowing amount of \$1,000 and a maximum of \$50,000. All loans must be repaid in equal payments through after-tax payroll deductions on at least a quarterly basis over a five-year period, unless the proceeds of the loan are used for the purchase of the participant's principal residence, in which case the loan repayment period may not exceed fifteen years. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Note 1. Plan Description (Continued)

Payment of benefits:

Benefits are payable upon death, disability, retirement, or the event of hardship. A participant or a participant's beneficiary may elect to receive either a lump-sum amount or installment payments equal to the value of his or her account. Distributions of the portion of a participant's account attributable to the participant's contributions and earnings thereon are also permitted in the event of financial hardship, as defined.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for the fully benefit-responsive contract, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Group annuity contract:

The Plan's investment in the group annuity contract with Empower Life & Annuity Insurance Company of New York (Empower Insurance) held at December 31, 2024 and 2023, named the Guaranteed Interest Fund, is a traditional fully benefit-responsive investment contract and, therefore, is reported at contract value. Empower Insurance/Great-West Insurance maintains the contributions in a general account fund. Empower Insurance is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value reflects contributions, credits for interest, charges for participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is determined by the issuer quarterly and, contractually, may not be less than 0%. The issuer determined the crediting interest rate by considering many factors, including economic and market conditions, the general interest rate environment and the expected and actual return on the portfolio within the general account.

The Plan's ability to receive amounts due in accordance with the fully-benefit responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

In June 2024, the Plan submitted its notice to the trustee of the guaranteed interest fund for a full redemption of its interest in the group annuity contract. The liquidation of the guaranteed interest fund was completed in May 2025. Participant balances remaining in the guaranteed interest fund at that date were transferred to the stable value investment option. No events occurred that limited the ability of the Plan to transact at contract value with the contract issuer or that also limited the ability of the Plan to transact at contract value with the participants.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Benefits:

Benefits are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events:

Subsequent events have been evaluated through October 10, 2025 which is the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority level to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used by the Plan for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee of the bank collective trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Note 5. Tax Status

The Company has adopted a pre-approved plan document sponsored by ADP Retirement, LLC, that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. The Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Party-In-Interest Transactions

A party-in-interest is defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, certain participants, and others. The Plan allows participants to take loans from their accounts in the Plan. Certain notes receivable from participants and income thereon qualify as party-in-interest transactions.

The Plan has an investment in a group annuity contract with Empower Insurance. In 2024 and 2023, Empower Insurance, and its related entity Empower Advisory Group, LLC, provided certain administrative services to the Plan. Fees incurred by the Plan for services related to the group annuity contract and Plan administration qualify as party-in-interest transactions. Investment advisory services provided to the Plan by UBS qualify as party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
