INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mercy Flights, Inc. Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Reliance Trust Company as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Mercy Flights, Inc. Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Mercy Flights, Inc. (the Organization), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and incorporates the final IRS code 415 regulation provisions and to implement the Pension Protection Act of 2006. The Organization is the Plan's sponsor and serves as plan administrator.

Eligibility

All employees are eligible to make salary deferral contributions to the plan on the first day of the month following the first 30 days of employment with a minimum requirement of one service hour. Employees are eligible to receive employer contributions on the first day of the month after completing one hour of service during the first six months of employment and attaining 18 years of age.

Contributions

Participants may contribute to the Plan through salary deferrals on earned compensation. A participant may defer an amount up to the Elective Deferral Dollar Limit under Internal Revenue Service (IRS) Code §402 and the IRS Code §415 Limitation during any calendar year. Participants may also make rollover contributions representing distributions from other qualified plans.

The Organization may elect to make profit sharing discretionary contributions, as defined by the Plan. For the year ended December 31, 2024, the Organization made discretionary contributions of \$230,501.

The Organization also makes safe harbor contributions equal to 5% of each eligible employee's compensation. The safe harbor contribution for the period ended December 31, 2024, was \$631,759.

Participant Accounts

Each participant's account is credited with the participant's contribution, plan earnings, and, if eligible, an allocation of the Organization's contribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the dollar amount in the participant's vested account. Participants direct the investment of the contributions into various investment options offered by the Plan.

Vesting

The Plan provides that participants are immediately 100% vested in employee contributions, employer contributions and employer matching contributions, and earnings.

Investment Options

All Plan investments are participant directed, and participants may select among different investment funds to invest their account balances. Income, as well as realized and unrealized gains or losses from the investments, are recorded in the participants' accounts.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Hardship Withdrawals

If the participant has an immediate financial need for the purposes of purchasing a participant's primary residence, for paying for post-secondary education, to prevent eviction from participant's principal residence or foreclosure on the mortgage of the participant's principal residence, for burial or funeral expense, for disasters arising from federally declared disasters, expenses for the repair of damage to the participant's principal residence that would qualify for the casualty deduction under the Internal revenue code, or un-reimbursed medical expenses, hardship withdrawals are allowed under the provisions of the Plan in amounts not in excess of the value of the participant's contribution account.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant (or by a beneficiary upon the death of a participant) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, a distribution of less than the entire vested account balance, or annual installments over a specified period not to exceed the life or life expectancy of the Participant. In-service hardship distributions are allowable under certain circumstances. If the participant's total vested benefit under the plan is between \$1,000 and \$5,000 upon termination of service there is consent to a distribution of the vested account balance, the vested benefit will automatically be rolled over to an individual retirement account (IRA) selected by the plan administrator.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value. The Plan's custodian, Reliance Trust, certifies the fair value of all investments. If available, quoted market prices are used to value investments. Shares of registered mutual funds are valued at the net asset value of shares held at quoted market prices by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Benefit Payments

Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Administrative Expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid (or reimbursed) by the Employer. The Plan administrator will allocate these expenses either proportionally based on the value of the account balances or pro rata based on the number of participants in the Plan.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to be as complete and accurate by Reliance Trust, the custodian of the Plan's investment assets, as of December 31:

NOTE 4 - INVESTMENTS

During 2024, the Plan's investments including gain and losses on investments bought and sold as well as held during the year appreciated in value by \$1,332,265.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5 - FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Units held in pooled separate accounts are investments represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles valued using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAVs of the underlying investments are quoted in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Investments measured at net asset value per share as a practical expedient have not been classified in the fair value hierarchy, but are presented in order to permit reconciliation of the plan's assets:

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - RELATED PARTY TRANSACTIONS

Reliance Trust is the Trustee of Plan assets and manages investments offered through the Plan and therefore qualifies as a party in interest. Fees paid by the Plan for the investment management services amounted to \$26,310 for the year ended December 31, 2024.

DA Davidson provides investment advisory services to the Plan and therefore qualifies as a party in interest. Fees paid for investment advisory services amounted to \$28,115 for the year ended December 31, 2024.

ADP provides administrative services for the Plan, including preparing the annual Form 5500 and assisting with maintaining participant records. Fees paid for administrative services amounted to \$4,621 for the year ended December 31, 2024.

NOTE 8 - TAX STATUS

The Plan obtained its latest determination letter on November 23, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 12 – LATE REMITTANCE OF PARTICIPANT CONTRIBUTIONS

During 2024, the Plan sponsor identified that employee contributions attributable to the December 31, 2022 payroll, totaling \$414, were not remitted to the Plan until September 25, 2024. In accordance with Department of Labor regulations, such untimely remittances constitute a prohibited transaction. As of December 31, 2024, the related lost earnings, estimated at approximately \$62, had not yet been remitted to the Plan. The Plan sponsor intends to correct this matter, including the deposit of lost earnings into participants' accounts.

In addition, the related safe harbor non-elective contribution of \$13,393 attributable to the same payroll was also deposited on September 25, 2024. While employer contributions are not subject to the same timing requirements as participant contributions, the delay has been disclosed herein for transparency.

NOTE 13 - SUBSEQUENT EVENTS

Management has evaluated events and transactions occurring after October 13, 2025 through the date the financial statements were available for issuance, recognition and/or disclosure in the financial statements. No subsequent events were identified.
