## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the Crystal Springs Services, Inc 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### 1. Description of Plan

Effective January 1, 2021, Crystal Springs Golf & Spa Resort 401(k) Plan entered into a new adoption agreement whereby the name of the plan was changed to Crystal Springs Services, Inc 401(k) Plan. The following description of Crystal Springs Services, Inc 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for more complete information.

#### ***General***

The Plan is a defined contribution plan available to all full-time eligible employees of Crystal Springs Golf & Spa Resort (the "Company"). The Plan is a participant-directed defined contribution plan as described in Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 (ERISA) and the IRC. The Plan became effective January 1, 2000 and was amended and restated on October 1, 2022.

Under the IRC, participants are not liable for federal income taxes on pre-tax employee contributions, Company contributions or Plan earnings until such time as they are partially or completely withdrawn from the Plan.

#### ***Assets Held for Investment***

All Plan assets are held with Reliance Trust Company ("Reliance"). Reliance acts as the Trustee over all of the Plan's assets. ADP Retirement Services acts as the administrator of the Plan effective October 1, 2022.

#### ***Eligibility***

All full-time employees of the Company are eligible for Plan participation and may enter the Plan provided that they are over 18 years of age and have completed six months of service and 500 hours of service by the next plan entry date. Certain nonresident aliens, seasonal employees and employees covered by a collective bargaining agreement are not eligible to participate in the Plan.

An employee who has satisfied the eligibility requirements may enter the Plan at the beginning of each quarter, following the date which he or she satisfies such eligibility requirements.

#### ***Contributions***

Eligible employees may contribute up to 90% of their eligible compensation up to the annual limit determined by the IRC. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

### 1. Description of Plan *(continued)*

#### ***Contributions (continued)***

A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. The minimum percentage of eligible compensation a participant may elect to defer is 1%.

The Company makes safe-harbor matching contributions equal to 100% of participant's contributions up to a maximum of a 4% of a participant's compensation. The Company may also make a discretionary employer profit-sharing contribution to the Plan on an annual basis. The Company did not elect to make an employer profit-sharing contribution for the year ended December 31, 2024.

#### ***Participant Accounts***

A separate account is maintained for each participant, which is credited with the participant's contribution and allocations of Employer contributions and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered by the Plan. There is no limit to how often a participant may change their investment options.

#### ***Vesting***

Upon entrance into the Plan, participants are 100 percent vested in their voluntary contributions. The matching and nonelective contributions vest as follows:

#### ***Forfeitures***

Forfeitures of terminated participants' non-vested accounts serve to reduce Company contributions or Plan expenses. At December 31, 2024, forfeited non-vested accounts amounted to \$522 and \$5,267, respectively. During the year ended December 31, 2024, the Company elected to use \$33,264 of the forfeited non-vested accounts to reduce its contributions, as allowed by the Plan.

#### ***Payment of Benefits***

Benefits are paid upon retirement, death, disability, or termination of employment. Upon termination of service, a participant who is not 100% vested will receive a distribution of the vested portion of his or her account balance. The non-vested portion of their account will be forfeited when the distribution is made. Participants who terminate employment and are 0% vested must take a distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

A participant may apply to the Plan Administrator for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant or their dependents, medical expenses to the extent not otherwise reimbursed under the Company's medical programs, expenses for the purchase of a principal residence or material alterations thereto, payments to prevent eviction from or foreclosure on a principal residence or burial or funeral expenses for the participant's parent, spouse, children or dependents.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are secured by the balance in the participant's account and bear interest as determined at the time of the loan origination. Principal and interest is paid ratably through monthly payroll deductions over a period of time not to exceed five years. If the proceeds are used to construct or rehabilitate a participant's principal residence, the Plan Administrator may permit a longer repayment term. Principal and interest repaid is reinvested based on the participant's present investment allocation selection. Delinquent participant loans are classified as distributions based upon the terms of the Plan document.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, all amounts credited to participant accounts shall become fully vested and non-forfeitable. Accordingly, assets will be distributed to the participants and beneficiaries in proportion to their respective account balances.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), using the accrual basis of accounting, which recognizes revenue when it is earned and expenses as they are incurred.

#### ***Use of Estimates***

In conformity with US GAAP, the Plan's management makes estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent net assets available for benefits at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the period. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well those held at the end of the year.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Investment Valuation and Income Recognition (continued)***

The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price.

The common/collective trusts are valued at NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to US GAAP guidance, alternative investments where fair value is measured using NAV are not categorized within the fair value hierarchy. The investment valued used in NAV had no unfunded commitments at December 31, 2024 and 2023.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are classified as distributions based upon the terms of the Plan agreement.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

With the exception of the Plan's recordkeeping fees expenses related to the notes receivable from participants (setup and maintenance fees) which are charged to the individual participant's account, all other administrative expenses incurred by the Plan are paid by the Company.

Expenses relating to investment management are paid directly by the respective investment vehicle and are included in net appreciation in fair value of investments.

### 5. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer, Reliance, dated October 6, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 8. Party-in-Interest Transactions

ERISA considers the recordkeeping fees and participant loan expenses paid to Reliance to be exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.
