

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Crowheart Energy Services 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from ADP Retirement Trust Services, LLC, a qualified institution, as of December 31, 2024 and for the period from August 1, 2024 through December 31, 2024, stating that the certified investment information as described in *Note C* to the financial statements is complete and accurate to the best of their knowledge and belief. #### A. Plan Description:

The following description of the Crowheart Energy 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

##### General:

The Plan was a participant-directed safe harbor defined contribution plan covering all non-bargaining, full-time employees of Crowheart Energy Services, LLC and related participating employers including Crowheart Energy Services Holdings Corp and Crowheart Energy, LLC (collectively, the "Company"). Effective November 1, 2024, the Company was acquired by a subsidiary of The Williams Companies, Inc (Williams) and the Plan was terminated, as described in *Note H*. Employees had to be age 21 or older to participate in the Plan. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The plan administrator was responsible for the oversight of the Plan. The chief financial officer of the Company served as the limited trustee. ADP Retirement Trust Services, LLC (ADP) served as the third party administrator, trustee and recordkeeper from August 1, 2024 until the final assets were distributed in June 2025. Ascensus Trust Company was the trustee of the Plan through July 31, 2024. Ascensus, Inc. (Ascensus) served as the recordkeeper and third party administrator through July 31, 2024.

##### Contributions:

Each year, participants could make traditional contributions up to the maximum of 100 percent of pretax annual compensation, as defined in the Plan. Effective August 1, 2024, participants could also make Roth deferrals. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company made traditional safe harbor contributions to the Plan by matching 100 percent of the first 6 percent of salary deferrals.

##### Participant Accounts:

Each participant's account was credited with the participant's contributions, allocation of the Company's contributions and plan earnings and any fees. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

##### Investment Options:

Participants directed the investment of their contributions into various mutual fund investment options offered by the Plan. Participants could change their investment elections at any time.

##### Vesting:

Participants were immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. All balances became fully vested upon the Plan's termination date of November 1, 2024.

##### Payment of Benefits:

On termination of service, reaching the age of 59.5 or becoming disabled, a participant became eligible for a lump-sum distribution of his or her vested account balance. The Plan also allowed for hardship withdrawals with certain limitations. In-service and hardship withdrawals were limited to the participant's pre-tax elective deferrals. Participants could take distributions from their rollover accounts at any time. Participants with vested balances below \$1,000 had their balances automatically distributed upon termination. Participants with vested balances greater than \$1,000 but less than \$5,000 had their balances automatically rolled into an IRA established in their name upon termination.

#### B. Summary of Accounting Policies and Investments:

##### Basis of Accounting:

Effective November 1, 2024, as a result of the acquisition by Williams, the Plan was terminated. As a result, the Plan's financial statements as of and for the year ended December 31, 2024 have been prepared using the liquidation basis of accounting in accordance with ASC 205-30, *Presentation of Financial Statements – Liquidation Basis of Accounting*. Based on the formal approval of the termination and the absence of significant impediments to the distribution of plan assets, it was determined that the liquidation was imminent as of November 1, 2024.

The Plan's financial statements as of and for the year ended December 31, 2023 have been prepared on a going concern basis as the Plan was active and ongoing during that period.

##### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **B. Summary of Accounting Policies and Investments (Continued):**

##### Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the trustees. See *Note D* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payment of Benefits:

Benefits are recorded when paid.

##### Administrative Expenses:

The Company absorbed administrative and operating costs of the Plan. Fees related to the administration of the Plan or associated with the investment of plan assets could be paid by the Plan or the Company, at the Company's discretion. Fees related to member requested services were charged directly to the participant's account and are included in administrative expenses.

#### **C. Information Certified by the Trustee and Agent of the Trustee:**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, ADP Retirement Trust Services, LLC has certified the following information as of December 31, 2024 and for the period from August 1, 2024 through December 31, 2024 included in the accompanying financial statements and supplemental schedule is complete and accurate to the best of their knowledge and belief. Ascensus, LLC, as recordkeeper and authorized agent of the trustee, Ascensus Trust Company, has certified the following information as of December 31, 2023, for the year ended December 31, 2023, and for the period from January 1, 2024 through July 31, 2024 included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments as shown in the accompanying supplemental information as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

#### D. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in active or inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability or that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan. Mutual funds held by the Plan are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### E. Related Party and Party-In-Interest Transactions:

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan incurred administrative fees of \$4,354 and \$3,885 to Ascensus during the years ended December 31, 2024 and 2023, respectively. The Plan incurred administrative fees of \$8,789 to ADP during 2024. The Company provided certain administrative services at no cost to the Plan.

#### **F. Plan Tax Status:**

The Plan adopted a non-standardized adoption agreement in connection with a pre-approved profit sharing plan and trust provided by ADP, LLC. The pre-approved plan document has obtained a favorable opinion letter, dated October 6, 2020, from the Internal Revenue Service stating that it constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements for the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management performs an annual analysis of the Plan's various tax positions, assessing the likelihood of those positions being upheld upon examination by relevant taxing authorities. Management believes the Plan has conducted its operations in accordance with applicable income tax reporting requirements, and has properly maintained its tax-exempt status, and has taken no material uncertain tax positions that qualify for recognition or disclosure in the financial statements.

#### **G. Plan Transfer:**

Effective for the blackout period from July 25, 2024 to September 15, 2024, the Plan's assets of approximately \$7,592,000 were liquidated and transferred from Ascensus Trust Company to ADP Retirement Trust Services, LLC. As a result, the Plan document was restated. No significant changes to operations were adopted under the restatement.

#### **H. Plan Termination:**

Effective November 1, 2024, as a result of the acquisition by Williams, the Plan was terminated in accordance with the plan document and applicable regulations under ERISA. As a result of the termination, the Plan ceased all ongoing operations and began the process of liquidating its assets and settling its obligations. Participants were permitted to take distributions from their accounts, which were fully vested. Participants who had not made an affirmative election to distribute their accounts as of June 20, 2025 had their accounts rolled into an individual retirement account with American Century Services, LLC.

#### **I. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**J. Subsequent Events:**

On June 20, 2025, the final assets totaling \$874,730 were distributed from the Plan.

The Plan did not have any other subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.
