## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Medela LLC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the Medela LLC 401(k) Savings Plan (the Plan) provides general information about the Plan's provisions. Medela LLC is the plan sponsor. Participants should refer to the plan document for a more complete description of the Plan's provisions, which may be obtained from the plan sponsor.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of Medela LLC (the Company) who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for the administration and oversight of the Plan.

#### **Contributions**

Each year, participants may contribute up to 50% of their pretax annual compensation, as defined in the Plan, subject to the Internal Revenue Code (the Code) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company contributes a safe harbor matching contribution to participants of the Plan equal to 100% of each participant's elective deferrals not exceeding 3% of the participant's compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation (for a maximum safe harbor matching contribution of 4%).

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and company safe harbor matching contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Medela LLC 401(k) Savings Plan

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1.00%, ranging between 4.25% and 9.50% at December 31, 2024 and December 31, 2023. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years, or a reasonable term established by the plan administrator for loans used for the purchase of a primary residence.

##### **Payment of Benefits**

On termination of service due to retirement, death, disability, or termination of employment, a participant may elect to receive his or her vested balance in a lump-sum amount. If the participant's vested interest in the Plan is less than \$1,000, a mandatory lump-sum distribution is made to the participant. If the participant's vested interest in the Plan is greater than \$1,000 but less than \$5,000 and he or she does not request a distribution, the vested account will transfer to an individual retirement account. Under certain conditions, participants may be eligible to receive a hardship distribution.

##### **Vesting**

Participants are immediately vested in their contributions and company safe harbor matching contributions, plus actual earnings thereon.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's net gains (losses) on investments bought and sold as well as held during the year.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### **Benefit Payments**

Benefit payments are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

#### **3. Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company.

#### **4. Fair Value Measurement**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

#### 4. Fair Value Measurement (continued)

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds:* Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the plan at year-end.

*Common/Collective Trust Funds:* Valued at the NAV provided by the administrators of the funds. The NAV is based on underlying assets owned by the fund, minus liabilities, and then divided by the number of shares outstanding.

#### **5. Related-Party and Party-in-Interest Transactions**

Certain plan investments are managed by Principal Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Trustee fees paid to the trustees of the Plan were \$92,577 for the year ended December 31, 2024. Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan for their services.

Certain administrative services are provided to the Plan pursuant to a service agreement between the trustee and the Company. The trustee receives revenue from mutual funds for services provided to the funds by the trustee. This revenue is used to offset certain amounts owed to the trustee for its administrative services to the Plan. If the revenue received by the trustee exceeds the amount owed under the agreement, the excess is remitted to the Plan, and such excess amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no such excess amounts. The Plan or Company makes payments to the trustee for administrative expenses not covered by revenue sharing.

#### **6. Tax Status**

The underlying non-standardized pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to rely on, the current IRS volume submitter advisory letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statement of net assets available for benefits.

#### **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain 100% vested in their company contributions.

#### **9. Subsequent Events**

Management evaluated subsequent events for the plan through October 7, 2025, the date the accompanying financial statements were available to be issued. No material subsequent events have occurred through that date that required recognition or disclosure in the financial statements.
