## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. THE PLAN

The following description of St. John's Health Care Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of St. John's Health Care Corporation (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company is the sponsor of the Plan. Reliance Trust Company (Reliance) is the Plan's custodian and trustee. Automatic Data Processing Inc., (ADP, Inc.) is the recordkeeper of the Plan's assets. Alesco Advisors LLC (Alesco) is the investment advisor of the Plan.

#### **Eligibility**

Employees of the Company that are not union employees governed by a collective bargaining agreement, not nonresident aliens and not leased employees are eligible to participate in the Plan upon attainment of age 18. All new participants are automatically enrolled in the Plan, contributing 4% of their annual salary as a qualified pre-tax contribution. Employees must be age 21 or older and have at least one year of service to be eligible for the Company's employer discretionary matching and profit sharing contributions.

#### **Contributions**

Participants may elect to defer a percentage of their compensation each year not to exceed dollar limitations that are set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

The Plan provides for employer discretionary matching contributions and employer profit sharing contributions. The Company's discretionary matching contribution was equal to 50% of the employee's contribution, up to 6%, and amounted to \$509,105 and \$457,129, for the years ended December 31, 2024 and 2023, respectively. The Company elected not to make any discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

#### **Participant Accounts**

Each Participant's account is credited with the participant's contribution and allocation of (a) plan earnings/losses, (b) the Company's discretionary matching contribution, if applicable, and (c) administrative expenses. The Company's discretionary profit-sharing contribution is allocated based on employee compensation. Allocations of Plan earnings/losses and administrative expenses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. THE PLAN (Continued)

### Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance consisting of elective deferral and rollover amounts. The Plan allows for two loans to be outstanding at any given time. The loans are payable in their entirety upon the occurrence of a distributable event and bear interest at a rate of the prime rate plus 1% as published on the 14<sup>th</sup> day of each month. Loan terms range from one to five years, unless they are used to purchase a primary residence, in which case repayment may be made over a maximum of thirty years. The notes are secured by the balance in the participants' vested account. Principal and interest is paid ratably through payroll deductions.

### Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in discretionary matching and profit-sharing contributions is based on years of service as follows:

The Plan has special vesting provisions for participants who are laid off by the Company. Participants who have been laid off, and who have accumulated 2 years of vesting service, shall be 100% vested in their account balance.

### Payment of Benefits

The Plan provides for benefit payments upon termination of service due to death, disability or attainment of retirement age (age 65). Participants may elect disbursement of their vested account balance in a lump-sum amount. Benefit payments may be made in installments if the participant's vested balance exceeds \$5,000 and must receive minimum required distributions. Benefit payments from the Plan are automatically made in a lump sum distribution upon termination of service if the participant's vested balance does not exceed \$5,000.

Additionally, the Plan provides for in-service withdrawals allowed from rollover contributions at any time. The Plan allows for in-service distributions to actively-employed participants that have reached the age of 59 ½.

### Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

### Forfeitures

Forfeitures of matching and profit-sharing employer contributions are used to reduce future employer matching contributions. Forfeitures of non-vested account balances and earnings on unused amounts totaled \$27,617 and \$24,254 in 2024 and 2023, respectively. There were \$28,374 and \$23,498 of forfeitures utilized to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. There were \$10 and \$767 of available forfeitures to offset future employer contributions as of December 31, 2024 and 2023, respectively.

## 2. THE PLAN (Continued)

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. All investments are participant directed. Purchases and sales of securities are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

### **Fair Value Measurements – Definition and Hierarchy**

Financial Accounting Standards Board *Accounting Standards Codification* (ASC) 820 establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

There were no changes in valuation techniques during 2024 or 2023.

A description of where the Plan's investments fall within the hierarchy is presented in Note 5.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. If the participant fails to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Benefits Paid to Participants**

Benefit payments to participants are recorded when paid.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Corrective Distributions

Amounts paid to participants for contributions to the Plan in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as corrective distributions in the statements of changes in net assets available for benefits.

### Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### Estimates

The preparation of financial statements in accordance with GAAP in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded (Level 1).

**Common/Collective Trust Fund:** Valued at the NAV of units in the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The common/collective trust fund is maintained in a stable value fund that invests in high-quality guaranteed investment contracts (GICs) and similar contracts issued by insurance companies, banks, and other financial institutions. The fund also invests up to 75% of its assets in security-backed investment contracts (SBICs), including separate account products of insurance companies. The fund invests at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds (including fixed income funds underlying SBICs) with investment policies and other provisions similar to those of the fund, and may invest without limit in these investments.

## 5. FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, all participants will become fully vested in their accounts.

## 7. TAX STATUS

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion letter, the plan administrator and the plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

## 8. SUBSEQUENT EVENTS

The Company amended the Plan effective January 1, 2025, which changed the trustee from Reliance to ADP Retirement Trust Services, LLC.

Management has evaluated subsequent events through October 8, 2025, which is the date these financial statements were available to be issued.
