REPORT OF INDEPENDENT CERTIFIED PUBLIC ACCOUNTANTS

To the Plan Administrator and Participants of the

Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Educational Testing Service 401(a) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other matter - supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Educational Testing Service 401(a) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a non-contributory, defined contribution plan covering all regular employees of Educational Testing Service ("ETS"). Eligible employees commence participation in the Plan upon their date of hire or as soon as administratively practicable. Benefits are generally distributable upon or after retirement or termination of employment at ETS. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is administered by ETS, the Plan sponsor, under the direction of the ETS Employee Benefits Administration Committee.

Contributions

Under the terms of the Plan, ETS contributes 6% of each eligible participant's base salary, subject to the Internal Revenue Service ("IRS") limitations, to be invested in accordance with the participant's investment instructions. The Plan does not allow for rollover contributions.

Vesting

Participants vest 50% after one year of service and 100% after two years of service.

Benefits

In the event a participant's employment with ETS is terminated, contributions on behalf of the participant will cease and vested benefits will become eligible for distribution. Participants may choose from various distribution options, including single lump sum, periodic withdrawals or annuity purchases.

In the event of a participant's death after retirement benefits have commenced, payments to the spouse or other beneficiary will be made under the terms of the payment method in effect at the time of death. If there is no payment method in effect, the spouse or other beneficiary will make an election from the payment methods available.

Minimum required distributions apply per IRS regulations. Effective January 1, 2020, the minimum required distribution age varies based on employee's date of birth: age 70 ½ (if born before July 1, 1949), age 72 (if born after June 30, 1949 but before 1951), age 73 (if born after 1950 but before 1960), or age 75 (if born in 1960 or later).

Participant Accounts

The Plan offers a variety of mutual funds as investment options as well as a self-directed brokerage account, for participants through Fidelity Management Trust Company ("Fidelity"), which is the only service provider currently accepting contributions. Participant accounts are self-directed and are based on participant allocations to investment elections available under the Plan. Balances may not be transferred from Fidelity to investment accounts that are no longer available for new contributions under the Plan.

Participants' accounts are credited with employer contributions, realized and unrealized investment gains and losses, interest and dividends and other income received, and charged with an allocation of administrative expenses incurred by the investment fund as a whole. The benefit to which a participant is

entitled is the accumulated value of the participant's vested account. The purchase of annuity contracts represents payment of annuities to participants. Once these annuities are purchased, they are no longer included in Plan assets.

Forfeitures

At December 31, 2024 and 2023, forfeited accounts totaled approximately \$4,000 and \$4,000, respectively. Forfeitures will first be used to reduce future employer contributions and then any residual amounts will be used to pay plan expenses. During 2024 and 2023, employer contributions were reduced by forfeited non-vested accounts of approximately \$126,000 and \$84,000, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan investments, including the Plan's investment in the TIAA Traditional Annuity, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies utilize information provided by its trustees and custodians. In determining fair value, the Plan uses various valuation approaches, including the observability of prices and inputs. See Note 4 for additional fair value disclosures.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments. Interest and dividends are recorded when paid.

Administrative Expenses

Costs incurred in the administration of the Plan are paid either by participants through account administrative fees, which are netted against investment activity, or by the Plan. The total cost of Plan administration is partially offset by Plan revenue credits which are reported in "Other income" on the Statement of Changes in Net Assets Available for Benefits.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. The 12b-1 fees, which are ongoing annual fees allowable under Section 12b-1 of the Investment Company Act of 1940, are deducted from earnings to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and are not separately identifiable as an expense.

Benefit Payments

Benefit payments are recorded when paid.

NOTE 3 - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, Teachers Insurance and Annuity Association ("TIAA") and TIAA's College Retirement Equities Fund ("CREF"), the custodians of the Plan have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to the aforementioned information except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

The accounting framework for measuring fair value provides a hierarchy that prioritizes the inputs for valuation techniques. The hierarchy gives the highest priority to Level 1 measurements and the lowest priority to Level 3 measurements. The most observable inputs are used when available. The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability and inputs that are derived from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies and inputs used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - The Plan's investments in registered investment companies are valued at quoted market prices at the close of the last business day of the year and classified as Level 1.

Variable annuities - CREF variable annuity investments include shares in registered investment companies that are valued at quoted market prices at the close of the last business day of the year and classified as Level 1.

Fixed-rate annuity - The Plan's TIAA Traditional Annuity is a fixed-rate contract-based investment through the Retirement Annuity ("RA"), a non-fully benefit responsive contract. Observable prices for identical or similar investments do not exist, and it is classified as Level 3. The fair value of the contract equals the accumulated contributions and interest credited to the contract, less any withdrawals.

Investments in the TIAA Traditional Annuity earn a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The average annual yield and accumulated crediting interest rates were both approximately 4.6%, net of annual fees, for the year ended December 31, 2024. The average annual yield and accumulated crediting interest rates were both approximately 4.8%, net of annual fees, for the year ended December 31, 2023. The crediting interest rate is calculated daily. The RA does not allow lump-sum cash withdrawals and transfers must be distributed over 10 annual installments.

Pooled separate account - The TIAA Real Estate account invests in real estate properties and related investments, principally valued based on the market value of its holdings. The pooled separate account is valued at quoted market prices at the close of the last business day of the year and classified as Level 1.

Self-directed brokerage account - Participant self-directed investments in TIAA and Fidelity accounts consisting of mutual funds are valued at quoted market prices at the close of the last business day of the year and classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments may result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Plan and the related trust are intended to meet the qualification requirements pursuant to Section 401(a) and Section 501(a) of the Internal Revenue Code of 1986, as amended (the "Code"), and accordingly, the net investment income of the trust is exempt from income taxes. The IRS has determined and informed ETS by a letter issued on May 14, 2015, that the Plan and related trust are designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the determination letter and ETS believes that the Plan is designed and is currently being operated in all material respects in compliance with the applicable requirements of the Code.

ETS evaluated the Plan's tax positions and concluded that the Plan and trust maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes is required in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine examinations by taxing jurisdictions.

NOTE 6 - PLAN TERMINATION

ETS has not expressed any intent to discontinue the Plan, although it may do so at any time in whole or in part. In the event of termination, all participants would become 100% vested and receive distributions as they become due in accordance with the terms of the Plan.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options which are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term may materially affect participants' account balances and the

amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. The volatility of the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024, may not necessarily be indicative of amounts that may be realized in a current market exchange.

NOTE 8 - RELATED -PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Fidelity, TIAA and CREF, the directed trustees and custodians of certain assets of the Plan as of December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid for investment management services are reported in "Net appreciation in fair value of investments" on the Statement of Changes in Net Assets Available for Benefits. The Plan also permits notes receivable from participants. Therefore, transactions pertaining to these investments qualify as party-in-interest transactions. Certain administrative expenses paid by the Plan Sponsor qualify as party-in-interest transactions.

NOTE 9 - SUBSEQUENT EVENTS

ETS has evaluated all material transactions or events that occurred after December 31, 2024 through October 13, 2025, the date the Plan's financial statements were available to be issued and has determined there were no subsequent events requiring adjustment to, or disclosure in the Plan's financial statements.
