We have performed audits of the accompanying financial statements of the Turning Point School Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Turning Point School Defined Contribution Retirement Plan (the "Plan") is a defined contribution plan that covers all employees of MWLA, Inc. dba Turning Point School (the "School"). The Plan was established on July 1, 1987 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Investment fund options are participant-directed.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement and any amendments for a more complete description of the Plan's provisions.

**A. Eligibility**

All employees are eligible to participate in the Plan on the first day of employment.

**B. Contributions**

The Plan permits each participant to contribute up to the Internal Revenue Code (the "Code") annual maximum. The School's matching contributions are equal to 100% of a participant's deferral up to 5% of the participant's eligible compensation. The School has the option of making discretionary employer contributions. There were no discretionary employer contributions in 2024.

**C. Vesting**

A participant is fully vested immediately as to voluntary salary deferrals, rollover contributions, any employer contributions and related earnings.

**D. Payment of Benefits**

Benefits are recorded when paid. Hardship distributions are permitted.

**E. Retirement Age**

Benefits under the Plan begin when a participant retires, dies, becomes disabled or ceases to be an employee, whichever applies. Normal retirement age is 59½.

**F. Administrative Expenses**

The School pays for a majority of administrative expenses of the Plan.

**G. Forfeitures**

Forfeitures will be used to reduce employer discretionary and/or matching contributions. There were no forfeitures for the year ended December 31, 2024. No forfeitures are available as of December 31, 2024 and 2023.

**H. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance (reduced by the highest outstanding loan balance during the

prior 12 months). A loan is secured by a participant's vested account balance, bears interest at the prime rate as of the loan approval date and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates between 4.25% to 9.50%.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are presented on the accrual basis of accounting.

**B. Investment Valuation and Income Recognition**

Accounting principles generally accepted in the United States of America ("GAAP") establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

**C. Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**D. Risks and Uncertainties**

The Plan provides for investment options in any combination of investments offered by the Plan. Investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed intent to do so, the School has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date, which will be treated as the valuation date.

**NOTE 4 - INCOME TAX STATUS**

Section 403(b) tax deferred annuity plans are not required to obtain determination letters from the Internal Revenue Service stating they are qualified under the Code. However, the plan administrator believes the Plan has been designed and operated to comply with applicable requirements of the Code and is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by TIAA-CREF, the custodian of the Plan.

**NOTE 6 - POOLED SEPARATE ACCOUNT**

Certain investments held by the Plan are issued and managed by the custodian. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibitions under ERISA.
