### 1. Description of the Plan

The following description of the Tate Access Floors, Inc. Retirement Savings Plan ("the Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering substantially all employees of Tate Access Floors, Inc. ("the Company") (and one affiliated company, ASM Modular Systems, Inc.) (collectively, "the Companies") on the later of 90 days of service or the attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The Plan was amended and restated effective January 1, 2017.
- B. Contributions - Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their deferral and the Companies' contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and one stable value common collective trust as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 5% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Companies contribute an amount equal to (1) 100% of the participant's pre-tax contributions up to 3% of the participant's compensation, and (2) 50% of the participant's pre-tax contributions that exceed 3% of the participant's compensation, but that do not exceed 5% of the participant's compensation. The Companies may also make optional profit sharing contributions or additional matching contributions each year. No such contributions were made for the year ended December 31, 2024. Contributions are subject to certain statutory limitations.
- C. Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of a) the Companies' contributions, b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- D. Vesting - Participants are vested immediately in their contributions plus actual earnings thereon, as well as the Companies' matching safe harbor contributions plus actual earnings thereon. Optional matching and profit-sharing contributions are vested based on years of continuous services. A participant is 100% vested in the optional contributions after five years of credited service.
- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.50%, which are commensurate with local prevailing rates at the time the loan is initiated, as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.
- F. Payment of Benefits - On termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in installments over a period not exceeding the life expectancy of the participant and his or her beneficiary. If a participant's vested account balance is \$1,000 or less, the participant's vested account balance can be distributed immediately with or without the participant's consent.
- G. Forfeited Accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,657 and \$251, respectively. For the year ended December 31, 2024, \$1,519 in forfeiture funds were used to reduce the Companies' contributions.

### 2. Summary of Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

### 2. Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in a default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

#### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values (NAV) of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 at the end of the reporting period. For the year ended December 31, 2024, there were no significant transfers between Level 1 and Level 2 or into or out of Level 3.

5. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 7. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Related-Party and Party-In-Interest Transactions

As described in Note 2, the Companies' pays certain expenses related to plan operations. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 10. Nonexempt Transactions

During 2024, there were certain pay periods where employee withholdings and loan payments totaling \$61,467 were not timely remitted to the Plan by the Company. The Company is planning to make a contribution representing lost earnings to the Plan associated with the untimely remittances.

During 2023, there were certain pay periods where employee withholdings and loan payments totaling \$67,153 were not timely remitted to the Plan by the Company. During 2024, the Company made a contribution representing lost earnings to the Plan associated with the untimely remittances.

### 11. Subsequent Events

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
