Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Farrell Fritz, P.C. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and to other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Farrell Fritz, P.C. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s Adoption Agreement and Basic Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Farrell Fritz, P.C. (the “Company”). Employees who have completed one-half year of service (six months effective October 1, 2024) and are age 21 or older become participants with respect to the 401(k) program under the Plan on the first day of the calendar quarter coinciding with or following satisfaction of the eligibility requirements. Employees who have completed one year of service and are age 21 or older become participants with respect to the employer nonelective contributions on January 1 or July 1 coinciding with or following satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Company is the Plan Administrator. Mercer Trust Company, the Plan’s Institutional Investment Fiduciary, Trustee and Custodian, determined the appropriateness of the Plan’s investment offerings, monitored investment performance, and reported to the Board of Directors of the American Bar Association Retirement Funds (the Plan’s Program Sponsor) as of December 31, 2023 and for the period from January 1, 2024 through September 30, 2024. ADP Retirement Services is the Plan’s record-keeper and ADP Retirement Trust Services, LLC is the Plan’s trustee and custodian as of December 31, 2024 and for the period from October 1, 2024 through December 31, 2024.

Contributions

Each year, participants may contribute an amount equal to a specified dollar amount or a percentage of their annual compensation, as defined in the Plan. Effective October 1, 2024, participants may contribute up to 90% of their eligible compensation to the Plan on a pre-tax or after-tax (Roth) basis, up to a maximum allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions and Company employer nonelective contributions into various investment options offered by the Plan. Effective October 1, 2024, the Plan has an automatic enrollment feature whereby eligible participants are automatically enrolled in the Plan at a pre-tax contribution rate of 1%.

The Company’s Board of Directors may elect to make an employer nonelective contribution to the account of each participant who completes 1,000 hours of service and is employed on the last day of the respective plan year. These contributions are allocated based on groups as defined in the Plan. The contributions for each group are allocated pro rata based on compensation.

Contributions (continued)

For the year ended December 31, 2024, the Company made an employer nonelective contribution to the Plan of \$1,317,556.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the employer nonelective contribution and Plan earnings. Those participants who elected to have their accounts managed by Voya Retirement Advisors were charged a fee to their accounts for such advice through September 30, 2024. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer nonelective contribution portion of their accounts is based on years of continuous service. Participants start vesting in employer nonelective contribution accounts after two years of vesting service at a rate of 20% per year and are 100% vested after six years of vesting service. Participants also become 100% vested in their account immediately upon attainment of normal retirement age, death, or disability, as defined in the Plan.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance; or \$50,000, reduced by the excess (if any) of the highest outstanding note balances during the 12-month period ending on the day before the note is issued, over the outstanding balance of notes from the Plan on the date the note is issued. Effective from January 1, 2024 through September 30, 2024, a participant could only borrow up to two new notes per year, at a maximum of five notes outstanding at any one time. Effective October 1, 2024, a participant may have no more than three outstanding loans from the Plan at any time. The notes are secured by the balance in the participant's vested account. Spousal consent applies if a loan is secured by transferred pension accounts. The note interest rate is 1% above the prime rate (published in the Wall Street Journal and updated quarterly) as determined by the Trustee at the time of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service, a participant whose individual vested account balances exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period certain, as defined in the Plan. Effective from January 1, 2024 through September 30, 2024, a participant will automatically receive a lump-sum distribution for individual vested account balances of \$1,000 or less. Individual vested account balances greater than \$1,000 but \$5,000 or less will automatically be directly rolled over to an IRA designated by the Trustee unless the participant elects to receive the value of the vested interest in his or her account as a lump-sum distribution within the time period prescribed by the Plan. Spousal consent rules apply with respect to transferred pension accounts. Effective October 1, 2024, participants are eligible to receive benefit payments when they reach age 59 ½. For individual vested account balances of \$5,000 or less, a participant will automatically receive a lump-sum distribution.

Upon death before distribution of a participant's vested account balance, the participant's beneficiary will receive the remaining vested account balance in either a lump-sum or installments. The spouse is the beneficiary of a married participant unless the participant elects otherwise with spousal consent. Pre-retirement survivor annuity rules apply with respect to transferred pension accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,101 and \$9,558, respectively. These accounts may be used to restore forfeitures, reduce future employer nonelective contributions, or pay reasonable Plan expenses. During 2024, \$118,288 of forfeitures were used to reduce employer nonelective contributions and no forfeitures were used to restore forfeitures or pay reasonable Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets.

Fair Value Measurements (continued)

Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The Self-Directed Brokerage Account consists of mutual funds, stocks, and bonds that are valued based on quoted prices in active markets. The common/collective trust is valued at the NAV, as provided by the trustees, which is used as a practical expedient based on the funds’ underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized when earned. The Plan does not charge participants a fee related to the administration of note receivables. No allowance for credit losses has been recorded as of December 31, 2024 **and 2023**. If a participant ceases to make loan repayments and the loan is deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Professional account management fees related to investment advice and account management services are charged directly to the participant's account who elected this service. These fees are included in administrative expenses. Investment related expenses and program management fees (see Note 5) are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and noted receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mercer Trust Company as of December 31, 2023 and for the period from January 1, 2024 through September 30, 2024, and ADP Retirement Trust Services, LLC as of December 31, 2024 and for the period from October 1, 2024 through December 31, 2024, qualified institutions.

5. Common/Collective Trusts

The common collective trust funds (the “Funds”) in which the Plan participated as of December 31, 2023, and for the period from January 1, 2024 through September 30, 2024, were maintained by Mercer Trust Company, the Institutional Investment Fiduciary and Trustee of the Plan. Interests in the Funds were represented by units, each of which represented an undivided pro-rata share of the net assets of a fund. Although similar in nature to mutual funds, the Funds were not traded on an active market. Participant transactions (purchases and sales) may have occurred daily, without requiring notice or restrictions of redemption.

Effective October 1, 2024, the Plan offers one common/collective trust to participants of the Plan, which is the Invesco Stable Asset ADPZ (the “Trust”). The NAV of the Trust is determined each business day. Issuances and redemptions of units may be made on such days, based upon the NAV per unit as of the valuation date last preceding the date on which such order to contribute or redeem assets is received.

The Plan has no unfunded commitments as of December 31, 2024 **and 2023**.

6. Related Party and Party-in-Interest Transactions

As of December 31, 2023 and for the period from January 1, 2024 through September 30, 2024, the Plan sponsor participated in the ABA Retirement Funds Program (the “Program”). As the Plan’s program sponsor, ABA Retirement Funds was responsible for the design and maintenance of the Plan, providing a variety of investment options under the Program and providing independent oversight over the Program’s service providers who provided custodial, recordkeeping and administrative services to the Plan.

Certain Plan investments consisted of common collective trust funds managed by Mercer Trust Company (“MTC”), the Institutional Investment Fiduciary and Trustee of the Plan. Certain of these investments managed by MTC were also maintained by State Street Bank and Trust Company, as Investment Advisor to the respective common collective trust funds, as defined by the Program. Voya Institutional Plan Services, LLC, an affiliate of Voya Retirement Insurance and Annuity Company and Voya Financial (collectively “Voya”), was the Plan’s recordkeeper, as defined by the Plan. Transactions with these related parties qualified as exempt party-in-interest transactions.

The common collective trust funds that were held by the Plan paid a program fee to ABA Retirement Funds, Voya and MTC for their respective services to the Program. These fees were included in net appreciation in fair value of the investments.

6. Related Party and Party-in-Interest Transactions (continued)

As of December 31, 2024 and for the period from October 1, 2024 through December 31, 2024, certain Plan investments are managed by ADP Retirement Trust Services, LLC, the custodian of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer nonelective contributions.

8. Tax Status

The Plan is maintained through the adoption of a pre-approved non-standardized profit sharing plan sponsored by ADP, LLC ("ADP"). The most recent IRS opinion letter is dated October 6, 2020, and provides that the pre-approved non-standardized profit sharing plan is acceptable with the applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan continues to be qualified and its related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service ("IRS"). The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
