INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Choctaw-Kaul Distribution Co. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Choctaw-Kaul Distribution Co. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF PLAN

The following description of Choctaw-Kaul Distribution Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a 401(k) plan covering all full-time employees of Choctaw-Kaul Distribution Company and Peerless Ohio Glove Corporation (collectively the "Company") who have six months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to the maximum percentage allowable of annual pretax compensation, as defined in the Plan, not to exceed the limits of Internal Revenue Code section 401(k). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common/collective trusts as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan does not have a provision for employer matching contributions.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.50%. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$836 and \$689, respectively. Forfeitures may be used to pay any administrative expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Reclassifications

Certain amounts in previously issued financial statements have been reclassified to conform with the current year presentation. Total equity and net income are unchanged due to these reclassifications.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Proceeds from the Plan's ERISA budget account are recorded as other income as soon as the Plan has the contractual right to receive them.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of annual amounts allowed by the IRS are recorded as excess contributions payable, with a corresponding reduction to contributions received for the year in question. The Plan distributes these excess contributions prior to March 15 of the following calendar year.

There were no excess contributions for the year ended December 31, 2024, and there were excess contributions of \$2,223 for the year ended December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Amounts totaling \$52,658 for fees paid by the Plan are recorded as administrative expenses. Of this amount, \$40,446 was paid to Wells Fargo for the services of an investment advisor and \$12,212 was paid to the Plan's record keeper. The investment advisor fees were paid using proceeds from the Plan's ERISA budget account and were not charged to participants. Of the recordkeeping fees, \$5,479 was charged to specific participants for transaction fees, while the remaining \$6,733 was allocated pro rata across all participants to pay for monthly operating expenses.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

1. Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
2. Collective trusts: Valued at net asset value of units of the collective trusts. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions may occur daily. If the Plan initiates a full redemption of the collective trusts, the issuers reserve the right to require up to 60 days' notification in order to ensure that securities liquidation will be carried out in an orderly business manner.

Significant Investment Strategies of Investees Which Report Net Asset Value per Share as a Practical Expedient

Holdings in the MetLife Stable Value Fund represent ownership units in the MetLife Group Annuity Contract No. 25554, which itself invests in corporate and government bond funds. The Contract simulates the performance of a guaranteed investment contract through the guarantee of a specific interest rate. The interest rate is reset every quarter as determined by MetLife with consideration of several market factors. MetLife guarantees that the rate will never be less than zero.

The State Street Global Advisors (SSGA) S&P Mid Cap Index Fund seeks an investment return that approximates as closely as practicable, before expenses, the performance of the S&P MidCap 400 Index over the long term. It attempts to invest as closely as possible in the securities comprising the Index in the same proportions as they are represented in the Index.

NOTE D - INVESTMENTS - INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

NOTE G - TAX STATUS

Although the Plan has not requested determination from the Internal Revenue Service (IRS) as to the Plan's tax-exempt status, the Automatic Data Processing Prototype 401(k) and Profit Sharing Plan, from which the Plan was drafted, has received a favorable opinion, dated October 6, 2020, from the IRS.
