INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor and Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Langer Industries, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Langer Industries, Inc. 401(k) Profit Sharing Plan (the "Plan") for eligible employees of Langer Industries, Inc. and Subsidiaries (collectively, the "Employer" or "Plan Sponsor") provides only general information. Participants should refer to the Plan Agreement and subsequent amendments for a more complete description of the Plan's provisions. In 2015, the Plan amended the Plan Agreement to include wholly-owned entities of Langer Industries, Inc.; Langer Transport Corporation, Transport Maintenance Company and ARM Motor Truck Leasing Corp.

General

The Plan is a defined contribution plan covering substantially all employees who are age twenty-one or older. Effective January 1, 2016, the Plan Sponsor amended the Plan Agreement to include an automatic enrolment feature for all new eligible participants as well as to change the eligibility requirement for participants to be twenty-one years of age and complete one month of service from the employment commencement date. Employees are eligible to enter the Plan on the first day of the month following the date the eligibility requirements are met.

Reliance Trust Company ("the Trustee") serves as the trustee of the Plan and ADP Retirement Services (the "Administrator") serves as the administrator of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Salary Deferral - Each year, participants may make pre-tax elective deferrals up to 90% of their annual compensation, as defined in the Plan Agreement, up to the 401(k)-deferral limit. As of January 1, 2016, all new eligible employees are automatically enrolled in the Plan at a default percentage of 3%, subsequently increased by 1% up to a maximum of 10% on each succeeding eligibility anniversary date, unless they opt out or elect to change the default election deferral. Effective October 1, 2019, the Plan Sponsor amended the Plan agreement to allow Roth elective deferrals. Participants may elect to designate all or any portion of their elective 401(k) deferral contributions as Roth elective deferral contributions. This election will be irrevocable and the amount contributed will be included in the participants' income for tax purposes.

For the 2024 and 2023 Plan years, the 401(k) deferral limit was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution permitted for 2024 and 2023 was \$7,500 for both years respectively. All contributions are made through payroll deductions. The contribution percentage(s) can be changed or stopped entirely at any time. Rollovers from other qualified plans or annuity contracts are permitted. All Company contributions are invested based upon participant account elections.

Employer Nonelective Profit Sharing Contribution

The Employer may authorize a profit-sharing contribution, which is a discretionary contribution as determined by management. This contribution, if any, will be made on an annual basis as of the last day of the Plan year and will be allocated in the same ratio as each participant's compensation over the total compensation of all participants eligible to share in such contribution. In order to qualify for the allocation of Employer nonelective profit sharing contributions, a participant, whether employed or not employed at the end of the Plan year, must have completed at least 500 hours of service during the Plan year. Contributions are subject to certain Internal Revenue Service limitations. There were no Employer nonelective profit-sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and an allocation of the Employer's contribution, Plan earnings or losses, participant forfeitures, and charged with withdrawals and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Agreement. Refer to Note 2 for information on investment transactions and income recognition on individual participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (CONTINUED)

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan which include mutual funds and common/collective trusts. Employer contributions, if any, are automatically invested into the participants' respective investment options. The available funds as of December 31, 2024 are listed in the supplemental Schedule of Assets (Held at End of Year).

Vesting and Forfeitures

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. A participant is 100% vested in the Employer nonelective profit sharing contribution after six years of credited service or upon reaching normal retirement age, death or classification as permanently and totally disabled. Forfeitures, if any, due to Employer nonelective profit sharing contributions will first be used to pay administrative expenses of the Plan and second, will be allocated to all participants eligible to share in the allocations of Employer nonelective profit sharing contributions or forfeitures in the same proportion that each participant's compensation for the Plan year bears to the compensation of all participants for such year. There was no forfeiture activity and no forfeiture balances for the years ended December 31, 2024 and 2023. Forfeitures, if any, will be disposed of in the Plan year in which the forfeiture occurs.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a distribution in a lump-sum amount, or as otherwise determined in the Plan Agreement, equal to the value of the participant's fully vested account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participant Loans

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balances in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1 to 5 years, unless the loan is for the purchase of a primary residence. Loans bear interest at a rate of prime plus 1% as determined at the time the loan is approved. Principal and interest are payable rateably through weekly payroll deductions.

Participants may also obtain a cash withdrawal of all or a portion of the value of their vested elective deferral account on the basis of hardship as permitted under the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") and are stated in United States Dollars.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

The Plan holds investments in several common/collective trusts (the "Trusts"). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion on valuation techniques and the Trusts' principal investment objectives.

Net appreciation in the fair value of the Plan's investments as reported on the statement of changes in net assets available for benefits includes the realized gains or losses and the unrealized appreciation (depreciation) on investments bought and sold as well as held during the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation or depreciation in fair value of investments.

Notes Receivable from Participants and Withdrawals

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. The financial statements include delinquent loans until specifically written off. Form 5500 reflects the delinquent loans as distributions. See Note 9 for the reconciliation from the Plan's financial statements to Form 5500. Included in the benefits paid to participants are discharged loans amounting to \$367 and \$11,487 for the years ended December 31, 2024 and 2023, respectively.

Excess Contributions Refundable

The payables reflected at December 31, 2024 or 2023, represent amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service ("IRS") and amounts deferred by participants that were not in accordance with the Plan Agreement. In accordance with IRS limits, the Plan is required to refund excess contributions received during the Plan year. Contributions totaling \$1,229 need to be refunded to applicable participants for the 2024 Plan year and were subsequently refunded in 2025. There were no excess contributions refundable related to the 2023 Plan year. These refunds are required in order for the Plan to pass the Average Deferral Percent ("ADP") test and to comply with Internal Revenue Code ("IRC") Section 415 for the year ended December 31, 2024. Contributions deferred by participants that were not in accordance with the Plan Agreement for a previous year totaled \$79 and will be refunded to the Plan participants in 2025.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

3. FAIR VALUE MEASUREMENTS

In accordance with the authoritative guidance on fair value measurements and disclosures under US GAAP, the Plan follows a standard that establishes a three-level valuation hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Registered Investment Companies (Mutual funds)*: The fair value of registered investment companies (including mutual funds) is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded and are classified within Level 1 of the valuation hierarchy.
- *Common/Collective Trusts*: Valued at the net asset value (“NAV”) per share (or its equivalent) based on information reported by the investment advisor using audited financial statements of the common/collective trusts at year-end. The NAV is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the trustless liabilities. The common/collective trusts NAV represents fair value since this is the amount at which the Plan transacts with the trust. Plan management believes that the value of the common/collective trusts are reasonably stated and that no adjustment to NAV as of December 31, 2024 and 2023 is required.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. EXEMPT PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain Plan investments are managed by the Trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. Pursuant to Plan documents, the Trustee receives revenue from mutual fund and common and collective trust service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan, and is included as a reduction to net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

If revenue received by the Trustee from such mutual fund or common and collective trust service providers exceeds the amount owed under the Plan documents, the Trustee remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts.

Fees paid by the Plan for recordkeeping and plan administration to the Trustee amounted to \$8,486 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The Plan has not considered Company contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions.

6. INCOME TAX STATUS

The Plan was adopted in the form of a prototype non-standardized plan sponsored by Automatic Data Processing that received a favorable opinion letter dated October 6, 2020, from the IRS which states its terms are in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes that the Plan as currently designed and operated is in compliance with the applicable requirements of the IRC, and the Plan and the related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. These investments are exposed to various risks, including, but not limited to interest, market, credit, geo-political, macro, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities may occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan Agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become fully vested in any Employer nonelective profit sharing contribution portion of their accounts.
