INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the WorldVu Development LLC 401(k) Savings Plan and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the WorldVu Development LLC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to the Financial Statements For the Years Ended December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN

The following description of the WorldVu Development, LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective June 19, 2014 by WorldVu Development LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees who are at least age 21 are eligible to participate in the Plan on the first of the month following the date of hire, with the exception of non-resident aliens and residents of Puerto Rico. The appointed Plan trustees and administrator control and manage the operation and administration of the Plan. The Plan administrator has all powers necessary to carry out the provisions of the Plan to satisfy the requirements of any applicable law. The Plan was most recently restated and amended effective January 1, 2022 to provide for Company safe harbor matching contributions.

Participant Contributions

Participants may elect to defer up to 90% of their annual compensation, as defined in the Plan document, not to exceed the maximum allowable contributions under Section 402(g) of the Internal Revenue Code (the Code) limitations, which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023. Participant salary deferrals may be contributed as traditional pre-tax 401(k) or Roth 401(k). Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

The Plan allows automatic enrollment of employees once the eligibility requirements have been met. Employees are automatically enrolled with pre-tax deferral contributions deducted from their pay at a rate of 3% of their compensation unless the employee opts out of Plan participation or elects a different percentage.

Company Contributions

The Company provides a safe harbor matching contribution equal to 100% on the first 3% of the participant's eligible compensation and 50% on the next 2% of the participant's eligible compensation deferred into the Plan. All employees who are eligible to participate into the Plan are eligible to receive Company safe harbor matching contributions. Safe harbor matching contributions are calculated and remitted each pay period and a true up is required at year-end. Safe harbor matching contributions totaled \$750,967 and \$841,193 for the years ended December 31, 2024 and 2023, respectively.

Company Contributions – continued

The Company may also make additional discretionary matching contributions allocated to each eligible participant's account as a percentage of the participant's elective deferrals as of the end of each Plan year. For the years ended December 31, 2024 and 2023, the Company did not make a discretionary contribution.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions, Company contributions, and charged with benefit payments, transaction fees related to distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in all salary deferrals, Company contributions, and rollovers.

Notes Receivable from Participants

Participants may borrow against the value of their account balance within the Plan, without regard to the intended use of the funds. The minimum note amount is \$1,000, and a participant may not have more than one note outstanding at a time. The total amount of borrowings cannot exceed the lesser of 50% of the participant's account balance or \$50,000 less the highest outstanding note balance for the previous twelve month period. Notes bear interest at a fixed rate based on the prime rate published in The Wall Street Journal on the first day of the month of note origination, plus 2%. Notes for reasons other than the purchase of a primary residence are to be repaid within 5 years. Notes for the purchase of a primary residence are to be repaid within 30 years.

Payment of Benefits

Upon termination of service, retirement, disability, or death, a participant or beneficiary may elect to receive payment of their vested portion in one of several different forms. If a participant's account balance upon termination is less than \$5,000 and no distribution election is made by the participant, the balance will be distributed without participant consent. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, all amounts in a participant's account may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. In all cases, certain income taxes and penalties may apply to withdrawals or distributions prior to age 59½. There were no net assets of the Plan allocated to accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023.

Plan Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Expenses relating to specific participant transactions are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

The Company utilizes a revenue sharing account to offset recordkeeping fees due from the Company. Plan expenses are shown gross on the accompanying statements of changes in net assets available for benefits. Revenue sharing generated income totaling \$34,202 and \$21,805 during the years ended December 31, 2024 and 2023, respectively, which was used to offset recordkeeping fees. There was no balance in the revenue sharing account as of December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of changes to net assets available for benefits during the reporting periods. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur in the near term and materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interest in common/collective trust: Valued at the net asset value (NAV), a practical expedient, determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment information contained in the accompanying financial statements and supplemental schedules, including assets held at December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

4. TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which received an opinion letter dated October 6, 2020 from the Internal Revenue Service (IRS) as to the pre-approved plan’s qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the date of this opinion letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan’s financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor (DOL); however, there are currently no audits for any periods in progress.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants to take out notes against their account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Some investment related fees incurred by the Plan are included in net appreciation in fair value of investments. Such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. PROHIBITED TRANSACTIONS

The Plan Sponsor discovered that during the years ended December 31, 2023, \$238,650 of participant contributions and loan repayments were not remitted to the Plan within the required timeframe as required by the DOL. As of October 10, 2025, management has corrected the late remittances totaling \$238,650 for the year ended December 31, 2023, by calculating lost earnings in accordance with DOL and IRS guidelines, for the contributions.

8. EXCESS CONTRIBUTIONS PAYABLE

During the year ended December 31, 2024, the Plan complied with all non-discrimination rules. As a result, the Plan did not record any excess contributions payable in the accompanying statements of net assets available for benefits as of December 31, 2024. During the year ended December 31, 2023, the Plan failed to comply with certain non-discrimination rules. As a result, the Plan was required to record excess contributions payable of \$16,303 in the accompanying statements of net assets available for benefits as of December 31, 2023. The Plan refunded these excess contributions to affected participants in February and 2024.
