**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Solero Technologies, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan which covers substantially all employees of Solero Technologies, LLC (the “Company”) excluding individuals classified by the Company as interns, co-ops, and nonresident aliens. Eligible employees are able to participate in the Plan immediately. Those individuals must complete 2 months of service to be eligible for the employer matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan initially became effective on January 1, 2022 and was amended and restated effective November 1, 2023 to increase the termination distribution force out threshold from \$1,000 to \$5,000. Subsequent to year end, effective January 1, 2025, the plan was amended and restated to incorporate prior updates and adopt revised provisions, including updated contribution, matching, and administrative rules, in compliance with current regulatory requirements.

A participant shall not have the right to receive benefits until termination of service, attainment of normal retirement age, meeting the requirements for a hardship distribution, disability, or death. A participant is eligible for normal retirement when the participant reaches age 65.

Contributions: Participants can contribute 1% to a maximum of 70% in 1% increments of their eligible compensation during the Plan year subject to certain limitations. Roth contributions are allowed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees, upon meeting eligibility requirements, are automatically enrolled at a deferral rate of 6% unless they elect to change this amount or decline entry electronically via the member services line or the member website. All participants who had an automatic deferral or whose deferral is greater than 6% or less than 10% will be subject to an automatic increase of 2% each year until they reach 15% unless they elect to change this amount. The Plan Sponsor contributes safe harbor non-elective contributions equal to 3%, discretionary fixed matching contributions up to 100% of the first 3% of participant deferrals, additional discretionary fixed matching up to 100% of the first 3% of participant deferrals – limited to \$500 annually, and profit-sharing contributions depending on years of service and compensation level relative to the Social Security Taxable Wage Base.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions, and (b) Plan earnings, and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, Disability: A participant (beneficiary) is entitled to 100% of his or her vested account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts is based on years of continuous service. Employer contributions and actual earnings thereon vest 100% upon three years of service.

Forfeitures: The non-vested portions of terminated participants’ accounts are forfeitures. Forfeitures are used to pay Plan expenses and reduce future Company contributions.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Payment of Benefits: Upon termination of service, a participant may elect to receive either a lump-sum or direct rollover amount equal to the vested account balance. If the participant's vested account balance is \$1,000 or less, the participant may elect to receive installments over a period not to exceed life expectancy or partial withdrawals. In 2023, this threshold was increased to \$5,000. Active participants may also take distributions from the Plan upon attainment of age 59½.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan provides for various investment options including mutual funds and collective trust funds. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balance.

Subsequent Events: Management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to or disclosure within the financial statements for the year ended December 31, 2024. Management has performed their analysis through October 13, 2025, which was the date that the financial statements were available to be issued and has determined that aside from the amendment above, there are no subsequent events to disclose.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the custodian of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 - FAIR VALUE MEASUREMENTS** (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trusts:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. The fund invests in investment contracts issued by life insurance companies, banks and other financial institutions with the objective of preserving principal investment while earning a level of interest income that is consistent with the principal preservation.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service has issued an opinion letter dated October 6, 2020, indicating that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the latest opinion letter. The plan administrator believes that the Plan is currently designed and being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by employees or officers of the Company. Certain professional fees for the administration and audit of the Plan were paid by the Company. Investment management and custodial fees paid by the Plan to ADP, Inc and affiliates of ADP qualify as party-in-interest transactions. Fees of \$59,744 were paid by the Plan to the Plan's recordkeeper during the Plan year for certain services related to the Plan.
