This representation letter is provided in connection with your audits of the financial statements and supplemental schedule of L. Kang, Inc., 401(k) Plan (the "Plan"), which comprise the Statements of Net Assets Available for Benefits (Modified Cash Basis) as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits (Modified Cash Basis) for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the "financial statements").
