### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of United Refining Company Incentive Savings Plan for Salaried Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

## Notes to Financial Statements

### 1. Plan Description

The following brief description of the United Refining Company Incentive Savings Plan for Salaried Employees (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions. United Refining Company is the “Plan Sponsor” of the Plan.

#### General

The Plan is a defined contribution 401(k) plan covering generally all salaried employees not covered under a collective bargaining agreement who have completed at least 30 days of eligible service (one year of service prior to January 1, 2011) or were employed by United Refining Company (the “Company”) on July 1, 1989 who have reached age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

United Refining, Inc. and United Riverhead Terminal, Inc., related employers, are also adopting employers as members of the controlled group.

Effective January 1, 2024, the plan was amended to allow participants to elect after-tax Roth contributions at their discretion.

#### Contributions

Participants may elect to contribute a percentage of base salary subject to certain IRS limitations. The Plan has an automatic enrollment feature. Eligible employees will automatically have 3% of eligible wages deferred and remitted to the Plan unless the employee changes the deferral percentage or elects not to participate in the Plan. Employee contributions are matched by the Company at the rate of 50% of the participant’s contribution, up to the first 6% of the employee’s salary. The Company will also make a non-elective profit-sharing contribution in an amount equal to 3% of eligible participant compensation for the Plan year, in addition to the above-mentioned matching provisions. Participants are permitted to make rollover contributions from previous plans qualified under Section 401(a) of the Internal Revenue Code (the “Code”) to any investment account. These types of contributions, however, are not matched by the Company. Matching contributions from the Company are allocated based upon participant elections.

Employee contributions from the participant’s eligible compensation as defined in the Plan are excluded from the participant’s current Federal taxable income, in accordance with Section 401(k) of the Code and are subject to certain limitations.

## Notes to Financial Statements

### 1. Plan Description (Continued)

#### Participants' Accounts

Each participant's account is credited with the participant's and the Company's contributions and an allocation of net plan earnings and are charged with an allocation of certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan and may transfer balances between investment options at any time. Currently, the Plan offers various mutual funds and one Common/Collective Trust fund as investment options for participants. The Plan also allows participants to select their own investments through self-directed brokerage accounts ("SDBA"). The SDBA allow participants to invest in mutual funds, nationally traded equity securities, treasury bills, notes and bonds, and taxable bonds.

#### Vesting

Participants are always vested 100% with respect to the current value of their tax deferred and rollover contributions as well as company profit sharing contributions. Participants who retire under the Company's pension plans, attain age 65, become permanently disabled or die are fully vested with respect to the current value of Company contributions.

An employee who became an eligible participant on the Plan's effective date, July 1, 1989, is at all times 100% vested in the Company's contributions made to their account. Employees who were not eligible as of the Plan's effective date are subject to the Plan's vesting rules with regard to Company matching contributions and become 20% vested after one year of service and 20% per annum thereafter.

#### Notes Receivable From Participants

Participants are not permitted to borrow against their account balances.

#### Payment of Benefits

Normal retirement age is 65. Early retirement is permitted after attaining age 55 and completing 5 years of vesting service. Benefits are paid upon participants' termination of service, retirement, death, disability, attainment of 59-1/2 years of age or hardship. Any benefit payments are made in accordance with the Plan's provisions as lump sum distributions or installment payments over 10 years or less at the discretion of the participant. All vested account balances less than \$5,000 may be automatically distributed to the participant.

## Notes to Financial Statements

### 1. Plan Description (Continued)

#### Forfeitures

Company contributions and earnings thereon that have not become vested, and have been forfeited in accordance with the applicable provisions of the Plan, may be applied to reduce the Company's contributions required under the Plan or to pay plan expenses. If a participant returns to employment prior to incurring a five-year break in service, as defined in the Plan document, any forfeited contributions are restored. As of December 31, 2024, and 2023, \$2,266 and \$2,629, respectively, had been forfeited by participants but not yet applied to reduce the Company's future contributions. In 2024 and 2023, employer contributions were reduced by \$10,000 and \$62,015, respectively, from forfeited nonvested accounts.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The Plan's financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value in accordance with ASC 820, *Fair Value Measurements and Disclosures*, as determined by the trustee, Bank of America, N.A. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. In accordance with the policy of stating investments at fair value, net appreciation or depreciation for the year, including both realized and unrealized gains and losses, is reflected in the statements of changes in net assets available for benefits.

#### Contributions

Participant contributions are made through payroll deductions and are recorded as additions to net assets available for benefits when the deduction is made. Employer contributions are recorded as additions to net assets available for benefits when the Company accrues such contribution as a liability. Employee and employer contributions not yet deposited are recorded as contributions receivable.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025 the date on which the financial statements were available to be issued.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in the net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. The Plan's financial statements include amounts that are based on the Plan Administrator's best estimates and judgments. Actual results could differ from those estimates.

### 3. Party-In-Interest Transactions

The Plan may occasionally pay fees to Bank of America, N.A. Bank of America, N.A. is the trustee of the Plan and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan amounted to \$2,841 and \$2,700 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment management services are netted against net appreciation in fair value of investments.

Fees paid by the Plan to Willis Towers Watson during the years ended December 31, 2024 and 2023 were \$39,469 and \$14,583, respectively.

Fees paid by the Plan to LVBW, LLP during the years ended December 31, 2024 and 2023 were \$16,800 and \$-0-, respectively.

All of these transactions are exempt from the prohibited transaction rules of ERISA.

### 4. Income Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Plan’s third-party administrator by a letter dated June 30, 2020, that the third-party administrator’s Non-Standardized Pre-Approved Plan on which the Plan is based, is designed in accordance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has had subsequent amendments, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 5. Information Certified by the Plan’s Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following information summarized in the financial statements and supplemental schedule relating to investment income for the Plan for the years ended December 31, 2024 and 2023, and investments held as of December 31, 2024 and 2023 was certified by Bank of America, N.A. as trustee of the Plan.

### 6. Plan Termination

The Plan sponsor has not expressed any intent to terminate the Plan but is free to do so at any time, subject to the provisions of ERISA. In the event of termination, each participant automatically becomes fully vested to the extent of the balances in his or her individual account.

### 7. Fair Value Measurements

Financial Accounting Standards Board ("FASB") ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - CCTs represent investments with various investment managers. Units held in CCTs are valued at the net asset value as reported by the investment managers. The Plan holds units of participation in a CCT that has investments in fully benefit-responsive investment contracts. As provided in ASC 962, an indirect interest in an investment contract is generally required to be reported at fair value, rather than contract value, to the extent it is fully benefit-responsive. The fair value of such investment contracts held by the CCT is determined using the market price of the underlying securities and the value of the investment contract as determined by the trustee.

CCT - Federated Capital Preservation Trust Fund is a collective investment fund for which Federated Investors Trust Company ("Federated"), a wholly-owned subsidiary of Federated Investors, Inc., serves as trustee under a Declaration of Trust dated October 25, 2007, as amended and restated on August 30, 2011, August 23, 2016, June 26, 2020, and July 16, 2021. The Trust Agreement is the governing instrument of the Fund. The trustee is organized as a Pennsylvania state-chartered trust company. The trustee and the Fund operate in conformity with the rules and regulations of the Pennsylvania Department of Banking as they apply to collective investment of fiduciary funds. The Fund is exempt from income taxes under Sections 401 and 501 of the Internal Revenue Code. The investment objective of the Fund is stability of principal and high current income. The Fund files its own 5500 giving it the status of a Direct Filing Entity.

In certain circumstances, the amount withdrawn from the Fund would be payable at fair value rather than at contract value. These circumstances may include, but are not limited to, the following: mergers, mass layoffs, plan terminations, implementation of early retirement incentive programs or other events within the control of the Fund or the Plan sponsor resulting in a material and adverse financial impact on the issuer's obligations.

Based on prior experience, Federated believes that it is not probable that such circumstances would be of sufficient magnitude to limit the ability of the Fund to transact at contract value with participants. Of course, there can be no guarantee that this will be the case.

Self-directed brokerage accounts - valued at the closing price reported on the active market on which the individual underlying assets are traded.
