#### Scope and Nature of ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of City Line Distributors, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of City Line Distributors, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

#### Opinion

**Note A - Description of the Plan**

The following description of the City Line Distributors, LLC (the “Company”) 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established January 1, 1994 and was subsequently amended and restated effective January 1, 2009 and September 21, 2021. Employees of the Company become eligible to participate in the Plan upon completion of one (1) year of service in which they completed 1,000 hours of service and have attained age 21. Effective September 21, 2021, the plan was amended so that all employees were eligible to participate once they completed one (1) year of service in which they completed 1,000 hours of service and have attained age 18. Employees who qualify to become participants are eligible to enter the Plan monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All eligible employees are automatically enrolled in the Plan. If the automatic enrollment provision applies to an employee, the Plan will automatically defer 2% of their compensation, which will increase in increments of 1% per annum up to 10%, unless the employee elects to opt-out of the Plan.

**Administration**

The Company is the Plan’s named fiduciary and plan administrator. Reliance Trust Company is the custodian and trustee of the plan and ADP Retirement Services, Inc. (“ADP”) is the record keeper. Reliance Trust Company holds the Plan’s investments and executes investment transactions. ADP prepares statements for participants, which include amounts of contributions, investment income, disbursements and fair value of investments. ADP also calculates distributions and forfeitures in the event of a participant’s termination of employment.

**Contributions**

**Participants salary reduction election:**

The Plan allows each participant to defer up to 75% of their annual qualified compensation as defined in the Plan and is subject to Internal Revenue Code (“IRC”) restrictions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In accordance with the IRC, participant contributions were limited to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. This amount will be adjusted annually in accordance with IRS rules and regulations. Participants who will reach age 50 by the end of the 2024 tax year are eligible to make additional catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

**Contributions (continued)**

*Employer profit sharing contribution:*

The Company may make a discretionary profit sharing contribution. Participants are eligible if they are employed on the last day of the plan year or upon completion of one year of service in which they completed 500 hours of service. The Company did not make a discretionary profit sharing contribution to the Plan for the years ended December 31, 2024 and 2023.

*Employer matching contribution:*

The Company may make a discretionary matching contribution. For 2024 and 2023, the Company matches 50% of the first 6% of base compensation. Any participant actively employed during the Plan year shall be eligible to share in the matching contribution for the Plan year. The Company's matching contributions to the Plan for the years ended December 31, 2024 and 2023 were \$363,739 and \$349,232, respectively.

**Participant accounts**

Each participant's account is credited with the participant's deferrals and the Company's matching contribution and Plan earnings. Plan contributions are participant directed and are invested in one or more investment vehicles available to participants under the Plan. Earnings and losses are determined by individual investment vehicle performance.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant becomes 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service and 100% vested after six years of service.

**Notes receivable from participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of the non-forfeitable accrued benefit of the participant under the Plan. Loan terms range for 1-5 years, unless the proceeds are used for the purchase of a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

**Forfeitures**

If excess 401(k) elective deferral contributions are refunded to a participant, any matching contributions will be forfeited. If the participant is a highly paid employee, the law may limit their contributions and the Company's matching contributions. If 401(k) elective deferral contributions are refunded to a highly paid employee, any matching contributions made because of these 401(k) elective deferral contributions will be forfeited.

**Forfeitures (continued)**

Matching contributions which are forfeited because of these limits may reduce the Company's future contributions or may be used to pay administrative expenses. Forfeited nonvested accounts totaled \$823 and \$14 at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, \$43,247 and \$17,121 in forfeitures were applied to reduce the employer's matching contributions and the Plan's administrative expenses, respectively.

**Investment options**

Upon enrollment in the Plan, a participant may direct employee contributions and employer discretionary contributions in any whole percent increments in any of the various investment options available by the Plan. Participants may change their investment options on a daily basis.

**Payment of benefits**

Upon termination of service, attainment of normal retirement age, or disability, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who reaches his or her normal retirement age but does not retire shall commence to receive his or her benefits at any time elected by the participant after his or her normal retirement age. If benefits are not paid to a participant who reaches his or her normal retirement age but does not retire, such benefits shall be invested as part of trust assets, with gains and losses allocated proportionately to the participant's account.

**Hardship withdrawals**

Participants may elect, subject to specific circumstances defined in the Plan, to receive up to 100% of their salary deferral contributions or the amount necessary to meet their financial need, whichever is lower.

**Note B - Significant Accounting Policies**

**Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

The fair value of assets is determined using various methods, which are impacted by a number of factors, including the availability of observable market data over the contractual term of the underlying assets. For some of the Plan's assets, fair value is determined based on directly observable market data or data available for similar assets in similar markets. For other assets, the fair value may be determined based on these inputs as well as other assumptions related to estimates of these assets, such as the creditworthiness of the issuer. Changes in net unrealized appreciation or depreciation are captured in the carrying value of the underlying investments in the Statements of Net Assets Available for Benefits in accordance with US GAAP guidance. Dividends are recorded on the ex-dividend date.

Plan investments in mutual funds are stated at fair value based upon quoted market prices. Shares of common/collective trust funds are valued at net asset value.

**Contributions**

Employee and employer contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings.

**Plan expenses**

The Company has elected to charge administrative fees to the Plan's trust. All other expenses are paid by the Company.

**Notes receivable from participants**

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. No allowance for loan losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. During the years ended, December 31, 2024 and 2023 delinquent loans reclassified as distributions were \$4,534 and \$2,107, respectively.

**Payment of benefits**

Benefits are recorded when paid.

**Note C - Fair Value Measurements**

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of fair value hierarchy are described below:

**Level 1 Inputs:** Valuation based on quoted prices in active markets for identical assets or liabilities that a reporting entity has the ability to access at the measurement date, and where transactions occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

**Level 2 Inputs:** Valuation based on inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, that is markets in which there are few transactions, prices are not current, or prices vary substantially over time.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 Inputs:** Valuation based on inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Shares of Registered Investment Companies**

The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

**Common/Collective Trusts**

The Plan includes an investment option to participants in the Invesco Stable Asset Fund, a collective investment trust, which invests in fully benefit-responsive investment contracts that are stated at net asset value, which approximates fair value. The redemption frequency for these funds is daily with a one day redemption notice period. There were no unfunded commitments as of December 31, 2024.

**Note F - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full termination, partial termination, or the complete discontinuance of contributions by the Company, all amounts credited to the affected participants' combined accounts are considered 100% vested.

**Note G - Tax Status**

The Internal Revenue Service has determined and informed ADP Retirement Services, Inc. by a letter dated October 6, 2020 that ADP's prototype plan, which has been adopted by the Company as of January 1, 2023 is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the advisory letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note H - Risk and Uncertainties**

The Plan provides the participant with options of investing in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and the Statement of Changes in Net Assets Available for Plan Benefits.

**Note I - Subsequent Events**

Management has evaluated subsequent events through September 18, 2025, the date on which the financial statements were available to be issued.
