We have performed audits of the financial statements of Lewis PR Inc 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of the Plan

The following description of the Lewis PR Inc 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Lewis PR Inc (the Company), as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The trustee of the Plan is Reliance Trust Company (the Trustee). The recordkeeper of the Plan is ADP, LLC. The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees of the Company are considered eligible for participation, except for employees covered by a collective bargaining agreement that does not provide for participation in the Plan. Employees must be 21 years of age to participate in the Plan. An eligible participant can enter the Plan immediately after one month of service.

#### *Contributions*

Each year, participants may elect to contribute a percentage from 1% up to 87% of the participant's eligible compensation, as defined in the Plan document, up to the maximum allowable under the IRC. Participants aged 50 or older before the close of the calendar year may also elect to make additional pre-tax catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations. Participants are also allowed to make Roth contributions to the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who contribute to the Plan during the Plan year are eligible for a match contribution by the Company, which equals 100% of the first 2% of a participant's eligible compensation contributed to the Plan. The Company made matching contributions of \$211,950 in 2024.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also 100% vested in any Company matching contributions plus actual earnings thereon.

### ***Payment of Benefits***

Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive their benefit as a lump-sum amount, partial amount or in the form of installments. Unless otherwise elected, participants with vested account balances of \$1,000 or less will receive an automatic lump sum cash payout. Participants with vested account balances ranging from \$1,000 to \$5,000 may be rolled over to an individual retirement account.

Participants over age 59½ are also entitled to receive a distribution of all or any portion of their vested account balance. Retired participants also have an option of delaying the receipt of benefits. The payments for retired participants, however, are required to begin no later than April 1st following the end of year in which the participant reaches the age of 72, or 73 if they reach age 72 after December 31, 2024. The Plan also allows for hardship withdrawals.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 maximum loan amount is reduced by the highest loan balance during the past twelve months. Participants may only have one loan outstanding at any time and must have paid off any existing loan before a new loan request can be initiated. The loans are secured by the vested balance in the participant's account and bear an interest rate of the prime rate on the 14th day of the month plus 2%. Loan repayments are generally made ratably through payroll deductions over a period not to exceed five years, unless the loan is used to purchase a primary residence, in which case, the loans may be repaid over 30 years.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan totaled \$8,536 for the year ended December 31, 2024.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and the Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* - Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Plan's trustee, Reliance Trust Company. Additionally, certain fees paid by the plan for investment services performed by the Plan's trustee are included as a reduction of the return earned on each investment fund. The Plan also makes loans to participants. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## 6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

## 7. Tax Status

The Plan uses a pre-approved 401(k) and Profit-Sharing Plan sponsored by ADP, LLC, which received a favorable opinion letter from the IRS dated June 30, 2020, which states that the pre-approved plan, as then designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Delinquent Participant Contributions

During the Plan year ended December 31, 2023, the Company failed to remit certain employee deferrals and loan repayments aggregating \$1,919 on a timely basis according to Department of Labor regulations. These employee deferrals and loan repayments were remitted to the Plan during 2023 respectively. The lost earnings related to the Plan year 2023 were remitted during the 2024 Plan year.
