## **NOTES TO FINANCIAL STATEMENTS**

### **December 31, 2024 and 2023**

#### **NOTE 1 – DESCRIPTION OF PLAN**

Saratoga Harness Racing, Inc. (the “Employer” or “the Company”) established a defined contribution 401(k) retirement plan, currently known as the Kings, Queens & Jacks, LLC 401(k) Plan (the “Plan”). The following brief description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan was established January 29, 2013 and covers all employees of Kings, Queens and Jacks, LLC (a participating employer), who are eighteen (18) years of age or older and have completed three months of service (as defined by the Plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The trustee of the Plan is the Reliance Trust Company (“Reliance”) and the recordkeeper is Automatic Data Processing, Inc.’s (“ADP”) Retirement Services. Effective January 1, 2025, Reliance resigned as trustee of the Plan and ADP Retirement Trust Services, LLC was appointed as the new trustee.

#### **Contributions**

Each year, participants may contribute pretax and Roth elective deferrals of annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their and employer matching contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision through April 30, 2023, whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund unless changed by the participant. The automatic enrollment feature was eliminated effective May 1, 2023.

The Company will make a matching contribution equal to 20% of participant’s elective deferrals, up to 3% of compensation. The Company may also make discretionary profit-sharing contributions each year based on an allocation of each eligible participant’s compensation to the total compensation of all the eligible participants for the year. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollover contributions and allocations of the Employer contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s contributions, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Notes Receivable from Participants**

Participants may borrow from their 401(k) accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. A participant’s loan interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### **NOTE 1 – DESCRIPTION OF PLAN (Continued)**

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in employer matching and employer discretionary profit-sharing contributions plus actual earnings or losses thereon is based on years of continuous service. A participant is 25% vested in the employer discretionary contributions after one year of service, increasing 25% per year, with 100% vesting after four years of credited service. A participant becomes 100% vested upon termination of service due to death, normal retirement, early retirement, disability, or plan termination.

##### **Payment of Benefits**

On termination of service due to retirement, death or disability, a participant may elect to receive one of the following: a lump-sum amount equal to the value of the participant's vested interest in his or her account, flexible income payments, or an annuity over the life expectancy of the participant and/or the designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For terminated participants with a vested account balance less than \$5,000, the Plan administrator will make a distribution in a lump-sum amount. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

Withdrawals from a participant's salary deferral account (excluding earnings) may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan (minimum of \$500). Withdrawals from a participant's accounts may also be made upon reaching age 59½, in accordance with the provisions specified in the Plan (minimum of \$500).

##### **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts were \$11,029 and \$13, respectively. The Plan provides that these accounts will be used to reduce employer contributions or to pay plan expenses. During 2024 and 2023, forfeited nonvested accounts were used to fund employer contributions by \$8,005 and \$917, respectively. Additionally, during 2023, plan expenses of \$803 were paid using forfeited nonvested accounts (none in 2024).

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants is measured as their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recognized when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

The plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described as follows:

Level 1 inputs consist of unadjusted quoted prices in active markets, that the Plan has the ability to access, for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

**NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets measured at fair values:

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Fund:** Valued at the Net Asset Value (NAV) of units of a common collective trust fund. NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require one year's notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – CERTIFIED INVESTMENTS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Reliance Trust Company, the trustee of the Plan, has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications are as of and for the years ended December 31, 2024 and 2023, and include investment information related to fair value of investments, notes receivable from participants, net appreciation (depreciation) in fair value of investments, dividend and interest income, and interest income on notes receivable from participants that are included in the Plan's financial statements and supplemental schedule.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of a termination, participants would become 100% vested in their employer contributions.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Notes receivable from participants are also considered party-in-interest transactions. Party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**NOTE 7 – TAX STATUS**

The Plan has been designed using a Non-Standardized Pre-Approved prototype plan document. The Plan obtained its opinion letter dated October 6, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
