INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

YEAR ENDED DECEMBER 31, 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Entertainment Benefits Group, LLC 401(k) Profit Sharing Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan adopted by the Board of Directors of Entertainment Benefits Group, LLC (“the Plan Sponsor”) and is subject to the provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a qualified automatic contribution arrangement 401(k) plan. A qualified automatic contribution arrangement 401(k) plan is a plan designed to make safe harbor matching contributions that enable the employer to simplify plan administration by ensuring that non-discrimination regulations are met.

Eligibility

All non-excluded employees of the Plan Sponsor are eligible to participate in the Plan. For purposes of determining eligibility, the Plan excludes from participation certain designated employees. Employees who fall under any of the excluded employee categories will not be eligible to participate in the Plan. The following categories of employees are not eligible to participate in the Plan: employees covered under a collective bargaining agreement (i.e. union employees), and non-resident aliens who do not receive any compensation from U.S. sources. In order to participate in the Plan, employees must satisfy certain age and service conditions. The employee must be a minimum of eighteen years of age. An employee must also work for the Plan Sponsor for at least six consecutive months and complete at least one hour of service per month during that time period. Employees who have not worked at least one hour during their first six months of employment will satisfy the Plan’s minimum service requirement once they have completed one year of service.

Contributions

Participants may elect to contribute up to 86% of their eligible earnings, as defined by the Plan. Participants may also contribute amounts representing distributions from other plans and certain individual retirement accounts. Under Internal Revenue Service (“IRS”) Code Section 402(g)(1), the maximum deferral of pretax earnings was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023 respectively. Those participants who have attained age 50 before the end of the plan year are eligible to make an additional \$7,500 in catch-up contributions in 2024 and 2023 respectively.

Contributions (Continued)

The Plan Sponsor will make safe harbor matching contributions equal to 100% of the first 3% of a participant's eligible earnings that they elect to defer and 50% of the next 2% of a participant's eligible earnings that they elect to defer.

Participants may also elect to make Roth deferrals for the exact contribution percentages stated above, which are subject to the same Plan Sponsor match provisions.

Additional profit-sharing amounts may be contributed at the discretion of the Plan Sponsor. No discretionary contributions were made for the year ended December 31, 2024. Participants may change or terminate their salary deferral contribution amounts at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution as well as an allocation of the Plan Sponsor's contribution and Plan earnings or losses. Participant accounts are charged with certain other administrative expenses, such as loan fees, specific to each participant. Allocations of the Plan's earnings or losses in each investment option and Plan Sponsor's contributions are made to the participant's accounts based on the ratio of each participant's current account balance in each investment option to total participant's account balances in the investment option. The benefit to which a participant is entitled is the participant's vested account balance.

Forfeitures of the non-vested account balances of participants are used to reduce employer contributions. There was no material forfeitures for the year ended December 31, 2024.

Vesting

Participants are immediately vested in salary reduction contributions, transfer contributions and any safe harbor contributions, as defined by the Internal Revenue Service. Participants are vested in the non-safe harbor matching and non-elective contributions based on years of service as follows:

Notes Receivable from Participants

Participants may borrow from their account up to the lesser of 50% of the participant's vested balance or \$50,000. The minimum principal loan is \$500. Principal and interest must generally be repaid within five years. The interest rate on notes receivable from participants is the prime rate as published in the Wall Street Journal on the 14th of every month, plus two percentage points. The interest rate is effective for any loan processed as of the 16th day of the month.

Payment of Benefits

Participant contributions and the vested portion of the Plan Sponsor's matching contributions are available for distribution upon attainment of retirement age, termination of employment, disability or death. If the participant's vested account balance was less than \$5,000 at the date of the distribution, then that balance shall be distributed in a single lump-sum payment. If the participant's vested account balance was more than \$5,000 at the date of the distribution, then the participant can elect to receive a lump sum or direct rollover or choose to defer receiving payment until age 70½.

Contributions are also available for distribution in the form of a hardship withdrawal.

In the event of death, 100% of the participant's vested account balance is payable to participant's beneficiary or beneficiaries, as designated on the appropriate beneficiary election form.

If a participant becomes disabled, the participant becomes 100% vested in all accounts. Disabled is defined by the Plan as when a participant is unable to engage in any substantial gainful activity due to the disability and the disability is expected to result in death or is expected to last for a period which exceeds twelve months.

Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent net assets available for benefits at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies, which are in accordance with U.S. GAAP. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the various Reliance Trust investment options (see Note 4). Participants may change their investment options at any time.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, as the notes are collateralized by the participant's vested account balance.

As of December 31, 2024 and 2023, the interest rates on notes receivable from participants ranged from 4.25% to 10.50%. Notes receivable from participants were approximately \$157,000 and \$164,000 as of December 31, 2024 and 2023, respectively, and mature at various dates through October 2029.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative and accounting functions are performed by the Plan Sponsor's employees, who received no compensation from the Plan. Administrative expenses, such as professional fees, are paid directly by the Plan's Sponsor. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses.

Reclassifications

Certain reclassifications have been made to the prior year financial statements in order for them to be in conformity with the current year presentation.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Reliance Trust Company, (Reliance), the trustee, held the Plan's investments as of December 31, 2024 and 2023. The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 – Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by approximately \$1,725,000. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

U.S. GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual term), the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There has been no change in methodology used as of December 31, 2024.

Mutual funds and bond funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Valued at the NAV. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 6. TAX STATUS

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
