## INDEPENDENT AUDITORS' REPORT

To the Participants and Trustees of  
Western Reserve Group 401(k) Profit Sharing Plan

### Opinion

We have audited the accompanying financial statements of the Western Reserve Group 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Western Reserve Group 401(k) Profit Sharing Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

## 1. DESCRIPTION OF PLAN:

The following description of the Western Reserve Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established in 1991 for all eligible employees of Western Reserve Mutual Casualty Company, Lightning Rod Mutual Insurance Company and Sonnenberg Mutual Insurance Company, collectively known as the Western Reserve Group (the Employer), who have completed three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Participating employees may defer up to the maximum percentage allowable not to exceed the limits of the Internal Revenue Code (IRC). The Plan also provides for automatic enrollment of eligible participants at 5% of eligible compensation. Participants may elect to change contributions at any time. Participants who reach age 50 may elect to make catch-up contributions. Participants may also contribute rollover contributions representing distributions from other qualified plans. Effective January 2013, participants may also contribute Roth contributions to the plan.

The Employer elected to make an annual safe harbor matching contribution equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation contributed by the Plan participants, for the years ended December 31, 2024 and 2023. The Plan also allows for regular Employer matching contributions, however, the Employer elected not to make any such contributions during 2024 and 2023.

The Employer may make discretionary profit sharing contributions. The discretionary contributions are allocated to individual participant accounts based on the ratio of the participant's eligible compensation to the total eligible compensation of all eligible participants. The Employer made a 4.60% and a 1.00% discretionary profit sharing contribution in 2024 and 2023, respectively, amounting to \$1,093,034 and \$229,287, respectively.

### **Participant accounts**

Each participant's account is credited with the participant's contribution and allocations of the respective Employer contributions, and Plan earnings. Income of each investment fund (including appreciation and depreciation in fair value of each investment fund) is allocated daily to participant accounts based upon the ratio of each participant's account to the total of each investment fund balance.

### **Participant notes receivable**

Effective January 2015, participants may borrow from their Plan accounts under terms ranging from 1-5 years for any general purpose. The participant must be an active Plan participant with a vested balance of at least \$2,000 to be eligible. The minimum loan amount is \$1,000. The maximum loan amount is the lesser of \$50,000 minus the highest outstanding loan balance at any time during the immediate 12 month period, or 50% of the participant's vested balance. Notes are secured by the balance in the participant's Plan account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. All Employer contributions are immediately vested.

**Investment options**

All participant and Employer contributions are allocated to investments at the direction of each participant.

**Distributions**

In accordance with the Plan, a participant may receive the full value of their accounts upon normal retirement (at age 65), upon early retirement (at age 60) or upon total disability. Upon death of a participant, the participant's beneficiary shall be entitled to the full value of the participant's accounts. Distributions are made in lump sum payments, installments, or a combination of both.

A participant may elect to withdraw any or all of their vested account balance in the event of financial hardship or attainment of age 59½, subject to applicable IRC requirements. All financial hardship distributions must be approved by Western Reserve Group (the Plan Administrator).

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

The following accounting principles and practices of the Plan are set forth to facilitate the understanding of data presented in the financial statements:

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Trustee Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. The policies are approved by the Compensation Committee of the Employer's Board of Directors. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Participant notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Distributions**

Benefit distributions are recognized when paid.

**Administrative expenses**

Certain administrative expenses are borne by the Employer and are excluded from these financial statements. Fees related to participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **Risk and uncertainties**

The Plan provides various investment options in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### **Subsequent events**

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through August 19, 2025, the date the financial statements were available to be issued.

### **3. PLAN TERMINATION:**

Although they have not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the right of each participant to benefits accrued to the date of such termination or partial termination, to the extent then funded, or the rights of each participant to the amount credited to his/her account at such time, shall be fully vested and non-forfeitable.

### **4. FEDERAL INCOME TAXES:**

The Plan elected to adopt a pre-approved defined contribution plan. The Internal Revenue Service (IRS) issued an opinion letter dated September 21, 2020 indicating that the plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for federal income taxes has been included in the Plan's financial statements.

### **5. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The objective of the collective trust is stability of principal and high current income.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
