Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 20X2 Financial Statements

We have performed an audit of the financial statements of The Chimes, Inc. 401(a) Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE A –DESCRIPTION OF THE PLAN

The following description of The Chimes, Inc. 401(a) Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan that covered eligible employees of The Chimes, Inc., Chimes Metro, Inc., Chimes Virginia, Inc. and Chimes International Limited (collectively, the Company) until October 1, 2008, at which time the Plan disallowed any new participant enrollment. The Plan was organized July 1, 1998, and amended on December 31, 2008, in order to freeze contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 2, 2011, The Chimes, Inc. 401(k) Profit Sharing Plan was merged with The Chimes, Inc. Money Purchase Pension Plan and Trust and was renamed The Chimes, Inc. 401(a) Defined Contribution Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Administrator.

2. Contributions

As of December 31, 2008, the Plan disallowed new contributions by participants and employers.

3. Participant Accounts

Each participant's account is credited with the participant's allocation of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

4. Vesting

Vesting for participants is defined by the provisions of the previous plan that the participant was enrolled in prior to the merger in 2011. All participants enrolled in the Plan are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service for The Chimes, Inc. 401(a) Profit Sharing Plan. For this Plan, a participant is 100% vested after five years of credited service.

NOTE A – DESCRIPTION OF THE PLAN – Continued

5. Payments of Benefits

The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½. Vested Plan accounts are paid only in the form of a cash lump sum (except that certain special provisions apply to distribution to the Pension Plan Account), such as, Joint and 50% Survivor Annuity, Qualified Optional Survivor Annuity, Life Annuity, and Life Annuity with 120 months Certain.

6. Forfeited Accounts

Forfeited non-vested accounts totaled \$31,886 and \$12,936 as of December 31, 2024 and 2023, respectively. These accounts will be used to pay any expenses payable by the Plan. During the year ended December 31, 2024, forfeitures of \$704 were used to pay administrative expenses of the Plan.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Administrative Costs

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

3. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

5. Payment of benefits

Benefits are recorded when paid.

6. Subsequent Events

The Plan has evaluated subsequent events and transactions through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends, for the year ended December 31, 2024 was obtained or derived from information supplied by the plan administrator and certified as complete and accurate by Reliance Trust Company, the custodian of the Plan as of December 31, 2024 and 2023.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS – Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing prices as reported by the respective entities. The investments held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The investments held by the Plan are deemed to be actively traded.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. If the Plan should terminate, participants would become 100% vested in their employer contributions.

NOTE F – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

ADP, Inc. is the record-keeper as defined by the Plan, and, therefore, transactions with the Plan and ADP, Inc. qualify as party-in-interest transactions. The total paid by the Plan to ADP, Inc. for the year ended December 31, 2024 totaled \$7,368.

NOTE G – TAX STATUS

The Internal Revenue Service issued a standard prototype profit sharing opinion letter dated March 21, 2013, stating that its prototype plan document was designed in accordance with the applicable Internal Revenue Code (IRC) requirements as of that date. Although the Company has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan has not taken any uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
