### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cipriani USA, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### **1. Description of Plan**

The following brief description of Cipriani USA, Inc. (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan available to all full time employees of Cipriani USA, Inc. (the “Company” or “Employer”) and of the Participating Affiliates, as defined, in the Plan documents. The Plan is a qualified retirement plan with a salary deferral feature under the provisions of the Internal Revenue Code (“IRC”) sections 401(a) and 401(k). The Plan is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 (ERISA) and the IRC. The Plan was established on January 1, 2018.

Under the IRC, participants are not liable for federal income taxes on pre-tax employee contributions, Company contributions or Plan earnings until such time as they are partially or completely withdrawn from the Plan.

#### ***Eligibility***

All employees of the Employer and any of the Participating Affiliates are eligible for Plan participation and may enter the Plan provided that they are over 21 years of age and have completed one year of service.

#### ***Assets Held for Investment***

All Plan assets are held with Reliance Trust Company (“Reliance”). Reliance acts as the Trustee over all of the Plan’s assets. Automatic Data Processing (“ADP”) is the record-keeper of the Plan’s assets and among other duties, is responsible for the payment of benefits to eligible participants.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered by the Plan. There is no limit to how often a participant may change their investment options.

Participants should refer to each fund’s prospectus for a more complete description of the risks associated with each fund.

### 1. Description of Plan (*continued*)

#### **Contributions**

Eligible employees may contribute up to 90% of their eligible compensation, including Roth elective deferrals, as applicable, up to the annual limit determined by the IRC. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. The minimum percentage of eligible compensation a participant may elect to defer is 1%.

The Company and Plan Affiliates may make matching and nonelective contributions to the Plan, although they are not required to do so. The matching nonelective contribution will be allocated to all employees eligible to participate in the Plan based on the employees' eligible earnings. There were no matching and nonelective contributions made for the year ended December 31, 2024.

#### **Vesting**

Upon entrance into the Plan, participants are 100 percent vested in their voluntary contributions. The matching and nonelective contributions vest as follows:

Less than 2 years	0%

#### **Forfeitures**

Forfeitures of terminated participants' non-vested accounts serve to reduce Employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$0. No amounts were used from the forfeited non-vested accounts during the year ended December 31, 2024.

### 1. Description of Plan (*continued*)

#### ***Participant Accounts***

A separate account is maintained for each participant, which is credited with the participant's contribution and allocations of Employer contributions and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### ***Payment of Benefits***

Benefits are paid upon retirement, death, disability, or termination of employment. Upon termination of service, a participant who is not 100% vested will receive a distribution of the vested portion of his or her account balance. The non-vested portion of their account will be forfeited when the distribution is made. Participants who terminate employment and are 0% vested must take a distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

A participant may apply to the Plan Administrator for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant or their dependents, medical expenses to the extent not otherwise reimbursed under the Company's medical programs, expenses for the purchase of a principal residence or material alterations thereto, payments to prevent eviction from or foreclosure on a principal residence or burial or funeral expenses for the participant's parent, spouse, children or dependents.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are secured by the balance in the participant's account and bear interest as determined at the time of the loan origination. Principal and interest is paid ratably through monthly payroll deductions over a period of time not to exceed five years. If the proceeds are used to construct or rehabilitate a participant's principal residence, the Plan Administrator may permit a longer repayment term. Principal and interest repaid is reinvested based on the participant's present investment allocation selection. Delinquent participant loans are classified as distributions based upon the terms of the Plan document.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, all amounts credited to participant accounts shall become fully vested and non-forfeitable. Accordingly, assets will be distributed to the participants and beneficiaries in proportion to their respective account balances.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), using the accrual basis of accounting, which recognizes revenue when it is earned and expenses as they are incurred.

#### ***Use of Estimates***

In conformity with US GAAP, the Plan's management makes estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent net assets available for benefits at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the period. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments that were valued at fair value, were valued using level 1 inputs and consisted solely of mutual funds.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well those held at the end of the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are classified as distributions based upon the terms of the Plan agreement.

### **2. Summary of Significant Accounting Policies (*continued*)**

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

With the exception of the Plan's recordkeeping fees expenses related to the notes receivable from participants (setup and maintenance fees) which are charged to the individual participant's account, all other administrative expenses incurred by the Plan are paid by the Company.

Expenses relating to investment management are paid directly by the respective investment vehicle and are included in net appreciation in fair value of investments.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, dividend and interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, a qualified institution.

### **4. Tax Status**

The IRS issued an opinion letter to the prototype plan document preparer, Reliance, dated October 6, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

### **5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
