## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor of the

### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed an audit of the financial statements of Plaza Motors Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

### Opinion

- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**



**NOTE A: DESCRIPTION OF PLAN**

The following description of Plaza Motors Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General.***

Plaza Motors Inc. (the Plan Sponsor) established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Plan Sponsor as defined by the Plan document who have completed at least three months of service are eligible to enroll. Employees actively elect to participate or not participate in the Plan. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions.***

Participants may contribute between 1% and 90% of eligible compensation, as defined in the Plan, as pretax or Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1% of eligible compensation. The Plan Sponsor contributes 100% of the participant contributions up to the first 1% of eligible compensation that a participant contributes to the Plan. Participants direct the investment of all contributions and are automatically invested in a designated balanced fund until changed by the participant. The Plan currently offers various mutual funds as investment options for participants.

***Participant Accounts.***

Each participant's account is credited with the participant's contributions, allocation of the Plan Sponsor's matching contributions, the Plan earnings (losses), and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

***Vesting.***

Participants are immediately vested in their contributions and the employer match contribution plus actual earnings thereon.

***Investment Options.***

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Plan Sponsor's contributions into various mutual funds offered by the Plan.

***Payment of Benefits.***

Upon termination, retirement, disability or death, a participant or beneficiary may elect to receive a distribution of the amount equal to the value of the participant's vested interest in his or her account in either a lump sum, equal installments, partial withdrawals or as a direct rollover to another eligible retirement plan.

Participants who are still active employees may elect to receive an in-service distribution upon attaining the age of 59 ½ or through a hardship withdrawal.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$397 respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$397 from forfeited nonvested accounts.

***Notes Receivable from Participants.***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest of the Prime Rate plus 2%.

**NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting.***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value.

***Use of Accounting Estimates.***

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition.***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants.***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Excess Contributions Payable.***

Amounts payable to participants totaling \$12,030 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2024 contributions. The Plan distributed the 2024 excess contributions prior to the March 15, 2025. There were \$32,875 in excess contributions for the year ended December 31, 2023.

***Payments of Benefits.***

Benefits are recorded when paid.

***Expenses.***

Certain expenses for administering the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value investments. Fees for the administration of notes receivable from the participants are included in administrative expenses and charged directed to the participant's account.

**NOTE C: FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels; Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

**NOTE F: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**NOTE G: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE H: TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Organization by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue code (IRC). Although the plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are not uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by tax authorities: however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**NOTE I: EVALUATION OF SUBSEQUENT EVENTS**

For the year ended December 31, 2024, the Plan has evaluated subsequent events for potential recognition and disclosure through October 2, 2025 the date of financial statement issuance.
