## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Magnolia Personnel Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of Plan

The following description of the Magnolia Personnel Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan covering eligible employees of Magnolia Personnel Group, LLC (the “Plan Sponsor”) and its affiliated company, Blind Nil, LLC (collectively, the “Company”) who are age 21 and older. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

#### (b) Contributions

Each year, participants may contribute up to the maximum amount allowable as determined by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a safe harbor matching contribution as follows: the Company matches participant deferrals at 100% of the first 4% of compensation, plus 50% of participant deferrals that exceed 4% up to a maximum of 6% of compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company’s board of directors. During the years ended December 31, 2024 and 2023, the Company did not make additional profit sharing contributions to the Plan. Contributions are subject to certain IRS limitations.

#### (c) Participant Accounts

Each participant’s account is credited with the participant's contributions and the Company’s safe harbor matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## Magnolia Personnel Group 401(k) Plan

### Notes to Financial Statements (Continued)

(1) Description of Plan (continued)

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Employer safe harbor matching contributions are 100% vested immediately to the participant. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is fully vested after five years of credited service. Full vesting in employer contributions also occurs upon death, disability or retirement at or after age sixty-five.

(e) Notes Receivable from Participants

Participants may borrow from the vested portion of their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan terms generally may not exceed five years. The loans are secured by the participant's account and bear interest at a rate determined by the plan administrator. The loan interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably by payroll deductions.

(f) Payment of Benefits

The Plan provides that distributions of amounts of \$5,000 or less be paid as a lump-sum. For account balances greater than \$5,000, on termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or various installment options over extended periods of time.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit responsive investment contracts, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of investments held by the Plan and fair value measurements.

### Notes to Financial Statements (Continued)

#### (2) Summary of Significant Accounting Policies (continued)

##### (b) Investment Valuation and Income Recognition (continued)

Investments are reported at fair value, except for the fully benefit responsive investment contracts, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of investments held by the Plan and fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### (c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### (d) Payment of Benefits

Benefits are recorded when paid.

##### (e) Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### (f) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgement occurs.

#### (2) Summary of Significant Accounting Policies (continued)

##### (g) Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### (3) Information Certified by the Custodian

For 2024 and 2023, the financial information included in the Plan's financial statements, except for contribution receivables, contributions, benefits paid to participants and administrative expenses, has been derived from information certified as complete and accurate by Empower Trust Company LLC, the custodian of the Plan, in accordance with Section 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### (4) Investments and Fair Value Measurements

The Plan invests in mutual funds and an unallocated investment contract with Empower Annuity Insurance Company of America ("EAICA").

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The following methods and assumptions were used to estimate the fair value of the mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan invests in mutual funds and an unallocated investment contract with EAICA. The following methods and assumptions were used to report the values of the unallocated investment contract, the EI Fixed Account – Series Class I or the “fixed account”. This unallocated investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The fixed account guarantees a credited rate of return that is adjusted quarterly based on current market conditions and performance of the fund's investments, but may not be less than 1%.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is set quarterly by the issuer and is effective on the first day of the quarter. The Plan must provide a 30-day advance notice of its intent to withdraw from the investment. If the Plan ends its participation in the fixed account, it will

receive the Plan's fair value as surrender value. Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs) that cause a significant withdrawal from the plan, or (c) the failure of the fixed account to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### (5) Tax Status

The Plan is using a non-standardized prototype profit-sharing plan document. In a letter dated June 2, 2021, the Internal Revenue Service ("IRS") indicated the standardized form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code section 401(a). Although the Plan has been amended since receiving the acceptability letter, the Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

#### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### (7) Parties-In-Interest Transactions

As more fully described in Note 4, the Plan invests in an unallocated investment contract with Empower Annuity Insurance Company of America ("EAICA"). Empower Trust Company, LLC, and Empower Retirement, LLC, affiliates of EAICA, (collectively, "Empower") serve as the custodian and recordkeeper for the Plan, respectively, and these entities qualify as parties-in-interest. Fees paid by the Plan for investment management and other services to Empower for the year ended December 31, 2024 and 2023 amounted to \$48,009 and \$44,649, respectively.

(8) Risks and Uncertainties

The Plan investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
