## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Summa Group Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Summa Group Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Summa Group Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

#### 1. DESCRIPTION OF THE PLAN

The following description of Summa Group Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions.

##### **General**

The Plan is a qualified retirement plan generally covering all eligible employees of Summa Group, LLC and subsidiaries (collectively, the “Employer”). The Plan was originally effective January 1, 2019, and amended effective December 31, 2022, to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Charles Schwab Trust Bank serves as the trustee of the Plan. The trustee receives contributions, holds and invests fund assets, and makes distributions to participants. BOK Financial Asset Management, Inc. maintains the participants’ account balances and provides recordkeeping services to the Plan.

##### **Eligibility and Service**

The Plan allows participation upon becoming eligible to all employees except union employees, leased employees, and non-resident aliens. The minimum age for participation is 21 and employees are required to complete a minimum of one year of eligibility service or 1,000 hours of service. Employees electing to participate in the Plan upon meeting eligibility requirements will become a participant of the Plan for all contribution types allowed by the Plan on the first day of the month following the date that eligibility requirements are met.

##### **Participants and Employer Contributions**

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (“IRC”). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants age 50 or over may also defer additional amounts as catch-up contributions. Participants may elect to start, increase, reduce, or totally suspend their elections at any time.

The Employer may, in its sole discretion, make a matching contribution on each participants’ behalf. For 2024, the Employer made matching contributions equal to 50% of the first 6% of each participant’s eligible compensation contributed to the Plan.

The Plan also accepts rollover contributions from eligible employees that represent distributions from other qualified retirements plans and certain IRAs.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, rollover contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their account balances in any of several investment securities. Participants can change their investment allocation among the various securities either through direct transfers from one option to another or by changing the percentage allocation of future contributions.

#### **Vesting**

Participants are immediately vested in their elective deferral contributions, rollover contributions, and actual plan earnings thereon. Employer contributions vest equally over a five year graded vesting schedule, starting after one year of completed vesting service.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. Notes receivable from participants are secured by the participant's account balance and bear interest at a reasonable rate. All notes require that repayment be amortized in level payments, not less than quarterly, over a period not extending beyond five years from the date of the note or fifteen years if the note is for the purchase of a principal residence.

#### **Benefit Payments**

Participants are entitled to receive a distribution from their accounts after they terminate employment. Distributions are in the form of single lump sum payments. In-service withdrawals are permitted when a participant reaches age 59½ or in the event of immediate and heavy financial need as a hardship distribution.

#### **Forfeitures**

Forfeitures result from non-vested employer contributions remaining in the Plan from terminated participants. Forfeitures may be used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,093 and \$44,661, respectively. Also, in 2024, the Employer utilized \$57,538 from forfeited non-vested accounts to pay plan expenses.

#### **Plan Termination**

Although the Employer intends to maintain the Plan indefinitely, the Employer may terminate the Plan at any time in its sole discretion. If the Plan is terminated, all amounts credited to participants' accounts will become 100% vested.

## **2. SUMMARY OF ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Employer to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### **3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable for the year ended December 31, 2024, was obtained by the Employer and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Funds:* Valued at the daily closing price as reported by the fund. The money market funds are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The money market funds are deemed to be actively traded.

**5. TAX STATUS**

The Employer adopted a pre-approved plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the pre-approved plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Employer believes that the Plan is designed, and is currently being operated, in compliance within the applicable requirements of the IRC and was tax-exempt as of December 31, 2024 and 2023.

GAAP requires the Employer to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Charles Schwab. Charles Schwab is the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
