Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Arnoff Moving & Storage, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Arnoff Moving & Storage, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.





Opinion

Note 1 Plan Description

The following description of the Arnoff Moving & Storage, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the participating companies, as listed below, who have attained age nineteen and have completed six months of service. The Plan allows automatic entry of new employees into the Plan on a rolling basis upon meeting the service and age requirements. The following companies (collectively referred to as the “Company”) participate in the Plan: Arnoff Moving & Storage, Inc.; Arnoff Moving and Storage of Albany, Inc.; Arnoff Storage, Inc.; and Arnoff-Stewart Liner Transportation Corp. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants in the Plan may contribute up to 90% of their annual compensation as defined by the Plan Document, subject to annual statutory limits determined by the Internal Revenue Code (“IRC”), through pre-tax 401(k) or Roth 401(k) salary reductions. Upon meeting the service and age requirements, eligible employees will automatically have 4% of compensation (as defined by the Plan Document) contributed to the Plan unless otherwise elected. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with provisions of the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan. Automatically enrolled participants have their deferral amounts and other contributions invested in a designated balanced fund until changed by the participant.

The Company may make a discretionary matching contribution equal to a uniform percentage of participant salary deferrals. Each year, the Company will determine the amount of the discretionary percentage. Participants must have attained age nineteen and have completed one year of service to receive the matching contribution. Participants who are not employed at the end of the Plan year will not share in the allocation of the matching contribution, regardless of service. No matching contribution was made for the years ended December 31, 2024 and 2023.

Additionally, each year, the Company may make a discretionary profit-sharing contribution to the Plan. Participants must have attained age nineteen and have completed one year of service (1,000 hours of service during the Plan year) to receive the profit-sharing contribution. Participants who are not employed at the end of the Plan year will not share in the allocation of the profit-sharing contribution, regardless of service. For the each of the years ended December 31, 2024 and 2023, the Company made a profit-sharing contribution of \$130,000 and \$117,000, respectively, to the Plan, less forfeited balances in the amount of \$5,020 and \$8,572, respectively.

Note 1 Plan Description (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as employer discretionary matching and profit-sharing contributions, and Plan earnings or losses net of investment expenses. Participant accounts are charged with direct expenses and an allocation of certain Plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary reduction contributions and rollover accounts plus actual earnings thereon. Participants are vested in the Company's discretionary matching contribution and discretionary profit-sharing contribution based on years of service. Such contributions, if any, vest in accordance with the Plan's vesting schedule. Regarding the Company's discretionary matching contribution, participants are 20% vested after two years of service and vest 20% each year thereafter with 100% vesting after six years of service. Regarding the Company's discretionary profit-sharing contribution, a participant is fully vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Participants may have a maximum of two loans outstanding at any time. Loan terms range from one to five years, however if the loan is for the purchase of a principal residence, the plan administrator may permit a longer repayment term. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent, which is fixed at the time of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account, a partial withdrawal, or in installments over a period not greater than the participant's or the participant's beneficiary's assumed life expectancy determined at the time of distribution. Participants are eligible for in-service distributions from their 401(k) and profit-sharing accounts upon attaining the age of 59½ years. In the event of a serious financial hardship, participants may withdraw a portion of their participant accounts not to exceed the amount required to meet the immediate need.

Forfeited Accounts

Forfeited non-vested account balances may be applied to reduce future employer contributions or to pay administrative expenses. For the years ended December 31, 2024 and 2023, unallocated forfeited non-vested amounts totaled \$7,681 and \$7,703, respectively.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Accounting Methods

Net assets available for benefits and changes in net assets available for benefits differ from that reported on the Internal Revenue Service (“IRS”) Form 5500, *Annual Return/Report of Employee Benefit Plans*. This difference is the result of using the cash basis for governmental reporting purposes and the accrual basis for financial reporting purposes. See Note 9 for a reconciliation of the financial statements to Form 5500.

Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the years.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as charges to participant accounts. If a participant ceases to make scheduled loan repayments, the plan administrator may deem the participant’s loan to be in default and the participant’s loan balance may be reduced, with a benefit payment recorded.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of certain participant account transactions are charged directly to the respective accounts and are included in administrative expenses. Investment-related expenses are included in the net appreciation in fair value of investments.

Note 3 Information Certified by the Plan’s Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee of the Plan, Reliance Trust Company.

Note 4 Fair Value Measurement

The Financial Accounting Standards Board’s (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 4 Fair Value Measurement (continued)

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the Fund. Mutual funds held by the Plan are open-end mutual funds that are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Tax Status

The Plan is an adoption of the ADP, LLC Non-Standardized Defined Contribution Pre-Approved Plan for which the IRS has determined and informed ADP, LLC by an opinion letter dated October 6, 2020, that the Pre-Approved Plan was designed in accordance with the provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 5 Tax Status (continued)

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balance. The net assets of the Plan will be allocated as prescribed by ERISA and regulations, pursuant thereto.

Note 8 Party-in-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees are paid from the Plan's assets and therefore qualify as party-in-interest transactions. Certain Plan investments are shares of mutual funds managed by Reliance Trust Company. Reliance Trust Company is the Trustee and ADP is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. If the revenue received by ADP for investment management services from mutual funds exceeds the fees due under the Master Plan Services Agreement between the sponsor and ADP, ADP remits the excess to the Plan's trust. Those amounts may be applied to pay Plan administrative expenses or allocated to participant accounts.

The Plan makes loans to participants and therefore, these transactions qualify as party-in-interest transactions.

Note 9 Reconciliation of Financial Statements to IRS Form 5500

Differences result from the use of the accrual basis for recognition of employer and employee contributions receivable for the financial statements, versus the use of the cash basis for recognition of this item in the governmental Form 5500, Schedule H. A difference also resulted from the use of tax reporting methods for recognition of loan defaults versus the use of the accrual basis to recognize participant loan defaults in the financial statements.

Note 10 Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.
