Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Cozen O'Connor Cash Balance Plan B (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Cozen O'Connor Cash Balance Plan B (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined benefit plan, which was effective January 1, 2021. The Plan provides benefits under a cash balance formula to each Eligible Employee (Shareholder, Senior Counsel, Managing Director, Chief Operating Officer, Chief Marketing Officer or Chief Operating Officer Ancillary Business Units/Chief Innovation Officer) of Cozen O'Connor (the "Firm" or "Plan Sponsor"), who have met the eligibility requirements.

General

The Plan intends to qualify as a defined benefit pension plan in accordance with section 401(a) of the Internal Revenue Code of 1986, as amended ("IRC"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Description of Provisions

Participation

Eligible Employees who are actively providing service for the firm on or after December 31, 2021, shall become a Participant as of the later of the effective date and the date of hire. Thereafter, an Eligible Employee shall become a participant following the later of (i) the attainment of age 21 and 30 days of employment or (ii) the date the employee becomes a member of the class of eligible employees.

Normal Retirement Age

Normal Retirement Age as defined by the Plan is the attainment of age 62.

Vesting

Participants in the Plan become fully vested in the benefit under the Plan upon the completion of three years of service, attainment of Normal Retirement Age, disability, or death. If a non-vested participant terminates service with the Firm (other than by death, disability or attainment of the normal retirement age), the participant shall forfeit his or her account balance.

Payment of Benefits

A participant's accrued benefit is straight life annuity or, for married participants, a qualified joint and survivor annuity ("QJSA") beginning on his or her Normal Retirement Date, which is equal to the actuarial equivalent annuity value of the participant's cash balance account plus interest credits from the date of determination until his or her Normal Retirement Date. If a participant continues employment beyond his or her 62nd birthday, he or she will be entitled to receive the greater of (1) the cash balance account as of his or her postponed retirement date, or (2) the actuarial equivalent of his or her accrued benefits as of the date that benefits are no longer suspended, plus the actuarial equivalent of additional cash balance credits, if any, and reduced by the actuarial equivalent of any cash balance account commenced or distributed.

A participant may elect to receive a distribution in the form of a lump-sum distribution, which is equal to the participant's cash balance account. If a participant is married on the annuity starting date, he or she may elect, without his or her spouse's consent, to receive his or her plan benefit under either a QJSA or qualified option survivor annuity ("QOSA").

Subject to certain maximums, a participant who remains in service after attaining age 59½ may elect to commence payments.

Death Benefits

Participants who die after they are vested while performing service for the Firm, or after terminating service with the Firm with a deferred vested benefit, are entitled to death benefits, which are payable to a surviving eligible spouse or designated beneficiaries. Participants who die after commencing their Plan benefits may or may not receive death benefits, depending upon which type of benefit payment they elected.

Cash Balance Credits and Interest Credits

Under the Plan, all eligible participants are credited, at the end of each Plan year, with cash balance credits and interest credits. Cash balance credits are based on the Formula Credit Amount as defined in the Plan document, which is primarily based on each participant's points and a percentage of each participant's supplemental bonus, as defined in the Plan document. Interest credits are equal to the rate of return on Plan assets not to exceed a cumulative annual rate of 6%.

Administration

Eligible Employees and employees of the Firm provide services to the Plan. Neither these individuals nor the Firm receives any compensation from the Plan. Substantially all administrative expenses including investment manager, actuarial, legal and accounting fees are paid by the Firm. No administrative expenses were incurred during 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") as applied to employee benefit plans, and in accordance with the Plan document.

Use of Estimates

The preparation of financial statements, in conformity with U.S. GAAP requires management to make estimates and assumptions in determining the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits. Actual results may differ significantly from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). Plan management determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan Administrator may be reimbursed for reasonable expenses properly and actually incurred in the performance of its duties in the administration of the Plan. However, the Firm will not be reimbursed by the Plan for any administrative expenses that were incurred during 2024.

NOTE 3 - FUNDING POLICY

The Firm makes contributions to the Plan sufficient to provide the Plan with assets necessary to pay pension benefits to Plan participants.

The Firm's funding policy is to make annual contributions to the Plan in amounts that are estimated to meet the minimum funding requirements of ERISA. For the Plan years ended December 31, 2024 and 2023, the Firm made contributions of \$7,643,252 and \$7,301,926, respectively, which were funded subsequent to year end. Minimum funding requirements under ERISA were satisfied.

NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, U.S. Bank National Association, the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and accrued interest as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.
- Schedule H, line 4j - schedule of reportable transactions for the year ended December 31, 2024.

NOTE 5 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable pricing inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets; and

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment company: The Plan invests in one money market fund that is valued at the net asset value ("NAV") of shares held by the Plan at year end based upon quoted market prices on nationally recognized exchanges (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investment measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

NOTE 6 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the provisions of the Plan, to the service Eligible Employees have rendered. Accumulated plan benefits include the benefits expected to be paid to: (a) retired or terminated Eligible Employees or their beneficiaries; (b) beneficiaries of Eligible Employees who have died; and (c) present Eligible Employees or their beneficiaries.

The accumulated plan benefits, for participants, are based on the cash balance accounts as of the valuation date. Benefits payable under all circumstances - retirement, death, and vested termination of employment - are included to the extent they are deemed attributable to Eligible Employee service rendered to the valuation date. The maximum amount of annual benefit payable at normal retirement age was \$275,000 and \$265,000 for the Plan years ended December 31, 2024 and 2023, respectively, pursuant to the IRC Section 415(b). The traditional unit credit actuarial cost method is currently being used by the Plan.

The actuarial present value of accumulated plan benefits is determined by an actuary and is that amount, which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, withdrawal, or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits was made as of January 1, 2024 and 2023. Had the valuations been performed as of December 31, there would be no material difference.

The actuarial assumptions used in the valuations at January 1, 2024 and 2023 are as follows:

Assumed rate of return on investments	1.5%
Retirement age	62
Form of payment	100% are assumed to elect a lump-sum form of payment

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

NOTE 7 - TAX STATUS

The Plan obtained a determination letter from the Internal Revenue Service ("IRS") dated August 10, 2023, stating that the Plan is designed in accordance with applicable provisions of the IRC. The Plan has been amended since receiving the determination letter. The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

Plan contributions are made and the actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

The Plan invests in one investment security, a money market fund. The investment security is exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with the investment security, it is at least reasonably possible that changes in the values of the investment security will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right, under the Plan, to discontinue or terminate the Plan subject to the provisions of ERISA. Whether all participants receive their benefits should the Plan terminate at some future time will depend on both the priority of those benefits and the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Firm and the level of benefits guaranteed by the Pension Benefit Guaranty Corporation ("PBGC").

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and as follows, but not in excess of the benefit insured by the PBGC:

- First to each participant, spouse and beneficiary who was receiving retirement income or who was eligible to receive retirement income at least three years prior to the date of Plan termination, an amount which will provide the amount of retirement income then accrued under the Plan.
- Second to each participant, spouse and beneficiary who was receiving retirement income or who was eligible to receive retirement income on the date of the Plan's termination an amount which will provide the amount of retirement income then accrued under the Plan.
- There shall next be credited to each other participant who, on the date of Plan termination, is eligible for postposed retirement income an amount which will provide for him or her the amount of the retirement income then accrued to him or her under the Plan.
- There shall next be credited to each other participant who would be entitled to additional retirement income in accordance with the first three provisions above, an amount which will provide for him or her the amount of retirement income then accrued under the Plan.
- There shall next be credited to each other participant an amount which will provide for him or her the amount of retirement income then accrued to him or her under the Plan.

Allocation in any of the above classes shall be adjusted for any allocation made to the same participant under a prior class.

NOTE 10 - PARTY-IN-INTEREST TRANSACTIONS

The Plan investment in a registered investment company fund managed by an affiliate of U.S. Bank, the trustee of the Plan. This qualifies as a party-in-interest transaction, which are exempt from the prohibited transaction rules.

NOTE 11 - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 14, 2025 the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

VESTING

Each participant is 100% vested in his or her Cash Balance Account upon completion of three years of service, attainment of Normal Retirement Age, disability, or death.

STATUTORY LIMITS

For 2024, the maximum compensation limit under IRC section 401(a)(17) is \$345,000, and the maximum benefit payable under IRC section 415(b) is \$275,000.
