NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the PBS PEO Services, LLC Retirement Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a multiple employer 401(k) defined contribution plan established by PBS PEO Services, LLC with an effective date of January 1, 2017, and is intended to provide participants with future retirement benefits. The Plan covers substantially all employees of the adopting employers who have met minimum service and age requirements as defined by the participation agreement of each adopting employer. Service requirements range from three to six months and/or 250 hours. Minimum age requirements range from 18 – 21 years of age. Generally, an employee enters the Plan on the first day of the calendar quarter coincident with or next following the completion of the service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

CONTRIBUTIONS

Participants may contribute a portion of annual compensation, as defined in the Plan, up to an established Internal Revenue Service maximum of \$23,000 and \$22,500 for the years 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants in the Plan who have obtained age 59 ½ by the end of the Plan year may defer additional amounts. The additional amount of these contributions is limited to \$7,500 for the years 2024 and 2023.

Certain highly compensated employees may have their contribution reduced under technical Internal Revenue Service guidelines.

Employer contributions are defined in the participation agreement of each adopting employer and may include:

- Safe-harbor match provision calculated at 100% of deferrals not in excess of 3% of eligible compensation plus 50% of deferrals between 3% - 5% of eligible compensation. The safe-harbor match contribution is 100% vested.
- Qualified non-elective contribution provision calculated at not less than 3% of the eligible compensation. The qualified non-elective contribution is 100% vested.
- Defined match provision calculated at 100% of deferrals not in excess of 4% of eligible compensation.

- Discretionary match provision to be determined annually.
- Discretionary profit sharing contribution to be determined annually.

Depending on the participation agreement of each adopting employer, a participant may be required to be employed on the last day of the plan year and/or work 1,000 hours during the year in order to share in the employer contribution.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Participant accounts are charged with administrative expenses related to specific participant transactions. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service as follows:

6 years	100%

The Plan provides that participants who die or become disabled while employed will become 100% vested.

FORFEITED ACCOUNTS

Forfeitures may be used to restore forfeitures, pay plan expenses, or reduce the employer contribution. During the year ended December 31, 2024, forfeitures of \$523 were used to reduce employer contributions. At December 31, 2024 and 2023, there were forfeited nonvested amounts of \$1,149 and \$524, respectively.

INVESTMENT OPTIONS

Participants may direct contributions, including employer contributions, into any investment option provided by the Plan. Participants may change their investment options daily. The Plan provides for investments in registered investment companies (e.g., mutual funds) and a guaranteed investment contract.

NOTES RECEIVABLES FROM PARTICIPANTS

Certain adopting employers permit participants to borrow against their Plan account balances. The maximum amount that may be borrowed is the lesser of (1) 50% of the non-forfeitable account balance or, if greater the total vested account balance up to \$10,000, or (2) \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. Unless used for the purchase of a principal residence, the loan must be repaid over a five year period. Use of the loan for the purchase of a principal residence allows for an extended repayment term of fifteen years. Loans of \$60,953 were outstanding at December 31, 2023, and bore interest between 4.25% to 9.5%. There were no loans outstanding at December 31, 2024.

PAYMENT OF BENEFITS

The Plan provides retirement benefits for employees who have reached age sixty-five. For terminated employees, participants may elect to receive a lump sum payment equal to the value of the vested interest in the participant's account. In-service distributions are allowed for a participant who has not separated from service and has either attained age 59 ½ or reached the normal retirement age of 65. Upon total disability or death of a participant, the Plan provides for distribution of a participant's account balance to the participant or beneficiary.

The amount of a participant's benefit is limited to the individual's account balance, which is composed of the participant's contributions to the Plan, employer contributions, and allocated income of the Plan.

HARDSHIP WITHDRAWALS

Withdrawal of a portion of a participant's account will be permitted due to an immediate and heavy financial need if Internal Revenue Service requirements are met.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accounting records of the Plan are maintained on the accrual basis for financial reporting purposes, except for benefits, which are recorded when paid.

ACCOUNTING PERIOD

The Plan Administrator has elected a calendar year ending December 31.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's dividends, interest and realized and unrealized gains and losses on the Plan's investments during the year.

PARTICIPANT NOTES RECEIVABLE

Participant notes receivable are recorded at the unpaid principal balances plus any accrued interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan is reduced and a benefit is recorded.

EXEMPT PARTY-IN-INTEREST TRANSACTIONS

All of the Plan's investments are managed and valued by Transamerica Financial Life Insurance Company, Inc. Thus, all investment transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts. Such loans are secured by the vested balances in the participant accounts. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures, of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

ADMINISTRATIVE EXPENSES

Certain expenses of administering the Plan are paid by the plan sponsor and therefore, are not included in the Plan expenses. For the year ended December 31, 2024, the adopting employers paid administrative fees of \$17,495 on behalf of the PBS PEO Services, LLC Retirement Plan.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

DATE OF MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Valuation based on quoted prices for identical assets and liabilities in active markets.

Level 2 – Valuation based on observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively trade.

NOTE 4 – GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company. The guaranteed investment contract issuers were contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Transamerica Financial Life Insurance Company, Inc., represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting rate is set semi-annually on January 1<sup>st</sup> and July 1<sup>st</sup>, and ranged from .75% to 1.65% for the year ended December 31, 2024, and from 0.75% to 1.10% for the year ended December 31, 2023.

NOTE 4 – GUARANTEED INVESTMENT CONTRACT (Continued)

Certain events limit the Plan's ability to transact at contract value with each individual contract. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

NOTE 5 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEES

The Plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, Transamerica Financial Life Insurance Company, Inc., determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments at fair value, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investments at contract value, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Non-interest bearing cash, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, which includes the net appreciation in fair value of investments and participant loan interest, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

In addition, the schedule of assets held at December 31, 2024, has been prepared from information certified by the trustee.

Accordingly, as requested by the plan administrator, the Plan's auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and schedule of assets held at end of year.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 – TAX STATUS

The Plan has adopted the Benefit Professionals, Inc. Pre-Approved Profit-Sharing Plan. The Internal Revenue Service informed Benefit Professionals, Inc. by letter dated June 30, 2020, that its plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – PLAN TRANSFER

During the year ended December 31, 2024, many of the participating employers elected to terminate their contracts with the Plan Sponsor and effect a transfer of approximately \$2,200,000 of Plan assets to a separate retirement Plan maintained by a related Plan Sponsor. This transaction resulted in a significant decrease in plan assets for the year. The transfer was made pursuant to Section 414(l) of the Internal Revenue Code, and participant account balances were transferred at fair value or contract value.
