Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Community Health Center of Central Wyoming 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

1. Description of Plan:

The following description of The Community Health Center of Central Wyoming 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all eligible employees of The Community Health Center of Central Wyoming, Inc. (the Organization). Eligible employees exclude employees who normally work less than 20 hours per week. Eligible employees may opt to participate in elective deferral contributions immediately upon employment. Eligible employees become eligible for employer contributions after completion of 500 hours of service in the first six months after their employment date and attaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Board of Directors is also responsible for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions – Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined by the Plan and subject to limitations established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants are also eligible to make Roth contributions. The Roth contribution to the Plan is made on an after-tax basis.

Nonelective contributions to the Plan are made by the Organization each pay period in an amount equal to 4 percent of each eligible participant's compensation, as defined by the plan document. Should an eligible employee contribute to the Plan, the Organization will match 100 percent of the first 2 percent of the eligible participant's compensation. The maximum contribution by the plan sponsor will not exceed 6 percent of an eligible participant's compensation. Contributions are subject to certain IRS limitations.

Participant accounts – Each participant's account is credited with the Organization's and participant's contributions, as well as allocations of the plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options – The Plan is a participant-directed plan. Upon enrollment in the Plan, a participant may direct employee contributions and employer contributions in 1 percent increments in any of the investment options as made available and determined by the plan administrator. Participants may change their investment options at any time. The Plan currently offers variable annuities and an investment contract as investment options.

1. Description of Plan (continued):

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. All eligible employees hired prior to January 1, 2011, are 100 percent vested in their account balances. Effective January 1, 2011, vesting in the Organization’s contribution portion of their account balance is based on years of continuous service. A participant is 100 percent vested after five plan years of credited service, reaching age 65, or upon death or disability prior to termination of service.

Benefit payments – On termination of service due to death, disability, retirement, or termination of service for other reasons, a participant is entitled to 100 percent of their account on their severance from service date. The distribution method depends on the account balance and the marital status and elections made by the participant. If the participant’s benefit in the Plan is \$5,000 or less, the plan administrator will distribute the vested account balance. For terminated participants who have not made a payout election and whose account balance is \$1,000 or less, the account balance will be involuntarily distributed in a single lump-sum payment. For account balances between \$1,000 and \$5,000, the account balance will be rolled over to an individual retirement plan designated by the plan administrator.

If the account balance is more than \$5,000, the distribution method depends on the marital status of the participant. If the participant is married on the date benefits begin, the participant will automatically receive a joint and 50 percent survivor annuity, unless an alternative form of payment is elected. If the participant is not married on the date benefits begin, the participant will receive a life annuity, unless an alternative form of payment is elected. If the annuity form of payment is waived, a participant can elect to have their benefit payment in a single lump-sum payment. The participant may also elect to rollover a distribution to another retirement plan if the account balance is more than \$200.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,949 and \$46,106, respectively. These accounts will be used to reduce future administrative expenses and employer contributions. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$71,386 and \$48,646 from forfeited nonvested accounts, respectively.

Plan termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, no further contributions will be made to the Plan, and the plan custodians will distribute the plan funds to the plan participants.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Administrative expenses – Certain administrative expenses are paid by the plan sponsor as provided in the plan document.

Subsequent events – The plan sponsor has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

3. Certification of Investment Information:

Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the custodians of the Plan, have supplied the plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024.

4. Fair Value Measurements:

Financial Accounting Standards Board (FASB) *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

4. Fair Value Measurements (continued):

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Variable annuities – Valued at the net asset value (NAV) of the units of the fund. The NAV has readily determinable fair value based on the fair value of the underlying mutual fund investments held by the fund less its liabilities. Unit values are calculated from the daily NAV using quoted market prices from an active market and using the number of shares held by the funds at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Traditional Investment Contract:

Group Variable Annuity Contract – The Plan has a group variable annuity contract with Empower Annuity Insurance Company of America that is classified as a traditional investment contract – the Insurance Company General Account (General Account). The contract meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The following table sets forth the Plan’s assets at contract value:

FASB Update 2009-12, *Fair Value Measurements and Disclosures* (Topic 820): *Investments in Certain Entities that Calculate Net Asset Value Per Share* (or its equivalent) require disclosures of certain attributes in entities that calculate NAV per share (or its equivalent) and do not have a readily determinable fair value.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, transfers to competing plan investment options, as defined within the investment contract, are not allowed. In addition, the contract does not allow transfers if the amount of any transfer from the General Account value of a participant’s account in any contract year exceeds 1/6th of the General Account values under the contract as of the end of the preceding contract year, unless consented to. This restriction does not apply to benefit payments. Currently, none of the participants’ accounts exceed the amount indicated.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer.

Examples of such events include the following:

- The Plan’s failure to qualify under Section 403(b) of the Internal Revenue Code (IRC) or the failure of the plan sponsor to be tax-exempt under Section 501(c)(3) of the IRC.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan’s prohibition on competing investment options.
- Bankruptcy of the Organization or other Organization events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

5. Traditional Investment Contract (continued):

Specific to the traditional investment contract held by the Plan, payment of the General Account after contract termination will result in payment of the net surrender value in the General Account in six equal installments plus interest, annually over a period of five years. The first installment will be paid within 30 days after the date of termination.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan has a concentration of investments in BlackRock Lifepath Dynamic 2040 Investor A, BlackRock Lifepath Dynamic 2050 Investor A, and American Funds Growth Fund of America. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of Plan's investments at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk, because the funds are invested at the direction of a single fund manager. At December 31, 2024, BlackRock Lifepath Dynamic 2040 Investor A, BlackRock Lifepath Dynamic 2050 Investor A, and American Funds Growth Fund of America each individually represented greater than 10 percent of the Plan's investments at fair value.

7. Party-in-interest Transactions:

The following transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA:

- The plan sponsor provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees that provide these services also are participants of the Plan.
- Plan investments are managed by Empower Trust Company LLC, the Plan's custodian.
- The plan auditor performs the required annual audit of the Plan.
- The Plan relies on a third-party service provider, PBMares, LLP, to prepare the Plan's IRS Form 5500 and manage the individual participant accounts of the Plan.

8. Plan Tax Status:

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71 or the draft Listing of Required Modifications issued April 4, 2009. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

The plan administrator will apply for a determination letter on the Plan when they are eligible to apply to the program.

GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

9. Subsequent Event:

The plan changed custodians to Voya Financial as of January 1, 2025.
