## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF THE PLAN

The following description of New Leaders 401(k) Profit Sharing Plan & Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### General -

The Plan is a defined contribution plan that covers substantially all Employees of New Leaders (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 2000, and most recently amended and restated on January 1, 2020.

#### Eligibility -

The Plan is a defined contribution retirement plan covering all employees of the Company except a) employees covered by a collective bargaining agreement, b) non-resident aliens who do not receive earned income constituting United States source income, and c) part-time, temporary, or seasonal employees and interns, unless they are 21 years of age and complete 1,000 hours of service during the eligibility period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable provisions of the Internal Revenue Code.

In addition, when an employee first becomes eligible to make salary deferrals and they have not completed a salary deferral agreement within 45 days after becoming eligible to enter the Plan and make salary deferrals, the Employer will automatically withhold 2% of an employee's eligible earnings from their paycheck each payroll period and contribute that amount to the Plan as a pre-tax elective deferral. An employee may enter a salary deferral agreement at any time to select an alternative deferral amount or to elect not to defer under the Plan.

#### Contributions -

Each year, participants may elect to contribute up to 87% of their pretax annual compensation, as defined, to their tax deferred account or Roth after-tax account, not to exceed amounts prescribed by the Internal Revenue Service ("IRS"). Participants who reached age 50 before the end of the Plan year are eligible to make catch-up contributions up to amounts prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans. Participants direct the investment of their contributions and the Company's discretionary contributions into various investment options.

The Company makes matching contributions in the amount equal to 100% of each participant's elective deferrals not to exceed 3% of the participant's eligible earnings calculated on an annual basis. An employee must contribute to the Plan to be eligible to receive the Company matching contributions.

The Company may also decide to make a non-elective contribution to the Plan, although the Company is not required to do so. The non-elective contribution will be allocated to all employees eligible to participate in the Plan. The non-elective contribution, if made, will be allocated as of the end of each Plan year based on eligible earnings within the computation period.

Vesting -

Participants are vested in Employer contributions based on years of continuous service. A participant is fully vested after three years of credited service as follows:

Participant accounts -

Each participant's account includes (a) investment earnings and losses, (b) the employee's contributions, and (c) the Company's contributions. Participants' accounts are also charged with an allocation of administrative fees that are paid by the Plan. Allocations of investment earnings and losses and administrative fees are based on either a participant's account balance or specific participant transactions, as defined in the Plan document.

Investment elections -

Contributions to the Plan are invested according to participant instructions. The Plan Administrator has selected a list of investment options and has provided participants with information describing these investment options.

Payment of benefits -

Participants are entitled to receive a distribution of their vested account in the Plan upon termination of their employment; retirement; death or disability and termination of the Plan without the establishment of a successor Plan. A participant may elect to receive a lump sum amount equal to the value of his or her account, or a series of cash payments, in substantially equal installments. Hardship withdrawals are permitted from the Plan if certain conditions are met.

If the total vested value is below \$5,000 in a participant's account at the time of termination, then a distribution will be made to the participant regardless of whether they consent to receive it. If the total vested value is greater than \$5,000, the participant has the option of either 1) rolling over their balance into a qualified individual retirement account, or 2) receiving a distribution. If the vested value is greater than \$5,000, the participant may remain in the Plan.

The Plan also provides for minimum required distributions per IRS regulations by April 1 of the calendar year following the later of the calendar year in which the participant reaches age 73 or the calendar year the participant retires. In addition, participants may elect in-service withdrawals of their vested account balances after reaching age 59½.

Forfeited non-vested accounts -

Forfeited balances of terminated non-vested participant accounts can be used at the discretion of the Plan Sponsor. The balance of forfeited non-vested accounts totaled \$4,128 and \$2,125 as of December 31, 2024 and 2023, respectively. The Plan Sponsor used \$76,168 and \$10,290 of forfeitures during the years ended December 31, 2024 and 2023, respectively.

#### 1. DESCRIPTION OF THE PLAN (Continued)

Notes receivable from participants -

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. All notes receivable from participants are secured by the balance in the participant's account. Interest rates on loans to participants range from 4.25% to 9.50% with various maturities through October 21, 2029.

Plan termination -

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting -

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

Use of estimates -

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of investments -

Investments in registered investment companies are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are loans for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date.

Benefit payments -

Benefits are recorded when paid.

Administrative fees -

Certain expenses of maintaining the Plan are paid directly by the Company and some are paid by the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net appreciation of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits. Expenses that are paid by the Company are excluded from these financial statements.

#### **3. INCOME TAX STATUS**

The Plan was established as a qualified plan under Section 401(k) of the Internal Revenue Code (IRC). The prototype plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service (the IRS) indicated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC and was qualified and tax-exempt. Management of the Plan, in consultation with its legal counsel, believes that the Plan continues to meet the requirements of Section 401 of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **4. INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's Administrator instructed the Plan's independent auditors not to perform, and they did not perform, such auditing procedures with respect to the information certified by the qualified institution.

Reliance Trust Company, the Trustee, issued Certification Statements as of and for the years ended December 31, 2024 and 2023. The Certification Statements certified the completeness and accuracy of investments presented in the Schedule of Assets (Held at End of Year) and the investment income in the Statements of Changes in Net Assets Available for Benefits as of and for the years ended December 31, 2024 and 2023.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Merrill Lynch, Pierce, Fenner & Smith, which is also the Plan's investment advisor. Fees incurred by the Plan for investment management services are netted in investment income and approximated \$63,026 and \$58,100 for the years ended December 31, 2024 and 2023, respectively. Accordingly, these transactions are considered party-in-interest transactions.

Fees paid by the Plan to Automatic Data Processing Inc. (ADP), the Plan's record keeper totaled \$42,137 and \$35,250 for the years ended December 31, 2024 and 2023, respectively. Accordingly, these transactions are considered party-in-interest transactions.

#### 6. RISKS AND UNCERTAINTIES

The Plan's investment securities are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 7. FAIR VALUE MEASUREMENT

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. Investments presented in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for investments measured at fair value:

*Registered Investment Companies (Mutual Funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. Mutual funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
