## Independent Auditor's Report

**Note 1: Description of the Plan**

The following description of the Vektek Corporation Retirement Plan (the Plan), provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of Vektek Employer, LLC (the Company). Employees are eligible to begin deferring contributions after attaining age 18 and completing two months of service. Automatic enrollment (3%) begins after three months of service for employees who have not yet enrolled in the Plan. Employees eligible for participant deferrals are also eligible for company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Employee Contributions**

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate accounts and a guaranteed income fund to Plan participants as core investment options.

**Employer Contributions**

The Company may make a matching contribution equal to a uniform percentage of the employee's salary deferral, which percentage is determined annually at the discretion of the Company's Board of Directors. During 2024 and 2023, the Company matched 50% of the participants' contributions up to 12% of his/her compensation, which amounted to \$307,053 and \$316,344, respectively.

At the end of the Plan year, the Company, at the discretion of their Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has elected not to make a discretionary contribution for 2024 or 2023. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

**Participant Accounts**

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in both their contributions and Company contributions, plus actual earnings thereon.

**Participant Loans**

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate determined by the Plan Administrator. Loan repayments are made ratably through payroll deductions. Generally, the loan term may not exceed five years.

**Note 1: Description of the Plan (Continued)**

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants' account. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Payment of Benefits**

Distributions are made upon death, disability, retirement, or termination of employment. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum or, if subject to required lifetime required minimum distribution payments, substantially equal payments. In-service distributions are permitted from the participant's account upon attaining age 59<sup>1/2</sup>.

**Forfeitures**

The Plan is a safe harbor plan and as such, forfeitures do not apply. Any previous forfeitures will be used to reduce employer contributions. Forfeitures were not used in 2024 and 2023. The forfeiture account balances for plan years ending December 31, 2024 and 2023 was \$183 and \$13, respectively. During 2024, \$164 was transferred into the forfeiture account from employer matching contributions.

**Note 2: Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

**Investment Valuation and Income Recognition**

Investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investments are presented as determined and certified by Voya Retirement Insurance and Annuity Company (the Custodian) as of the Plan's year end. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology include quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or other inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

**Participant Loans**

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions upon a distributable event, as defined in the Plan document. There were no loans in default at December 31, 2024 and 2023.

**Note 3: Fair Value Measurements**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

**Pooled Separate Accounts**

The fair value of the Plan's pooled accounts are valued daily at their net asset values (NAV). This account offers options from multiple providers that are managed in one account. Fixed accounts held by the Custodian are also valued at NAV daily pricing and are held in the insurance company's general account.

**Note 4: Investment Contracts**

Participants in the Plan have the option to invest in the Voya Fixed Account. These funds are maintaining the contributions in a general operating account, plus earnings at guaranteed credit rates, less withdrawals and fees. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable time frames. The contracts are included in the financial statements as of December 31, 2024 and 2023 at contract value as reported to the Plan by Voya Retirement Insurance and Annuity Company for 2024 and 2023.

**Note 5: Related Party and Party in Interest Transactions**

The Company absorbs the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

In addition, certain plan investments are shares of proprietary funds managed by Voya Retirement Insurance and Annuity Company, for which they are paid a minimal fee. These transactions qualify as exempt party-in-interest transactions.

Additional party in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, investment fees paid to CBIZ Financial Solutions, Inc. and administrative fees paid to Voya Retirement Insurance and Annuity Company. These transactions qualify as exempt party-in-interest transactions.

**Note 6: Plan Termination**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 7: Tax Status**

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9: Reconciliation of Financial Statements to Form 5500**

The financial statement amounts reconcile with the annual Form 5500 filing to the Internal Revenue Service.

**Note 10: Information Prepared and Certified by Custodian (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian of the Plan.

**Note 11: Subsequent Events**

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.
