### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Macias Gini & O'Connell LLP ("MGO", "we", "us", or "our") has performed an audit of the financial statements of Neology, Inc. 401(k) Discretionary P/S Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Neology, Inc. 401(k) Discretionary P/S Plan (the “Plan”) provides only general information about the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a participant directed defined contribution plan, originally established on January 1, 1998 by Neology, Inc. (the “Company,” the “Employer,” or “Plan Sponsor”) to provide benefits to eligible employees as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). It also provides certain benefits in the event of death, disability, or other termination of employment. The Trustee of the Plan is Reliance Trust Company (the “Trustee” or “Reliance”). The Plan is subject to the provisions of ERISA.

#### Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Reliance serves as the Plan’s directed trustee and asset custodian and ADP, LLC (“ADP”) provides record-keeping services and manages participant accounts and participant related transactions.

#### Contributions

Each year, participants may contribute to the Plan up to 80% of compensation on a pre-tax basis, with dollar limits established by the IRC. Such contributions are excluded from the participant’s Federal taxable income until received as a withdrawal or distribution from the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) and may elect to make “after-tax” Roth contributions. During 2024, the maximum annual 401(k) pre-tax contribution limit was \$23,000, and the maximum annual catch-up contribution for participants 50 years of age and older was \$7,500.

The Plan provides for employer safe harbor contributions for all eligible participants. Safe harbor contributions are based on a percentage of a participant’s compensation. For the year ended December 31, 2024, the Company made safe harbor contributions in amounts equal to 100% of the participant’s elective deferrals up to a maximum of 6% of participants’ eligible compensation, which totaled \$1,071,887. Additionally, the Company may make discretionary profit-sharing contributions and qualified non-elective contributions (“QNECs”). The Company recorded QNECs to the Plan of \$25 for the year ended December 31, 2024. The total QNEC receivable at December 31, 2024 was \$25.

#### Participant Accounts

Each participant’s account is credited or charged with the participant’s contribution and allocation of (i) employer’s 401(k) matching contributions and (ii) the participant’s share of earnings or losses on contributions and administrative expenses. Each participant directs all amounts credited into their account into one or more of the investment options available under the Plan. Accordingly, as a participant-directed plan, each participant’s investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are immediately vested in their contributions, rollovers and employer safe harbor contributions plus actual earnings thereon. Vesting in the discretionary employer matching contributions portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

#### Investment Options

Participants direct the investment of their individual account balance in various investment options. Participants may change their contribution investment options daily and may transfer part or all of past investments to other investment options daily. Participants may elect to change their deferral percentage or stop making contributions monthly.

#### Notes Receivable From Participants

Participants may borrow up to 50% of their vested account, but the amount of the loan may not be less than \$500 nor exceed \$50,000, reduced by the excess of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan. A participant may have no more than three loans outstanding at any time. All loans, other than those used to purchase a principal residence, must be repaid within five years with interest fixed at the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 2% at the time of approval of the loan. Loans used for the purchase of a primary residence may not extend beyond 30 years from the date of the loans. Participant's loans are valued at the outstanding loan balance, plus any accrued but unpaid interest. Principal and interest are paid ratably through weekly payroll deductions. Loans mature through December 2029 with interest rates ranging from 4.25% to 10.50%.

#### Hardship and In-Service Withdrawals

The Plan Administrator may authorize a lump-sum distribution of at least \$500, but not to exceed the amount necessary to meet the financial need created by the hardship or the participant's contributions (excluding investment income), provided the participant submits positive evidence of an immediate and heavy financial need as defined in the Plan. Participants who have reached age 59½ may elect to withdraw all or a portion of their vested account balance while still employed.

#### Deemed Distributions

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded in the calendar quarter following the calendar quarter during which the loan was defaulted. These amounts are no longer included in net assets available for benefits and are recorded as benefits paid to participants. There were \$1,739 of deemed distributions for the year ended December 31, 2024.

**Benefit Payments**

Upon termination of service due to death, disability or retirement, as defined in the Plan, participants are generally entitled to a lump sum distribution of their fully vested account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account. Participants are generally paid in lump-sum cash distributions, however, they may also elect to receive either installment payments or a partial withdrawal of their fully vested account balance. Under the terms of the Plan, if the vested value of the account of a participant who has terminated employment is greater than \$5,000, the amounts may remain in the Plan until the participant elects to receive it. As of December 31, 2024 and 2023, all employees who elected to withdraw from the Plan had been paid.

**Expenses of the Plan**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Investment Valuation and Income Recognition**

All Plan investments are held by the Trustee. The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as components of net appreciation or decline in fair market value of investments for such investments.

**Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure from December 31, 2024 through the date these financial statements were available to be issued, October 14, 2025. No such events were identified.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”)’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments, dividends and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (“FASB”) established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted market prices of shares or units held by the Plan. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Valued at the quoted market prices of shares or units held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – EXEMPT PARTY-IN-INTEREST**

At December 31, 2024 and 2023, all Plan investments were managed by Reliance, the Trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Trustee were \$45,050 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 7 – TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan, sponsored by ADP. The Internal Revenue Service (“IRS”) has issued a favorable opinion letter dated October 6, 2020 on the prototype plan that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan does not believe it has any uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s administrator believes it is no longer subject to tax examinations for years prior to 2021.
