We have performed an audit of the accompanying financial statements of The DynaServ 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

1. Plan Description

The following description of the DynaServ 401 (k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) Plan established January 1, 2006 covering all eligible full-time non-union employees of DynaServ Florida LLC; DynaServ Florida, Inc. who are at least twenty-one years old and who have either completed 1000 hours of service in the first twelve months of employment or any subsequent calendar year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Reliance Trust Company serves as the Plan's custodian and performs the record keeping and investment services. The management of DynaServ Industries is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors the investment performance.

The Plan adopted the ADP Non-Standardized Defined Contribution Pre-Approved Plan. The IRS has determined and informed the Plan sponsor by an opinion letter dated October 6 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) and is in compliance with legislative and regulatory changes set forth in IRS Notice 2017-37.

Contributions

Each year, participants may contribute up to the maximum percentage of compensation and dollar amount allowed under Internal Revenue code 402 (g) not to exceed the limits under code section 401 (k). These limits were \$23,000 for 2024 and \$22,500 for 2023. Participants may also make roll over contributions from other qualified Plans and all eligible employees who were 50 years of age or older prior to the close of the Plan year may make catch up contributions up to \$7,500 in 2024 and 2023. The Company elected to make a safe harbor contribution equal to 100% of an employee's deferral of the first 3 percent of compensation plus 50 percent of each participant's contributions representing the next 2 percent of compensation.

Notes To Financial Statements

Participants Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings, and charged with an allocation of investment gains or losses, withdrawals and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon enrollment in the Plan, participants may elect to allocate their contribution within the investment offerings by Reliance Trust Company . Participants may change the amount of their deferral and the allocation of future deferral contributions quarterly. Participants can transfer their account balances between investments up to four times annually.

Investments

Upon enrollment in the plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan

Vesting

Participants are immediately vested in their own and the Company's safe harbor contributions and the earnings thereon.

Benefits

On termination of service, due to death, disability or retirement, a participant or their beneficiary may elect to receive a single lump sum payment equal to the participant's vested interest in his or her account. If a participant's account balance is greater than \$5,000, the participant or their beneficiary may elect to receive monthly payments or defer payment until they are age 72. The Plan allows for hardship withdrawals under certain circumstances.

Notes To Financial Statements

1. Plan Description - Continued

In response to the Covid-19 pandemic, the CARES act was passed in April 2020 allowing eligible participants to take up to \$100,000 from a qualified retirement plan without the 10% early withdrawal penalty. This distribution did not require a participant to take a loan before taking a Corona Virus-related distribution (which may differ from the plan's hardship withdrawal provision). The participant is not required to repay the amount, but repayments are permitted within three years.

Forfeited Participant Accounts

At December 31, 2024 and 2023, forfeited participant accounts totaled \$-0. These accounts when funded, are available to reduce future employee contributions or pay plan expenses.

Notes Receivable from Participants

Notes Receivable from Participants are secured in the participants vested balance in their account and bear interest at 4.25% - 9.5%, which is commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest. As of December 31, 2024 participants had no notes. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Loan balances are limited to 50% of his or her nonforfeitable account balance in the Plan. The maximum aggregate dollar amount of loans outstanding to any Participant from the Plan and any other qualified retirement plan maintained by the Employer or an Affiliated Employer may not exceed \$50,000, reduced by the excess of the Participant's highest outstanding Participant loan balance during the 12-month period ending on the date of the loan over the Participant's current outstanding Participant loan balance on the date of the loan. Interest is accrued on the monthly outstanding loan balance. A loan is considered in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the Participant missed the scheduled payment, in accordance with the Plan's administrative procedures.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Plan Termination

The Sponsor has the right under the Plan to amend or discontinue the Plan at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. The Sponsor finalized a sale of their assets in February 2024 including the workforce in place. The Sponsor initiated discontinuance action with the administrator in June 2024. Normally a retirement plan in termination has one year to distribute its assets. The plan has not distributed the remaining assets within the year and is considered ongoing under Internal Revenue guidance.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value.

2. Significant Accounting Policies – Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Payment of Benefits Benefits are recorded when paid. Participant contributions are withheld from payroll and remitted to the plan trustee each payroll period along with the Company's safe harbor match.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Risk and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan Funding

Concentration of Credit Risk

Investments held by Reliance Trust Company are covered by the SPIC up to \$500,000 in 2024 and 2023.

Date of Management's Review

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10-05, Fair Value Measurements and Disclosures, provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-5 are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - For quoted prices for similar assets or liabilities in active markets; quoted prices from identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) terms, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements – Continued

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies - The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation.

4. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Reliance Trust Company, the trustee of the Plan and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest.

5. Tax Status

The Internal Revenue Service has determined that the prototype Plan, which was adopted by the employer, is designated in accordance with applicable sections of the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management has evaluated all of the Plan's tax positions for all open years and has concluded that the Plan has no uncertain tax positions that require adjustment to the financial statements.

6. Investment Information Certified by Plan's Trustee

The following is a summary of the investment information regarding the Plan at December 31, 2024 and 2023, and income for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared or derived by Reliance Trust Company in 2024 and 2023 the trustee of the Plan and furnished to the Plan administrator.
