We are required to be independent of Care Indeed 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Care Indeed 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Care Indeed 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedule of Assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1. Plan Description**

The following description of the Care Indeed 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

### General

The Plan was established on March 1, 2019, in accordance with Section 401(k) of the Internal Revenue Code.

### Eligibility

The Plan provides eligibility for participation for all employees of Care Indeed Inc. (the "Company") who are at least 21 years of age, and upon completion of 6 consecutive months from date of employment during which employee completes 200 hours of service.

The following employees are excluded employees, not entitled to participate in the Plan:

- Union employees whose employment is governed by a collective bargaining agreement
- Certain nonresident aliens who have no earned income from sources within the United States
- Leased employees

### Plan Administration

The Plan is administered by Care Indeed Inc. Reliance Trust Company serves as the trustee, while ADP acts as the recordkeeper and third-party administrator, responsible for processing and maintaining participant data records.

### Participant Contributions

Employee contributions to the Plan are deferrals of the employee's compensation made through a direct reduction of compensation in each payroll period. The plan has two kinds of Elective Deferrals, the participants are able to make- 1) Pre-Tax 401(k) deferrals or 2) Roth 401(k) deferrals. The maximum tax deferred contribution may not exceed 90% of their annual eligible earnings, as defined in the Plan, on a tax - deferred basis, up to a maximum amount allowed by the Internal Revenue Code ("IRC").

Furthermore, the Plan allows for automatic enrollment into the Plan at a contribution rate of 4% of eligible compensation, unless the employee affirmatively elects otherwise.

### Employer Contributions

The Company may make discretionary matching contributions equal to a discretionary percentage determined by the Company, of the participant's elective deferrals. For the year ended December 31, 2023, the Company contributed a matching contribution of \$0.25 for \$1.00 up to 4% participants elective deferrals.

### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the company contributions portion of their accounts plus earnings thereon is based on years of services. A participant is 100 percent vested after 6 years of credited service.

#### Participant Accounts

Each participant's account is credited with participant's contribution and earnings thereon and allocations of the Company's contribution and related earnings and charged with an allocation of administrative expenses. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchase. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Rollover Contributions

Participants are allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans and individual retirement accounts. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

#### Investment Options

Participants may direct investments of their account balance among several investment options.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the value of their vested account balance. Loan terms shall not be for more than five years unless the loan is for the purchase of a principal residence. Loan used to purchase primary residence may be repaid within period of no more than 30 years. The loans are secured by the remaining vested balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

#### Benefit Payments

Upon retirement, death, disability, or termination, a participant or his/her beneficiary may elect to receive accumulated retirement benefits in a single distribution in cash. In addition, a terminated participant may also elect to transfer into an individual retirement accounts all amounts which qualify as a rollover under the provisions of the Internal Revenue Code of 1986, as amended.

#### Forfeitures

Forfeitures may be used to pay plan administrative expenses or to reduce employer contributions. As of December 31, 2024, and 2023, the forfeiture account balances were approximately \$1,200 and \$1,000, respectively. During the year, there were additional forfeitures of approximately \$9,700. Forfeitures totaling approximately \$9,500 were used to reduce employer contributions.

#### Administrative Expenses

Certain administrative fees are paid by the Plan. Expenses that relate solely to a participant are assessed against such participant as provided in the Plan agreement.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 2. Significant Accounting Policies**

Basis of Presentation

The financial statements of the plan are prepared using accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

GAAP requires the plan management/administrator to make estimates and assumptions that affect certain reported amounts of net assets and changes therein. Actual results may differ from those estimates.

Investments

The plan's investments are stated at market value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Participant loans are valued at their outstanding balances, which approximates fair value. Purchases and sales of securities are recorded on a trade- date basis. Investment income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date.

A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan agreement.

Excess Contributions Payable

As of December 31, 2024, no excess contributions were identified, and therefore no liability was recorded in the accompanying financial statements.

As of December 31, 2023, the Plan recorded a liability for participant contributions that exceeded the Internal Revenue Code limits. These amounts, together with related earnings, were refunded to the affected participants in early 2024 in accordance with applicable regulations. Amount payable to participants for contributions in excess of amount allowed by the IRS are recorded as liability with a corresponding reduction to participant contribution.

Distribution Payable

As of December 31, 2023, the plan has a liability for distributions payable, which includes amounts owed to participants for benefits that have been approved but not yet paid. These distributions are recorded as current liabilities in the financial statements.

Net Appreciation in Fair Value of Investments

Net appreciation in the fair value of investments, as recorded in the accompanying statements of changes in net assets available for benefits, includes changes in the fair value of investments acquired, sold, or held during the year.

Rollover Contributions

Participants may contribute amounts representing distributions from other qualified retirement plans. These rollover contributions are non-payroll participant deposits that are included within participant contributions on the accompanying Statement of Changes in Net Assets Available for Benefits. Rollover contributions are recorded when received by the Plan. For the year ended December 31, 2024, rollover contributions totaled approximately \$15,000.

Other Income and Other Expenses

The plan sponsor established a revenue sharing agreement with a mutual fund provider, resulting in other income and expenses associated with administrative fees from this arrangement. Both items are allocated to participants who invested in those mutual funds, based on their account balances. These amounts are reported in the statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**Note 3. Risks, Uncertainties and Concentration**

As of December 31, 2024 and 2023, investments in several mutual funds each individually represented 5 percent or more of the Plan's total investments and, in the aggregate, accounted for approximately 60 percent of total investments for each year. Investment securities are exposed to various risks, including interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of these securities in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 4. Fair Value Measurements**

The fair value measurement standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements):.

Level 1 - Inputs to the valuation methodology are quoted prices in active markets for identical assets or liabilities

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Categorized as Level 1 and are valued at the closing price reported on the active market on which the individual securities are traded.

*Common collective trust:* Units held in common/collective trust (CCT) are valued using the NAV practical expedient of the CCT. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT may be redeemed at NAV daily without restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, dividends, interest income on notes receivable from participants, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

**Note 6. Party-In-Interest Transactions**

Party-in-interest transactions under ERISA include notes receivable from participants and are exempt from the prohibited transaction rules set forth by ERISA.

**Note 7. Income Tax Status**

The Plan was determined to qualify under Section 401 (k) of the Internal Revenue Code (the Code) and therefore, is exempt from federal income taxes under Section 501(a) of the Code. The Plan is exempt from state taxes under similar statutes. As long as the plan maintains its tax exemption, the Plan is not liable for federal and state taxes.

GAAP requires the plan administrator to evaluate uncertain tax positions taken by the plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress
