

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

Note 1 - Description of Plan

The following description of the Mechanical Systems Company, LLC 401(K) PS Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering employees of the Mechanical Systems Company, LLC (“Company”), the plan sponsor, who complete 1,000 hours of service during the first twelve months of employment and are age eighteen or older. It is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute a portion of pretax annual compensation, as defined by the Plan, or contribute a portion of after-tax amounts as Roth contributions. The Company implemented an automatic enrollment feature in 2021. Within 30 days after employees become eligible and have not declined participation in the Plan, 1% of their eligible compensation will be withheld and contributed to the Plan as a Pre-Tax Elective Deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes a matching percentage of the participant’s elective deferral. The maximum match by the Company is 100% of the participant’s first 3% of eligible compensation, and an additional match of 50% of the next 2% of eligible compensation. Additional amounts may be contributed at the option of the Company’s board of directors.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is also immediate.

Note 1 - Description of Plan (Continued)

Notes Receivable from Participants. Participants may borrow from their fund accounts a maximum of 50% of their vested account balance not to exceed \$50,000. Loan terms shall not exceed 5 years unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 5.25% to 10.50%. Principal and interest are paid weekly.

Payment of Benefits. Participants are eligible to receive a distribution of benefits upon retirement at the age of 65, or upon death, disability, termination of employment, or in the event of certain hardships as defined under the Plan. At age 59½, participants may elect to take distributions from any accounts that are 100% vested without being required to terminate employment. Participants entitled to receive a distribution of benefits shall be paid in a lump-sum payment if the vested account balance does not exceed \$5,000. In the instance where the vested account balance exceeds \$5,000, participants may elect to receive a lump-sum distribution or ad-hoc distributions, subject to any reasonable limitations the plan administrator may impose.

Forfeited Accounts. Nonvested forfeiture accounts may first be used to pay any plan administrative expense and then may reduce future employer matching contributions. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

Investment Options. Upon enrollment in the Plan, a participant may direct employee contributions to a variety of investment vehicles.

Note 2 - Summary of Significant Accounting Policies

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Use of Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Basis of Accounting. The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with U.S. GAAP.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants' account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Administrative Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees for trustee, legal, investment management and record keeping services are paid by Plan.

Note 3 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 4 - Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan was amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 5 - Related Parties and Parties-In-Interest Transactions

Certain Plan investments are units of common collective trusts and mutual funds account managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as parties-in-interest. There were no fees paid to Reliance Trust Company by the Plan for investment management and record keeping services for the year ended December 31, 2024.

During 2024, the Plan Sponsor paid \$18,055 for the Plan's annual audit. This expense is excluded from these financial statements.

During 2024, the Plan incurred expenses of \$17,644 to ADP's Retirement Services and \$13,287 to UBS recorded as administrative expenses on the statement of changes in net assets available for benefits.

These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements
Mutual Funds

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on closing price reported on the active market where the individual securities are traded.
