Opinion

A. Description of the Fund

The following brief description of the Retirement Plan for Hourly Paid Bargaining Unit Employees of PMC Biogenix, Inc. (“The Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The Plan is a noncontributory defined benefit pension plan which covers all hourly employees of PMC Biogenix, Inc. (the Company) who have completed one year of credited service. The Company administers and bears the entire cost of the Plan; no contribution is required of any employee. The Plan was formed on March 1, 2008.

Participant accounts, benefits and vesting

Contributions from the Company are based on amounts determined on an actuarial basis to be necessary to provide the Plan with assets sufficient to meet the benefits to be paid to Plan participants. A participant is 100% vested after five years of credited service. The formula for normal retirement benefits is based upon a retirement benefit formula equal to one twelfth of the sum of the benefit described in the following illustration calculated separately for each plan year in which the participant is employed and then totaled for all such years. Compensation prior to Plan participation shall not be counted. Plan benefits were frozen effective October 16, 2009.

Participant’s Compensation During a Plan Year	Percentage Used in Calculation
Up to \$600 *	0% of such compensation
Between \$600 and \$3,000 *	1.1% of such portion
Over \$3,000 *	1.65% of such portion

* Proportionately adjusted for any year in which an individual is a participant for only part of the plan year by the ratio which the number of months of participation bears to 12.

Reduced benefits are available if early retirement is elected. Generally, retirement benefits as determined by a formula are payable monthly.

If a participant dies prior to partial or full vesting in the Plan, the death benefit provided under this Plan shall be the minimum spouse’s death benefit and would be paid under the following circumstances:

1. In the case of a participant who dies after the earliest retirement age and such participant had retired with an immediate joint and survivor annuity on the day before the participant’s date of death, or
2. In the case of a participant who dies on or before the earliest retirement age and such participant had:
 - a. Separated from service on the earlier of the actual time of separation or the date of death
 - b. Survived to the earliest retirement age

- c. Retired with an immediate joint and survivor annuity at the earliest retirement age based on the participant's vested accrued benefit on date of death
- d. Died on the day after the day on which said participant would have attained the earliest retirement age, the death benefit provided under this Plan

In the case of an unmarried participant or unmarried former participant who dies prior to such participant's retirement date, no death benefits shall be payable under this Plan.

Funding policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual Employee Retirement Income Security Act of 1974 (ERISA) minimum funding requirement. During the years ended December 31, 2024 and 2023, there were no employer contributions made to the Plan. The Company's contributions for December 31, 2024 and 2023, met the ERISA minimum funding requirement. No participant contributions are permitted under the Plan.

B. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the liquidation basis of accounting for the Plan year ended December 31, 2024 and accrual basis for 2023. Under the liquidation basis of accounting, assets are carried at the value the Plan expects to receive and liabilities are recorded at a value the Plan expects to be obligated to pay.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results could differ from these estimates.

Concentration of Credit Risk

Financial instruments that potentially expose the Plan to concentrations of credit risk include cash. In assessing its risk, the Plan's policy is to maintain funds only with reputable financial institutions. While the Plan attempts to limit any financial exposure, its deposit balances may, at times, exceed federally insured limits. The Plan has not experienced any losses on such accounts.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 6 for discussion of fair value measurements.

Investment valuation and income recognition (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Accounting

Valuation techniques used in fair value measurements need to maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. Assets and liabilities measured at fair value are categorized into one of three different levels depending on the observability of the inputs employed in their measurement. Level 1 inputs are quoted prices in active markets for identical assets or liabilities. Level 2 inputs are observable inputs other than quoted prices included within Level 1 for the asset or liability, either directly or indirectly through market-corroborated inputs. Level 3 inputs are unobservable inputs for the asset or liability, including the Plan's own assumptions in determining the fair value of the assets or liabilities. See Note D for discussion of fair value measurements.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

C. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1	Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 3	Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at quoted market prices, which represent the Net Asset Value (NAV) per share at the close of the financial markets. The NAV is based on the value of the underlying assets owned by the investment, minus its liabilities and then divided by the number of shares outstanding. Mutual funds report NAV daily and are required to transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

D. Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated vested Plan benefits is the present value of expected future payments for benefits to Plan participants which have been accrued as of the termination date. Accumulated benefits include amounts expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of vested participants who have died, and (c) present participants or their beneficiaries.

The actuarial present value of accumulated Plan benefits is that amount which results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The actuarial present value of accumulated vested benefits of the Plan was determined by the Plan's actuary, Sentinel Benefits & Financial Group, as of January 1, 2024.

E. Tax Status

The Internal Revenue Service (“IRS”) determined and informed the Plan by a letter dated February 28, 2023, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan is designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan’s counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has conducted that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

F. Plan Termination

The Company approved an amendment to terminate the Plan effective September 30, 2023. The Plan’s participants were notified of the termination on July 26, 2023. All participants in the Plan will receive a distribution of their vested benefits as soon as administratively practicable after the effective date and expiration of the regulatory waiting period and settlement for purchase of annuities with an insurance company. Participants may elect to roll their benefits into a group annuity contract with an insurance company that the plan sponsor plans to purchase.

F. Plan Termination (Continued)

The Company is awaiting approval for the termination from the Pension Benefit Guaranty Corporation (PBGC). Therefore, management determined that liquidation was not yet imminent as of December 31, 2023. The Plan has adopted Financial Accounting Standards Board Accounting Standards Codification 205, Presentation of Financial Statements: Liquidation Basis of Accounting for the year end December 31, 2024. The Plan's 2023 financial statements were prepared on an accrual basis for a going concern and do not include any adjustments that might result from the Plan's subsequent termination. The termination is also not reflected in the accumulated benefit information as of December 31, 2022.

Upon Plan termination, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding the Plan termination.
2. Other vested benefits insured by the PBGC (a U.S. government agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC when the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits upon Plan termination will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

G. Minimum Funding Standards

As discussed in Notes A and D to the financial statements, any funds needed to pay benefits and administrative expenses of the Plan shall be received from former contributing employers as settlement of their withdrawal liability and minimum funding deficiency obligations and from the PBGC in accordance with its financial assistance agreement with the Plan.

H. Related Party and Party in Interest Transactions

Certain Plan investments are managed by Principal Trust Company, the Plan's custodian, therefore these transactions qualify as party in interest transactions. Certain administrative functions are performed by officers and employees of the Company, who may also participate in the Plan, at no cost to the Plan.

I. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

J. Subsequent Events

For purposes of determining the effect of subsequent events on these financial statements, management has evaluated events subsequent to October 8, 2025, the date on which the financial statements were available to be issued. As of October 2025, all Plan assets are distributed.
