Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MISA Consolidated 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of Plan

The following description of MISA Consolidated 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was formed on January 1, 2007, and simultaneously on January 1, 2007, Marubeni-Itochu Steel America Inc. ("MISA") and its related companies (the "Company") adopted the MISA Consolidated 401(k) Plan as a merger, revision and complete restatement of the following previously adopted plans: Clark Cincinnati, Incorporated 401(k) Plan, MISA Metal Processing Retirement Plan, MISA Steel Processing, Inc. 401(k) Plan and Western Metal Lath Retirement Savings Plan. In 2008, Quality Edge 401(k) Plan and MISA Metals, Inc. Salaried Employees Profit Sharing Plan merged into the Plan. In 2013, RSDC of Michigan, LLC Non Union 401(k) Profit Sharing Plan & Trust and Marubeni-Itochu Tubulars America, Inc. 401(k) Plan merged into the Plan. In 2019, the employees of CTAP, LLC joined the Plan. In 2022, MISA Specialty Processing (Worthington Specialty Processing) joined the Plan.

The Plan covers all full-time and part-time employees of the Company, except those classified as special project employees, leased employees, union represented employees unless otherwise indicated in their collective bargaining agreements, nonresident aliens and independent contractors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan administrator.

Eligibility

Eligible employees who have reached the age of 18 are generally eligible to participate in the Plan after completing three months of service for the sole purposes of eligibility to make participant contributions and to participate in matching contributions.

Contributions

Each year, participants may voluntarily contribute from 1% to 75% of his or her pre-tax annual compensation, as defined by the Plan, up to the federal maximum elective deferral each year (\$23,000 for 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of his or her contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless he or she affirmatively elects not to participate in the Plan. Automatically enrolled participants have his or her deferral rate set at 3% of eligible compensation.

On October 17, 2016, the Plan was amended, effective January 1, 2017, to provide an employer safe harbor contribution which is the sum of 100% of a participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 6% of the participant's compensation.

The matching contribution is set each year by the employer. The Company contributed \$8,246,572 in matching contributions for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. A participant is 100% vested after four years of credited service for the Company's matching contributions made before January 1, 2017. Effective January 1, 2017, the Company's matching contributions are 100% vested upon participation.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$177,488 and \$166,780, respectively. These accounts will be applied to administrative expenses or to reduce future employer contributions to the Plan. During 2024, employer contributions were reduced by \$69,082 from forfeited nonvested accounts.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes receivable from participants

Participants may borrow from his or her fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting. The primary differences from financial statements prepared under accounting principles generally accepted in the United States of America arise from accounting for investment income and contributions which are recorded when received, and investment and administrative expenses and return of excess contributions are recorded when paid, rather than recording such items on an accrual basis. Accordingly, the accompanying financial statements are not intended to be presented in conformity with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements on the modified cash basis requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded when received. Interest income is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which participants' compensation is earned.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage account: The self-directed brokerage account includes various common stock and mutual funds. Refer to mutual funds above for a description of the valuation methodology used. Common stocks are valued at the closing price reported on the active market in which the individual securities are traded.

Note 4 - Related party transactions and party-in-interest transactions

ADP Retirement Services ("ADPRS") provides certain administrative services to the Plan pursuant to an agreement between the Company and ADPRS. ADPRS receives revenue from mutual fund and collective trust fund service providers for services ADPRS provides to the funds. This revenue is used to offset certain amounts owed to ADPRS for its administrative services to the Plan.

If the revenue received by ADPRS from such mutual fund or collective trust fund service providers exceeds the amount owed under the agreement, ADPRS remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan sponsor may make a payment to ADPRS for administrative expenses not covered by revenue sharing.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Tax status

The Plan is based on a prototype plan document. The prototype plan sponsor has obtained an opinion letter dated October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan document is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the prototype plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
