The Peachtree Orthopedics Pension Plan (the Plan) was adopted effective January 1, 2020. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a cash balance defined benefit plan providing retirement, disability, and death benefits to all eligible employees. The plan sponsor is Peachtree Orthopaedic Clinic, P.A. (the Company, Plan Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan includes staff and shareholder physicians who have completed one year of service with the Company and are 21 years of age. Entry dates are the first date of each quarter.

Participant's Accounts

Under the plan provisions, amounts are credited by the Company to the participants' hypothetical accounts. The accounts are allocated compensation credits and interest credits at the end of every year. The compensation credits are allocated based on employment classification and their age as of the first day of the Plan year.

Participants' hypothetical accounts also receive interest credits of 3% at the end of every year. However, in no event shall the interest crediting rate for any plan year be at a rate greater than the market rate of return as defined in regulations promulgated by the Secretary of the Treasury.

Funding Policy

The Company's funding policy is to contribute funds to the Plan as necessary to provide for current service and for any unfunded liability over a reasonable period. To the extent that these requirements are fully covered by assets in the Plan, the Company may elect not to make any contribution in a particular year. The Company made contributions of \$2,715,000 and \$2,284,624 for the years ended December 31, 2024 and 2023, respectively. The Plan has met the ERISA minimum funding requirements.

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Pension Benefits

Participants become 100% vested after three years of continuous service and are entitled to annual pension benefits beginning at normal retirement age (65) of the actuarial equivalent of their account balance, which is the sum of annual cash balance credits and interest credits. Participants may elect to receive their pension benefits in the form of a joint and survivor annuity. If employees terminate before rendering 3 years of service, they forfeit the right to receive accumulated plan benefits attributable to the Company's contributions. Employees may elect to receive the value of their accumulated plan benefits as a lump-sum distribution upon retirement or termination, or they may elect to receive their benefits as a life annuity payable monthly from retirement.

Death and Disability Benefits

A participant shall have a nonforfeitable right to 100% of his or her accrued benefit on the date that the participant incurs a disability or dies while he or she is in employment. If a participant dies after his or her employment ends, only the portion of the participant's accrued benefit with respect to which he or she had a nonforfeitable right as of his or her date of death shall be payable.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Note 3: Plan Termination

The Plan Sponsor reserves the right to terminate the Plan, by action duly taken by its Board of Directors, at any time as the Plan Sponsor may deem advisable. Upon termination of the Plan, the Plan Sponsor shall direct the Trustee to pay or provide for the payment of all reasonable administrative expenses of the Plan and Trust Fund, and thereafter the Plan Sponsor shall direct the Trustee to use and apply the remaining assets of the Trust Fund to provide for liabilities thereof with respect to Participants and Beneficiaries of deceased Participants in the manner prescribed by Section 4044 of ERISA (or any corresponding provision of any subsequent applicable law in effect at the time) by purchasing annuities for the benefit of such Participants and Beneficiaries, by continuing the Trust Fund and making provision under the Trust Agreement for the payment of such liabilities, or by distributing amounts from the Trust Fund to and on behalf of such Participants and Beneficiaries. If, after payment or provision for payment of all reasonable administrative expenses of the Plan and Trust Fund and satisfaction of all liabilities of the Trust Fund with respect to Participants and Beneficiaries of deceased Participants, there shall be excess assets remaining due to actuarial error, the Plan Sponsor shall direct the Trustees to revert such excess assets to the Plan Sponsor; provided, however, that the Plan Sponsor may instead direct the Trustees to make a direct transfer of all or a designated portion of such excess assets to the trust maintained in connection with any "qualified replacement plan," as such term shall be defined in Code Section 4980(d)(2).

Note 4: Information Certified by the Plan's Trustee (Unaudited)

The plan administrator has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, the investments on the schedule of assets (held at end of year) as December 31, 2024, and the information reflected on the schedule of reportable transactions for the year ended December 31, 2024.

Note 5: Fair Value Measurements

In accordance with Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, the inputs to valuation techniques used to determine fair value are categorized into a fair value hierarchy. Observable inputs (highest level) reflect market data obtained from independent sources, while unobservable inputs (lowest level) reflect internally developed market assumptions. The inputs are summarized in a three-level valuation hierarchy as follows:

Level 1: Quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in markets that are not active; and
- model-derived valuations in which all significant inputs are observable or can be corroborated by observable market data for substantially the full term of the investment.

Level 3: Model-derived valuations in which one or more significant inputs are unobservable.

If the inputs used to value the investment fall within different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the investment.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets.

Note 6: Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan’s provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees’ compensation during their credited service. The accumulated plan benefits for active employees are based on their years of credited service on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The Plan’s actuary estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The net long-term rate of return on investments and the discount rate used to estimate the present value of accumulated plan benefits are the same.

The significant actuarial assumptions used in the valuation as of January 1, 2024 and 2023, were as follows:

Long-term rate of return on investments, net of expenses: 3% for 2024 and 2023

Mortality basis: Based on Pri-2012 total dataset base rate mortality table projected generationally using the using the Principal Mortality Improvement Scale

Weighted average retirement age: Age 66 for 2024 and 2023

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Note 7: Related-Party Transactions and Party in Interest Transactions

Certain administrative expenses are absorbed by the Plan Sponsor and are not included in these financial statements. Certain investment related expenses are included in the appreciation (depreciation) in fair value of investments. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

Note 8: Tax Status

The IRS has determined and informed the Company by a letter dated July 17, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 10: Subsequent Events

The Plan has evaluated for subsequent events between the statement of net assets available for benefits date of December 31, 2024, and the report date, the date the financial statements were available for issuance, and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

Physician Directors who are also Executive Physician Directors and whose age on December 31, 2011 shall be greater than 50 will receive a \$115,000 credit.

Interest Crediting Rate: At the end of the Plan Year, the interest crediting rate is applied to accumulated Cash Balance Credits at the beginning of year minus any distributions during the year. The Crediting Rate is 3.00%.

Age-Based Table: Cash balance credit for a Physician Director is based on their employment classification and age as of the first day of the Plan Year. One-twelfth of the Physician Director’s annual Employer Contribution Credit shall be accrued at the end of each calendar month provided the Participant is an Active Participant at the end of such calendar month. If an individual does not earn 500 Hours of Service during a Plan Year, the Participant shall not accrue a Cash Balance Credit for such month.
