## INDEPENDENT AUDITORS' REPORT

To the Trustee and Plan Administrator of  
the Powercon Corporation 401(k) Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements
