SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Vectorworks, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 DESCRIPTION OF PLAN

The following description of the Vectorworks, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees Vectorworks, Inc. and its participating employers, Nemetschek, Inc., Solibri, LLC, and dRofus, Inc. (collectively referred to as the Company), provided the employee meets eligibility requirements of the Plan. Employees are eligible to participate in the Plan on the first day of the month coinciding with or following their 18th birthday and the completion of three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make before-tax contributions, not to exceed Internal Revenue Code limitations, as well as after-tax Roth contributions. Participants who are 50 years old before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualified retirement plans. Upon meeting the Plan's eligibility requirements, participants are entered into the Plan under an automatic enrollment feature with a pre-tax deferral contribution of 3% of eligible compensation (as defined) that will automatically be elected, unless otherwise directed by the employee. Each year, the automatic deferral will increase by 1% up to a maximum of 6% of eligible compensation.

The Company may make discretionary and matching contributions for active participants in the Plan. The Company makes a matching contribution equal to 100% of a participant's elective deferrals up to 1% of the participant's eligible compensation plus 50% of the participant's additional elective deferrals up to 6% of the participant's eligible compensation. For 2024, the Qualified Automatic Contribution Arrangements (QACA) safe harbor matching contribution totaled \$823,689, net of forfeitures. There were no discretionary contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any discretionary Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their elective deferral contributions. A participant generally becomes fully vested in the Company's discretionary and matching contributions

based on years of continued service. For discretionary contributions, participants vest 20% after two years of service, with an additional 20% each year, becoming fully vested after six years of service, or upon permanent disability or death of the participant. For matching contributions, participants become fully vested after two years of service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

Notes Receivable From Participants

Participants may borrow against the balance in their accounts, up to the lesser of 50% of their vested balances or \$50,000. The minimum borrowing amount of any loan is \$1,000. Participants may not have more than one loan outstanding at any given time. Loan terms require amortization of principal and interest over a period not to exceed five years. Loans used to acquire a principal residence may extend beyond a five-year term. Loans bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Loans are repaid through payroll deductions and may be repaid in full at any time.

Payment of Benefits

Upon termination of service, a participant is entitled to receive a lump-sum amount equal to the vested portion of the participant's account. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions defined in the Plan Document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$60,259 and \$38,216, respectively. These accounts may be used to pay Plan expenses and reduce Company contributions in accordance with the Plan Document. In 2024, Company contributions were reduced by \$50,042 from forfeited non-vested accounts. Plan expenses totaling \$18,500 were paid from forfeitures during 2024.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments

Investments are stated at fair value. See Note 3 for a discussion of fair value measurements.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

(See Independent Auditors' Report)

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trust: Valued using the NAV per unit. NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV. Participants may redeem units of the Federated Capital Preservation Fund for the purpose of funding a benefit payment, making a participant note, honoring an employee-directed transfer to another noncompeting investment, or paying Trustee fees. Participants may make withdrawals from this fund for other purposes generally only upon 12 months' advance written notice to the Trustee.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 **TAX STATUS**

The Plan obtained its latest determination letter on October 6, 2020, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements. GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions as of December 31, 2024.

NOTE 6 **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$108,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
