# THE NEW ST. JOHNLAND NURSING 401(K) PLAN

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. THE PLAN

The following description of The New St. Johnland Nursing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a contributory defined contribution plan covering all non-union employees of St. Johnland Nursing Center, Inc. (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Automatic Data Processing, Inc. (ADP) provides recordkeeping services for the Plan. Reliance Trust Company (Reliance) is the Plan’s trustee and custodian and executes investment transactions.

#### **Eligibility**

Employees become eligible to participate and contribute to the Plan upon completing 90 days of service and attaining the age of 18. Employees become eligible to receive the Sponsor’s matching and profit-sharing contributions upon completing one year of service and attaining the age of 21.

#### **Contributions**

Eligible participants are able to contribute up to 80 percent of their annual compensation, as defined in the plan document. The total contribution to the Plan may not exceed the annual dollar limits set by the Internal Revenue Code (IRC). Participants may designate all or a portion of their elected deferrals as Roth elective deferrals. Participants are also permitted to make rollover contributions of amounts received from other tax-qualified employer-sponsored defined contribution plans.

The Sponsor may make matching contributions equal to a fixed percentage of the participant’s elective deferrals. For the years ended December 31, 2024 and 2023, the Plan Sponsor made matching contribution equal to 50%, respectively of eligible employees’ salary deferrals, to the extent such deferrals did not exceed 6% of eligible participant compensation. Participants were entitled to receive matching contributions if they completed 1,000 hours of service during the plan year and were employed on the last day of the plan year.

The Sponsor can also elect to make discretionary profit-sharing contributions. The Plan Sponsor did not elect to make profit-sharing contributions for the years ended December 31, 2024 or 2023.

Participants direct how their accounts are to be invested by choosing among the investment funds made available by the trustee of the Plan.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Sponsor’s contributions, (b) plan earnings and (c) plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## 1. THE PLAN (Continued)

### Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or installment payments under various options.

Participants may also, in certain instances, make withdrawals to meet the need of a hardship, as defined by IRC. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Matching and profit-sharing contributions made by the Sponsor vest according to the following schedule:

### Notes Receivable from Participants

Participants are allowed to borrow against their respective account balance. Participants may borrow up to the lesser of 50% of their vested account balances or \$50,000. Loans are repayable over periods not to exceed five years, except in the case of a loan taken for the purpose of purchasing a primary residence. All loans bear interest at the prime rate plus 1%. The loans are secured by the balances in the participants' accounts.

### Investment Options

The Plan currently offers various investment options including mutual funds and common collective trusts. Participants may change their investment options daily.

### Forfeitures

Participants who terminate employment before being fully vested will forfeit their interest in employer contribution account balances. These forfeited account balances will be used to reduce future employer contributions. The balance of unallocated forfeitures totaled \$5,577 and \$6 at December 31, 2024 and 2023, respectively. Approximately \$2,400 and \$4,000 of forfeitures were used to reduce employer contributions during 2024 and 2023, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Investments

Investments are stated at fair value. Changes in the current value of investments, including realized/unrealized gains and losses on assets sold/held during the year, are reflected in the statements of changes in net assets available for benefits as appreciation in the fair value of investments. Dividends are recorded on the ex-dividend date and purchases and sales of securities are rendered on a trade-date basis (the date the order to buy or sell is executed). Interest income is recognized on the accrual basis.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Investments (Continued)

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect the amounts of assets available for Plan benefits.

### Fair Value Measurements

Fair value of investments represents the price that would be received upon the sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants as of the measurement date. Financial instruments are measured and reported at fair value and are classified and disclosed in one of the following categories based on the lowest level input that is significant to the fair value management in its entirety:

- Level 1 inputs are quoted prices in active markets that are accessible at the measurement date for assets or liabilities.
- Level 2 inputs are observable prices that are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 inputs are unobservable inputs that are used when little or no market data is available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

The Plan's investments in mutual funds were valued based upon quoted prices in active markets. The Plan's investments in common collective trust funds are valued at fair value using the net asset value (NAV) per share practical expedient based on the value of underlying investments.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Allowance for Credit Losses

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant deteriorations are expected in the future economic conditions, therefore management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 and 2023.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

### Administrative Expenses

Administrative expenses may be paid by the Plan or the Sponsor, at the Sponsor's discretion. Management fees and operating expenses charged to the Plan for investments are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

The Plan is invested in common collective trusts (CCT) that invest in various securities through commingled investment vehicles and calculate NAV on a daily basis. Units are issued and redeemed as of the end of each day at the daily NAV. The investments were organized by the Plan Sponsor to maximize investment opportunities and returns. The investments are managed by professional investment management firms. Income is allocated to the Plan based on the percentage of the net asset value of its individual funds to the total investment balance. These investments had no unfunded commitments in 2024 and 2023.

Redemptions are generally restricted to processing on a valuation date at the daily NAV per unit computed on that date. CCT units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the CCTs. Due to the nature of the investments held, changes in market conditions and the economic environment may significantly impact the NAV and, consequently, the recorded value of the Plan's interests in the funds.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account.

## 6. TAX STATUS

The Plan obtained the latest opinion letter for the Prototype Plan it is based on, dated October 6, 2020, in which the Internal Revenue Service stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

## 7. PARTY-IN-INTEREST TRANSACTIONS

ADP is the recordkeeper and Reliance is the trustee and custodian of the Plan's assets. As such, transactions between ADP, Reliance and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.
