## Independent Auditors' Report

### The Trustees of the Parker Jewish Institute Retirement Savings Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Parker Jewish Institute Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### **1. Description of Plan**

The following description of Parker Jewish Institute Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan was established by Parker Jewish Institute for Health Care and Rehabilitation (the "Employer" or "Company") on April 1, 2002 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Eligible employees who are over 19 years of age and who have completed 3 months of service are eligible to participate in the Plan. The Plan is a 401(k) Plan also covering participating related Employers: Parker Jewish Institute for Health Care and Rehabilitation Foundation, AgeWell New York, LLC, Lakeville Ambulette Transportation, LLC and Queens-Long Island Renal Institute, LLC. Effective June 30, 2020, Lakeville Ambulette Division, LLC is no longer a participating employer.

Effective June 1, 2013, the Plan was amended to allow elective deferrals for the employees of the previously excluded groups as a tax deferral option to the 403(b), which was terminated at that time. Employees covered by The New York State Nurses Association (except for the Long Term and Hospice Programs) and Local 1199 collective bargaining agreements, as well as the Lakeville Ambulette Division (up to June 30, 2020) are now included.

#### ***Contributions***

Each year participants may elect to have a minimum of 1% deducted on a pre-tax basis from their eligible compensation as defined by the Plan document. Participants who have attained age 50 before the end of the plan year, are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. There is an annual limit as to the amount that can be contributed that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer may make a matching contribution in an amount equal to 50% of the participants' elective deferrals, up to 4% of the participants' eligible compensation for those within the plan who are eligible for the matching contribution.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution, (b) Plan earnings (losses) and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Investment Options***

Upon enrollment in the Plan, a participant directs contributions into the investments offered by the Plan.

**1. Description of Plan (continued)**

***Vesting***

Participants are immediately vested in their contributions and Employer matching contributions plus actual earnings thereon.

***Payment of Benefits***

The Plan provides for normal retirement at age 65. The Plan permits distributions to participants upon termination from the Company, disability or death. The normal form of payment is a lump sum. A participant may request an in-service distribution once they have reached age 59½. Upon heavy and immediate financial need, a participant is also eligible to take a hardship distribution.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. The loans are secured by the balance in the participant's account and bear interest at rates at the prime interest rate plus 2 percentage points. A participants may only have one loan outstanding at any given time. The loan must be repaid within a five year period unless the loan is for the purchase of a principal residence in which case the loan repayment period may not extend beyond ten years. Principal and interest is paid ratably through payroll deductions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

**2. Summary of Significant Accounting Policies (continued)**

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is reported at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price. Mutual funds are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade- date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded, when a distributable event occurs.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in the NAV of the respective investment vehicles and, consequently, those expenses are not separately reflected but are a component of net appreciation in value of investments. Expenses are also paid to Empower Trust Company for management fees and administrator fees which are charged to individual participant's accounts.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 11, 2025.

The Plan is invested in a fully benefit-responsive investment contract with MassMutual. Both principal and interest are guaranteed by MassMutual. The SAGIC Diversified Bond II (the “Fund”) is provided through a group annuity contract (the “Contract”) and is supported by MassMutual. A crediting rate is established for amounts invested in the Fund and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract.

Certain events limit the ability of the Plan to transact at contract value. Such events include: (1) the complete or partial termination of the Plan; (2) establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. No events are probably of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**5. Tax Status**

The Plan has adopted a prototype Plan document offered by Empower Retirement, LLC, which received an Internal Revenue Service opinion letter dated November 14, 2022, indicating the prototype plan as then designed qualifies under Section 401(a) of the IRC. Although the Plan has been amended, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**6. Party-In-Interest Transactions**

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
