### Note 1: Description of Plan

The following description of the Holmen Cheese LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Holmen Cheese (the "Plan") who are age 18 or older and have completed one hour of service within the 30 day time period following their date of hire. If an employee does not complete one hour of service within the 30 day time period of employment, they will have satisfied the service requirement once they are credited with a year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

In December 2022, Setting Every Community up for Retirement Enhancement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from beginning effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

Effective December 31, 2024, the Company transferred Plan assets to a pooled employer plan (PEP) and, thus, terminated the Holmen Cheese LLC 401(k) Plan.

#### Contributions

Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage increases by 1% each year up to a maximum of 15% of compensation.

The Company contributes a safe harbor matching contribution equal to 100% of the first 4% of base compensation that a participant contributes to the Plan. Additional nonelective contributions may also be contributed at the discretion of the Company. During the year ended December 31, 2024, the Plan made matching contributions of \$310,938; there were no nonelective contributions to the Plan for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### **Note 1: Description of Plan (Continued)**

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of Company discretionary nonelective contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions, Company safe harbor matching contributions, Company discretionary nonelective contributions, and actual earnings thereon.

#### **Payment of Benefits**

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic installments, or a direct rollover to another eligible retirement plan. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

### Note 3: Fair Value Measurements (Continued)

*Common trust fund - Putnam Stable Value Fund:* Valued at the net asset value (NAV) as a practical expedient to estimate fair value. The Putnam Stable Value Fund was based on the underlying unit value of assets reported by the traditional and synthetic guaranteed interest contracts with various crediting formulas. The stable value fund invested in investment contracts issued or sponsored by various insurance companies and commercial banks. The common trust fund's objective was to preserve principal and provide investors with the potential to achieve returns higher than those from other conservative investments. To achieve this, the fund invested in instruments issued by highly rated insurance companies or financial institutions that were not expected to experience significant price fluctuations in most economic or interest rate environments.

### **Note 4: Information Prepared and Certified by the Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A., the Trustee of the Plan.

### **Note 5: Party-In-Interest Transactions**

Alerus is the Trustee of the Plan and acts as the Plan's third-party administrator; therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the third-party administrator services were included in administrative expenses for the year ended December 31, 2024.

The Plan's investment advisor is Orgel Wealth Management. For the year ended December 31, 2024, fees paid by the Plan for investment advisor services were included in net investment income. These transactions also qualify as party-in-interest transactions.

### **Note 6: Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Effective December 31, 2024, the Company transferred Plan assets to a PEP and, thus, terminated the Holmen Cheese LLC 401(k) Plan.

### **Note 7: Tax Status**

The Company adopted a non-standardized, pre-approved plan document with an IRS opinion letter, which states the plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
