Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Proterra Powered LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of Plan

The following description of the Proterra Powered LLC (“Plan Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General – The Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), is a defined contribution plan covering substantially all employees of the Plan Sponsor. Employees must be at least 18 years of age and complete at least three months of service to become eligible to participate in the Plan, begin making elective deferrals, and receive Plan Sponsor safe harbor contributions. Participants become fully eligible for nonelective contributions after 1 year of service. In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Employees covered by a collective bargaining agreement;
- Non-resident aliens;
- Leased employees; and
- Residents of Puerto Rico.

The Plan was established effective February 1, 2024 (Inception), following the spin-off of participant accounts and related assets from the Proterra Inc. 401(k) Plan (the “Predecessor Plan”). The spin-off was completed in connection with the Volvo Group’s acquisition of Proterra Inc.’s battery business line, Proterra Powered, through an asset sale under Chapter 11 bankruptcy proceedings. In accordance with the acquisition, Volvo Battery Solutions LLC was formed to operate the acquired business, and the Volvo Battery Solutions LLC 401(k) Plan was established to provide retirement benefits to employees of the newly created entity.

On April 12, 2024, Volvo Battery Solutions LLC changed its legal name to Proterra Powered LLC. To reflect this change, the Plan document was amended effective October 1, 2024, to update the plan sponsor and rename the Plan as the Proterra Powered LLC 401(k) Plan.

This is the initial plan year, covering the period from February 1, 2024 (Inception) through December 31, 2024, and therefore, no comparative financial statements are presented.

Contributions – Participants may elect to contribute a specific percentage or dollar amount of their eligible compensation on a pre-tax and/or Roth after-tax basis, subject to the limits defined by the Internal Revenue Code (“IRC”). Additionally, participants age 50 or older may elect to make a catch-up contribution subject to the limits defined by the IRC. Participants may also contribute amounts representing eligible rollover distributions from other qualified defined benefit or defined contribution plans.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The Plan includes an automatic enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to opt out or choose a different deferral rate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, with contributions invested in a designated balanced fund until otherwise directed by the participant. The Plan does not include an automatic escalation feature.

The Plan Sponsor provides a safe harbor matching contribution equal to 100% of a participant's elective deferrals up to 4% of compensation that a participant contributes to the Plan. Additional discretionary contributions may be contributed at the option of the Plan Sponsor. To be eligible to receive a discretionary contribution, a participant must complete at least 1,000 hours of service during the Plan year and be actively employed on the last day of the Plan year, unless otherwise waived under the Plan document. No discretionary contributions were made during the period from February 1, 2024 (Inception) through December 31, 2024.

The Plan provides for an annual true-up calculation to ensure participants receive the maximum matching contribution permitted under the Plan's safe harbor formula. The true-up for the 2024 Plan year was determinable as of December 31, 2024, and totaled approximately \$40,997. This amount is reflected as employer contributions receivable in the accompanying statement of net assets available for benefits. The related contribution was remitted to the Plan in May 2025.

Participant Accounts – Each participant's account is increased by the participant's contributions and Plan Sponsor matching contributions, as well as any discretionary contributions. Participant accounts are decreased by participant distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their salary deferral and rollover contributions, Plan Sponsor safe-harbor matching contributions, plus actual earnings thereon. Employees vest in Plan Sponsor discretionary contributions and actual earnings thereon based on years of service. Employees are 20% vested after two years of service and vest ratably at 20% per year thereafter. Accordingly, participants are fully vested in Plan Sponsor contributions after six years of service.

Notes Receivable from Participants – Participants may borrow from their individual accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, in accordance with the IRC. The loans are secured by the balance in the participant's account.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions, and generally must be repaid within a period not to exceed five years for personal loans, and ten years for loans towards a primary residence. Upon termination of employment, any outstanding loan balance becomes due and payable in full, unless otherwise satisfied in accordance with the Plan (e.g., through rollover to another qualified plan that accepts loan transfers). Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits – Upon termination of employment due to retirement, death, or disability, a participant may elect to receive a lump-sum distribution, installment payments, or partial withdrawals equal to the vested value of their account. If a participant's vested balance exceeds \$5,000, distribution may be deferred until requested. In-service distributions are permitted at age 59½. Hardship withdrawals, as defined by the IRC, are available from eligible sources and must be at least \$500. Upon a participant's death, benefits are payable to the designated beneficiary in accordance with the Plan document.

Transfer of Plan Assets – In May 2024, total assets of \$12,122,278 were transferred from the Predecessor Plan to the Plan in connection with the spin-off. The transferred assets consisted of participant-directed investment holdings of \$11,963,326 and participant loan balances receivable of \$158,952.

Of the investment holdings, \$11,693,236 was liquidated and deposited into the Plan's trust, while the remaining \$270,090 was transferred through a direct trust-to-trust transfer. The participant loan balances represented outstanding loans as of February 1, 2024 (Inception).

The transfers were recorded by the Plan at the carrying value of the assets received, which approximated fair value. No gain or loss was recognized by the Plan in connection with the transaction.

Income Taxes – The Plan Sponsor most recently obtained an Internal Revenue Service ("IRS") opinion letter dated November 30, 2020, which states that the form of the pre-approved plan document sponsored by Sentinel Benefits Group Inc. is qualified under Section 401(a) of the IRC. The Plan Administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan continues to be qualified and that the related trust remains tax-exempt under Section 501(a) of the IRC. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to discontinue its contributions at any time and to terminate its participation in the Plan, subject to the provisions of ERISA. In the event of partial or complete Plan termination, participants will become fully vested in their accounts.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value, which represents the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional information on fair value measurements.

The accompanying statement of changes in net assets available for benefits reflect the net appreciation in the fair value of investments, including both realized gains (losses) and unrealized appreciation (depreciation). Realized gains and losses are determined based on the actual cost and selling price of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis, and dividend income is recorded on the ex-dividend date.

Contributions Receivable – Contributions receivable represent amounts due to the Plan for participant and employer contributions related to compensation earned prior to year-end that were remitted to the Plan subsequent to year-end. Such amounts are recorded on an accrual basis when they are determined and due to the Plan.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. In the event of a default or the participant’s death, the entire outstanding principal and accrued interest become immediately due and payable. Any unpaid balance is considered a taxable distribution from the Plan.

Benefits Paid to Participants – Benefits are recorded when paid.

Plan Expenses – Certain administrative and recordkeeping expenses are paid from Plan assets and may be allocated to participants either pro rata based on account balances or as a flat fee. Expenses attributable to individual participants, such as loan or distribution processing fees, are charged directly to those participants' accounts.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Party-in-Interest Transactions – The Plan holds cash in a noninterest-bearing account and invests in a money market fund managed by Charles Schwab, the Plan’s Trustee (the “Trustee”), as defined in the Plan document. Accordingly, these transactions qualify as party-in-interest transactions under ERISA.

Risks and Uncertainties – Plan investments are subject to various risks, including interest rate and market risk. It is at least reasonably possible that changes in market conditions in the near term could materially affect participants’ account balances and the amounts reported in the financial statements.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events – The Plan Administrator has evaluated the effects of all subsequent events, for recognition or disclosure, through October 14, 2025, the date the accompanying financial statements were available to be issued.

3. Information Certified by the Trustee (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the investments and participant loans included in the accompanying financial statements and supplemental information are complete and accurate.

The Trustee also certified interest and dividend income totaling \$440,909, interest on notes receivable from participants of \$9,361, and net appreciation in fair value of investments of \$738,464 for the period from February 1, 2024 (Inception) through December 31, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that were valued using Level 3 inputs at December 31, 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Cash held in a noninterest-bearing account with the Trustee is recorded at its carrying value, which approximates fair value due to its short-term nature. Accordingly, cash is excluded from the fair value hierarchy table.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Funds: Shares of money market funds are valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and Collective Trusts ("CCTs"): CCTs are valued daily at net asset value based on the market value of the underlying assets. The underlying securities are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance companies approximates fair value of the investments.

4. Fair Value Measurements (continued)

The investments are redeemable at the adjusted net asset value under agreements with the insurance companies. It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements and the economic environment may significantly affect the net asset value of the pooled separate accounts and, consequently, the fair value of the Plan investments.
