Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

Note 1 – Description of Plan

Guarino's Swimming Pool Service, Inc. and South Shore Gunitite Pools, Inc. (the "Companies" or "Employer") established the Guarino's Swimming Pools Service, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") effective January 1, 1999. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Guarino's Swimming Pool Service, Inc. and South Shore Gunitite Pools, Inc. who have attained the age of 18, and three months of service, except those employees covered by a collective bargaining agreement and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The plan administrator, who is appointed by plan management, has appointed Fidelity Management Trust Company ("Fidelity") to hold the Plan's investments and execute investment transactions.

Contributions – Each year, eligible participants may contribute up to the maximum amount allowed under Internal Revenue Service ("IRS") limitations, as defined by the Plan. Salary reduction election may be changed as of the beginning of each payroll period. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants may also designate a portion or all of their deferrals as Roth deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer provides a non-elective matching contribution equal to 50% of the first 4% of compensation that a participant contributes to the Plan. The Employer may make an additional annual discretionary profit sharing contribution in an amount to be determined by the Employer. For the year ended December 31, 2024, the Plan Sponsor did not make a profit-sharing contribution to the Plan.

Participant Accounts – Each participant's account is credited with the participants' contributions, as well as allocations of (a) non elective matching contributions (b) discretionary Employer profit sharing contributions, (c) plan earnings or losses, and (d) plan expenses. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting – Participants are immediately vested in their voluntary contributions. Matching and profit sharing contributions become fully vested after three years of service, as defined by the Plan. The Employer's discretionary profit sharing and additional discretionary match contributions made to each participant's account are subject to vesting requirements. Any participant becomes fully vested upon death, disability, attainment of normal retirement or upon termination of the Plan.

Note 1 – Description of Plan – Continued

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and only one loan can be outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%, which is commensurate with local prevailing interest rates, as determined by the plan administrator. Principal and interest are paid weekly through payroll deductions over a maximum of five years, with an extension available if the purpose of the loan was to acquire a primary residence.

Payment of Benefits – The Plan allows benefits to be paid in the form of one lump-sum cash payment. Upon termination for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant has \$5,000 or more in their account, he or she may elect to maintain the account after separation from the Employer. The Plan includes provisions that allow the plan administrator to distribute the balance of a participant's account if the terminated participant maintains a balance equal to or less than \$1,000. Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship.

Forfeited Accounts – Participants who terminate their employment prior to becoming fully vested in the Employer contributions forfeit such nonvested contributions and earnings thereon. Forfeitures are retained in a money market account in the Plan, and are used to reduce Employer contributions, plan fees or allocated to other plan participants. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,126 and \$18,237, respectively. The Plan did not use any forfeited nonvested accounts to fund the Plan expenses for the year ended December 31, 2024.

Note 2 – Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 – Summary of Accounting Policies – Continued

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and advisory fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties – The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events – The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Plan investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, notes receivable from participants, interest income on notes receivable from participants, and investment transactions for the years ended December 31, 2024 and 2023, were certified as complete and accurate by Fidelity. Therefore, in accordance with the request of the plan administrator and as permitted by ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure, this information was not subjected to standard auditing procedures by the independent auditors.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds and Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds (Level 1) held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: The NAV, as provided by the custodian, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient was not used when it was determined probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor reserved the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contribution portion of their accounts. The Employer may reduce or suspend the employer safe harbor contributions upon satisfaction of certain requirements, including a 30-day advanced notice to all eligible employees.

Note 6 – Parties in Interest Transactions

Certain Plan investments are managed by affiliates of Fidelity. Fidelity is a trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

Note 7 – Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
