INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Teamsters Managed Annuity Trust Fund:

Opinion

We have audited the financial statements of Teamsters Managed Annuity Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Teamsters Managed Annuity Trust Fund's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Teamsters Managed Annuity Trust Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Cash

Cash consists of monies held in checking accounts and highly liquid, interest-bearing accounts without significant withdrawal restrictions.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific method used for the Plan’s investment class is presented below.

Mutual Funds - The fair value of the mutual funds is generally based on quoted market prices in active markets (Level 1).

Wilmington Trust Collective Investment Trust III for MetLife Group Annuity Contract No. 25554: The fair value of the Wilmington Trust Collective Investment Trust III for MetLife Group Annuity Contract No. 25554 (the “Wilmington Trust”) has been estimated by the insurance company using the net asset value (“NAV”) of the investments, as a practical expedient.

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer contributions due and not paid prior to year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as the result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Other Receivables

Certain expenses for administration and bookkeeping services are reduced or completely subsidized by funds received directly by one of the Plan's service providers from entities in which the Plan's assets are invested ("Sub-TA fees"). Sub-TA fees are initially paid to the Plan's record keeper to offset the expenses for administration and bookkeeping services. Any remaining balance, after offsetting the expenses, not paid prior to the year-end is recorded as other receivables.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in mutual funds and a collective trust, which invests in fully benefit-responsive insurance contracts. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The Plan was established under the terms of an Agreement and Declaration of Trust dated May 21, 1991, between IEDA and Beard Affiliates, LLC and the Teamsters Local 853 and Teamsters Local 860. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was designed to be a supplementary retirement savings program in conjunction with the Teamsters Managed Health Care Trust Fund (the "Health Care Trust"). Participants who provide adequate proof of alternative medical insurance may waive their right to participate in the medical portion of the Health Care Trust, and a portion of the employer medical contribution will be directed to the Annuity Plan. Part of the employer contribution is allocated for administrative expenses and the remaining annuity contribution is 100% vested; therefore, there will be no forfeitures. Each participant's account is credited with the annuity contributions (net of the allocation for administrative expenses) received on the participant's behalf and, at least annually, an allocation of the Plan's net earnings in proportion to the ratio of each participant's account balance bears to the value of all participants' accounts as of the preceding valuation date.

Participants should refer to the Plan booklets for more complete benefit information and eligibility requirements.

3. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right to terminate the Plan subject to the provisions of ERISA. The Plan’s assets would be distributed to the participants and their beneficiaries as if the Plan had not been terminated, and to satisfy the other obligations of the Plan.

4. TAX STATUS

The Plan’s latest determination letter from the Internal Revenue Service, dated September 18, 2015, stated that the Plan is in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and is, therefore, exempt from federal income taxes under the provisions of Section 501(a).

The Plan’s administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is funded by participating employers based on their respective collective bargaining agreements. Contributions received during the year were sufficient for the Plan to be in compliance with the minimum funding standards of ERISA. Employer contributions for both this Plan and Teamsters Managed Health Care Trust Fund (the “Health Care Trust”) are deposited together in a lockbox bank account sponsored by the Health Care Trust. The amount due to the Plan is calculated and transferred monthly. The monthly allocation to the Plan per eligible participant is \$350. Of this monthly allocation, a portion is for administrative expenses. The administrative fee per eligible participant per month remained at \$60 in 2024.

Substantially all employer contributions are from employers in the production, trucking and warehousing industry located in Northern California.

6. INVESTMENTS AT FAIR VALUE HIERARCHY

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Wilmington Trust invests in Metropolitan Life Insurance Company fully benefit-responsive insurance contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 60-day redemption notice to liquidate its entire share in the Wilmington Trust. The Plan will receive the lesser of the guaranteed value or the market value when terminating this investment as an option in the Plan. At December 31, 2024 and 2023, all of the Plan's investments, as a practical expedient, were estimated using NAV.

8. RELATED PARTY TRANSACTIONS

Employer contributions for both this Plan and Teamsters Managed Health Care Trust Fund (the "Health Care Trust") are deposited together in a lockbox bank account sponsored by the Health Care Trust. The amount due to the Plan is calculated and transferred monthly.

In addition, this Plan is jointly administered with the Health Care Trust. Certain joint expenses are paid by the Health Care Trust and a portion is reimbursed by this Plan. For the year ended December 31, 2024 and 2023, the amount receivable by the Plan is \$197 and \$0, respectively.

9. REDUCTION OF ADMINISTRATION FEES

Certain expenses for administration and recordkeeping services are reduced or completely subsidized by funds received directly by one of the Plan's service providers from entities in which the Plan's assets are invested ("Sub-TA fees"). These Sub-TA fees are initially paid to the Plan's record keeper under its contract with the entities in which the Plan's assets are invested. During the years ended December 31, 2024 and 2023, expenses for administration and recordkeeping services totaling \$1,397 and \$1,515, respectively, were offset by \$33,675 and \$34,799 of Sub-TA fees, respectively. If these Sub-TA fees were discontinued or if modifications were made to the agreement between the Plan and the respective service provider, the expense reduction of certain administration and recordkeeping expenses would cease, which could result in possible increases in administration expenses.
