## Independent Auditors' Report

The Plan Administrator

### *Opinion*

We have audited the financial statements of the AHC Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits in liquidation of the AHC Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits in liquidation for the years then ended, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Emphasis of a Matter - Basis of Accounting*

As discussed in Note 1 to the financial statements, the governing body of the AHC Employee Stock Ownership Plan approved a plan of liquidation on April 6, 2021, and management determined that liquidation is imminent. As a result, the Plan is presenting the 2024 and 2023 financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

## ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### (1) Description of plan

The following brief description of the AHC Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, which is available from the Plan administrator.

#### (a) General

American Health Companies, Inc. ("AHC" or "Employer") established the Plan effective January 1, 1993. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 ("IRC"), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

At the beginning of 2021, in preparation for a transaction by which the operations of AHC were acquired by Mitchell Family Office ("MFO"), management of AHC undertook a reorganization through which a new entity, FAHC, Inc. ("FAHC") was formed. AHC was reorganized as a limited liability company, and the Plan's ownership in AHC was converted into 100% ownership of FAHC, thus the shares of AHC common stock became shares in FAHC (together with AHC, the "Company"). In April 2021, FAHC's interest in AHC was sold to MFO and the Plan received cash substantially equivalent to the fair value of the AHC common stock. The Plan was amended to provide for the termination of the Plan on April 6, 2021, and sponsorship of the Plan was transferred to FAHC, Inc. As a result of the termination, all plan participants became 100% vested. The trust shall continue until all participants' accounts have been completely distributed to each participant (or designated beneficiary) in accordance with the Plan.

According to the terms of the Securities Purchase Agreement executed as part of the transaction with MFO, there were two escrow accounts created – one totaling \$250,000 related to potential post-closing working capital adjustments (the "Adjustment Escrow") and one originally totaling \$7.7 million related to potential indemnification obligations of FAHC, Inc. (the "Indemnification Escrow"). The Adjustment Escrow was released in full to FAHC, Inc. in July 2021. During February 2024, Indemnification Escrow funds of approximately \$7,500,000 were released to FAHC, Inc.

The common stock is held in a trust established under the Plan. The trust department of an independent third-party bank is the Plan's trustee.

#### (b) Eligibility

Prior to Plan termination, employees of AHC and its participating subsidiaries were generally eligible to participate in the Plan after attaining age 21, providing they worked at least 1,000 hours during such Plan year.

(c) Employer contributions

Employer contributions for each Plan year were determined at the Company's discretion. Participants who did not have at least 1,000 hours of service during such plan year or were not employed on the last working day of a plan year were generally not eligible for an allocation of Employer contributions for such year.

During 2024, Employer contributions totaling \$941,344 were made to participant accounts to address errors that occurred in prior years. No Employer contributions were made to the Plan during 2023.

(d) Participant accounts

The Plan is a defined contribution plan under which a separate individual account was established for each participant. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

(e) Vesting

Participants were 20% vested in the Plan after two years of credited service and earned an additional 20% with each credited year of service thereafter. After six years of credited service, a participant was 100% vested. The Plan also provided for 100% vesting for participants upon death, disability or reaching the normal retirement age.

Pursuant to the termination of the Plan, however, participants were 100% vested in their account balances.

(f) Payment of benefits

Prior to termination of the Plan, no distributions from the Plan were made until a participant retired, died (in which case, payment would be made to the participant's beneficiary or, if none, his or her legal representatives) or otherwise terminated employment with the Company and its participating subsidiaries. Distributions for other separations from service commenced in the fifth Plan year following the separation from service and are generally made in five annual installments. The amount distributed was based upon the immediately preceding valuation date. Distributions were made in cash or, if a participant elected, in the form of Company common stock. Under the provisions of the Plan, the Company was obligated to repurchase participant shares, which have been distributed under the terms of the Plan. However, upon termination of the Plan, all participants were required to take distributions in the form of cash.

(g) Trustee voting rights

The trustee, in its sole discretion, shall vote shares of qualifying employer securities held in the trust. However, as to any corporate matter, which involves the voting of shares of qualified employer securities, such as approval or disapproval of any merger or consolidation, recapitalization, reclassification, etc., the trustee shall vote such shares as follows: shares of qualifying employer securities held in employee stock ownership plan ("ESOP") accounts for which it has received instruction from participants shall be voted in accordance with those instruction. In the absence of voting instructions by a participant, the trustee in its sole discretion shall vote shares of qualifying employer securities held in a participant's ESOP account.

(h) Diversification

Prior to termination of the Plan, diversification was offered to participants close to retirement so that they had the opportunity to move part of the value of their investment in Company common stock into investments which were more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan could elect to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50%. Participants who elected to diversify received a cash distribution.

(i) Put option

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

(j) Plan termination

The Plan was terminated on April 6, 2021. The interest of each participant in the trust fund is being distributed to such participant or the participant's beneficiary at the time prescribed by the Plan terms and the IRC.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared in accordance with the liquidation basis of accounting.

(b) Investment valuation and income recognition

As of December 31, 2024 and 2023, the Plan's investments are stated at liquidation value, which approximates fair value. The fair value of the common shares of FAHC is determined by annual independent appraisals. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023 distributions requested but not yet paid totaled \$24,703 and \$178,354, respectively.

(d) Administrative expenses

Administrative expenses may be paid by FAHC or the Plan, at FAHC discretion.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and October 10, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Administration of plan assets

The trustee of the Plan holds the Plan's assets, which consist principally of the FAHC's common shares, money market funds, and cash.

Company contributions are held and managed by the trustee, which invests cash received, interest and dividend income and makes distributions to participants.

### (5) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASU") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.**

**Level 2 - Inputs to the valuation methodology include:**

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) *Common stock*: Valued at estimated fair value, as determined by annual independent appraisals. The appraiser prepares a preliminary report which plan management, along with the Plan's trustee, review in detail, discuss and approve.
- (ii) *Money market fund*: Valued at the net asset value of shares held by the Plan at year end in an active market. The money market fund is redeemable daily and there are no restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (7) Risks and uncertainties

The Plan invests in FAHC common stock and money market investments, which are exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with such investment securities and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets in liquidation.

### (8) Income tax status

The Plan received a determination letter from the Internal Revenue Service ("IRS") dated September 25, 2013, stating that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan and related trust are designed and being operated in compliance with the applicable requirements of the IRC. On December 6, 2021, the IRS issued a favorable determination letter that the termination of the Plan does not affect its qualified status.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Related party and party-in-interest transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in Company common stock and Evolve Bank and Trust holds cash. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. The Plan paid no fees for trust and management services to the trustee in 2024 or 2023.
